

Dear Relative:

This genealogical information I assumed might interest you. It has been a preoccupation of mine for the past couple of weeks.

I have amused myself trying to straighten out the genealogy and connections of the Dydes, Fenwicks and Hobarts.

I extracted certain parts of a more complete record prepared by Mr. James S. Cushing which included many other branches of the Walters' family and which was lent to me by Jessie Dyde.

I also prepared a chart as accurately as possible with the information available, but which is partly guesswork. For instance, the child of George Savage 1767-1845 had a large family by his first wife, Louisa Farr. Some of their children were born in England and some in Canada. One of their oldest children was a daughter who I named on the chart only as a daughter, but her name was probably Amelia. According to Cushing, this daughter married George Farr which you will note is her mother's maiden name. There is no information available as to what the connection might be to his wife's mother's maiden name.

My main purpose was to show the connection between the Dydes, Fenwicks and Hobarts and this is, I hope, clearly indicated on the chart.

The two marriages of George Fenwick, first to Amelia Hobart, my grandfather's sister and then to Myra Dyde, my grandmother's niece, was a complication. Another complication was the marriage of Frances Fenwick, a first cousin of my father, to her step-mother's brother who was my grandmother's niece.

You can figure that one out on the chart. I hope this interests you and furnishes you with some information and amusement.

Dear Mr. Dyde:

Since writing to you in April, I have been learning a little more about your great-grand parents: Robert and Myra (Walters) Dyde. These facts I obtained from the Christ Church Cathedral Records, the Montreal Archives and the Mount Royal Cemetery Records. Robert Dyde died in Montreal, 20 June, 1818. His widow married, 29 May, 1824, George Savage, Sen. as his second wife. I have been unable as yet to learn the name of the first wife of George Savage, by whom he had seven sons and one daughter. He died 21 July, 1845, and Myra Walters died 22 Oct. 1866. They are both buried now in the Mount Royal Cemetery, Montreal, in the lot of Alfred Savage, son of George Savage, Sen.

I would be much obliged if you would fill in any of the exact dates of birth--marriage and death in the enclosed charts. Any additional facts or dates about your grand-father: Samuel Walters Dyde would be much appreciated.

Your Letter to Mr. Whyte was shown me at the Genealogical Society's Library. I have been compiling all sources of information at present known to me in tracing all Fenwicks in Scotland (and elsewhere at times), since 1972.

This is all the information the 1841 census gives but we have a Kenneth of matching age in the street you need with a brother George and a sister Jessie (1.e. Jannet) The Church of Scotland Old Parish Records for Dundee shows, Vol. 282/21. Marriages:
Contracted Nov. 4th 1823 John F., upholsterer and Janet daughter of late George Stiven, Grocer.

John and Janet both of this Parish (Dundee) at the time of wedding contract and were wed Nov. 18th 1823.

My searches into the Church of Scotland O.P.R.'s for births found Vol. 282/16 (1826 - 30) P. 354

1826 Nov. 9th Born, Kenneth McKenzie Fenwick, son of John F. Upholsterer, and Janet Stiven. Baptised Nov. 25th 1826. Witness: Kenneth McKenzie.

This was the total information from Ch. of Scotland O.P.R.s so we can assume the family joined the Congregational Church, where, (should one come to light) these children's births were recorded or possibly Father's death.

If I find any Congregational records I will search them for us both as I have yet to look for this source of information.

Unfortunately we do not know Jannett Stivens Parish of Birth, the' 41 census and her marriage lines do not give this.

There are up to 8 parishes covering Carse of Gowrie which would involve a professional searcher, but you have her born about 1801 by the census ages.

On all the information collected to date I can only make a guess at the Father of John, born 1799, Approx. He may be the son of a James F., Hairdresser and Wigmaker who married a Barbara Downie 5 Nov 1793 in Dundee O.P.R.s Amongst 7 children shown in the O.P.R.s Dundee Births there is an amole gap between a Peter B.28.12. 1796 and a James B. 15 July 1801 for John to fit into and no other F. families in Dundee at that time in life producing families.

The families of Peter F. B. 1796 and a James F., B.1802
Approx. are shown in the 1841 census. Unfortunately both these
chaps, Peter for sure, died before 1855. O.P.R.s show Peter died
1st May 1848. But James in the 1851 census is still alive and
has moved of Union Street, No. 48 from Nethergate where he was shown
in the 41 census. No nos. of houses were shown intthe 41 census of
Union Street as my first job was to see if James moved to John the
Upholsterer's house.

He was subsequently released and in the spring of 1810 came with his family to New York, and in 1813 moved to Boston. In 1814, the family came to Montreal, Canada. He died there 22 June 1818, aged 61 years. His widow, Myra (Walters) Dyde, was married to George Savage of Montreal, watchmaker, by licence 29 May, 1824, by John Bethune, Rector of Christ Church Cathedral. The marriage was witnessed in the presence of John Dyde son of the bride, and Joseph Savage, son of the bridegroom. George Savage died 22 July, 1845, aged 67 years. He was born in Huddersfield, Eng., 27 July, 1767. His wife died 22 October, 1866, aged 95 years.

GENEALOGICAL RECORD

Of the ancestry of John Walters of Ilfracombe, Devonshire, England, we know comparatively little. The family is said to have originated in Pembrokeshire, Wales, and to have gone from there to Swansea; later going to Bideford and Ilfracombe, Devonshire.

<u>l</u>. John Walters, was born about 1748, and was possibly the son of Miles Walters, baptised at Ilfracombe in 1720. He married at Ilfracombe, 5 April, 1773, Mary deVessaille. She was born 13 April,1748, and died 10 March 1819, and was buried in the church cemetary at Dartmoor, Devonshire. John died about 1826. He apparently spent the earlier part of his life at Ilfracombe, later going to Dartmoor, where he has been referred to as Clerk of Works. There is a tradition that he was an officer in the British navy, and that he was in charge of the French prisoners at Dartmoor during the Napoleonic wars. As far as can be ascertained, he was a builder, and drew plans for the church at Dartmoor, and some of those of Dartmoor prison.

John's wife, Mary deVessaille was of Huguenot stock, and is said to have been descended from an officer deVessaille in the French Army, who was brought with other French Huguenots of Plymouth, Devonshire, 20 October 1685, (four days after the Revocation of the Edict of Nantes), and who is said to have later married Margaret Higginson of Ilfracombe.

The French Revolution was then at its height, and his father being compelled to come to Paris, where he had large business relations, sent Mrs. Dyde to Altona, a town on the river Elbe, which was soon after taken possession of by the French, under whose flag the Colonel was born. Mrs. Dyde disguised as a sailor, with her young son concealed in a clothes basket, escaped to Hamburg and afterwards reached Paris, where her husband was a prisoner, with many of his countrymen, for having too openly expressed opinions hostile to the powers that were.

He was subsequently released, and about 1805 came with his family to New York, N.Y., by way of Long Island. Here his two children were baptized 3 July, 1809, by Rev. Thomas Lyess, D.D., Rector of Christ Protestant Church in the city of New York. While living in that city he was in the hostelry business. In 1813 he moved to Boston, Mass., and in 1814, the family came to Montreal, Canada. He died there 22 June 1818, aged 61 years.

His widow, Myra (Walters) Dyde, was married to George Savage of Montreal, watchmaker, by license, 29 May, 1824, by John Bethune, Rector of Christ Church Cathedral. The marriage was witnessed in the presence of John Dyde, son of the bride, and Joseph Savage, son of the bridegroom. George Savage died 22 July, 1845, aged 77 years. He was born in Huddersfield, England, 27 July, 1767. He married Louisa Farr for his first wife, and by her had nine children. Myra Walters died 22 October, 1866, aged 90 years.

- 4. Samuel Walters 2, (John Walters 1,) was baptized 10 June, 1778. He was at sea from 1796 to 1798, and entered the Navy as Lieutenant 8 March, 1805. In March, 1811 he presented a beautiful painting on ivory of himself in naval uniform to his mother at Stone House, Plymouth, Devonshire, to perpetuate his memory, and as a token of sincere affection and esteem. (This painting is now in the possession of Mr. Harold B. Cribb of Vancouver, B.C.). In one of the books kept by Lieutenant Walters at this time we find the following entry in his own handwriting:

"Hamo Isle, between it and the Main, the Road where all the Foreign Licensed ships assembled for Convoy of the British Ships of War:-was there in H.M. Ship Courageux 1811-1812". (Note: The place is marked with a cross not far from Christianstadt, near the southern tip of Sweden). Again in December 1813 he was off the Coast of Brazil, in the Windham Transport, and alludes to passing a great number of birds there. There is also a very interesting chart of the list of ships in the American Navy at this time. (Note: Book was kindly loaned by Mr. Frank W. Mills of Pointe Claire, Que.).

In December, 1815, Lieutenant Walters appears to have been still connected with the Royal Navy. Afterwards he received a grant from the British Government of a piece of land in what was then Bytown, now Ottawa, Ontario, as a reward for his services. The exact date of his coming to Canada is uncertain, though at the time of his death from Cholera, 29 July 1834, he was living in Montreal, Que. He was buried in Papineau Cemetery, Montreal. Later in 1861, after the burial of his sister, Henrietta in 1861, his brother-in-law, Capt. John Rodd has his bones moved to the same lot in Mount Royal Cemetery.

7. John Dyde 3, (Myra Walters 2, John Walters 1) was born at Altona, Denmark, 4 March, 1800. He came to New York, N.Y. with his parents in 1805, later in 1814 going with them to Montreal, Que. Here he became installed in the Militia, subsequently becoming Sergeant Major and Ensign and Adjutant. In 1817, he obtained a situation in the North West Company, and then set out for the Red River Country, going as far as the Rocky Mountains. In 1819 he returned to Montreal.

On 8 June 1822, he married Elizabeth Henrietta, daughter of W.J. Holt, a veteran officer who had been taken prisoner at Saratoga while serving under Burgoyne. He afterwards made two trips to the West Indies and was twice ship-wrecked. After suffering great hardships he arrived in 1829, in New York, and immediately came to Montreal where he had been given up as lost by all but his wife.

In 1831, he went to Quebec as Inspector of Ashes, and was subsequently made manager there of the Towboat Company, retaining his place as Inspector. In 1833, he was appointed Lieutenant and Adjutant of the Garrison Artillery. In 1835, in addition to his other appointments, he received the position of Manager of the St. Lawrence Steamboat Company.

At the outbreak, in 1837, of the political troubles he raised the Company of Grenadiers in twenty-four hours after the order had been issued to raise a regiment of a thousand strong, "The Loyal Quebec Volunteers", and thus became senior officer.

In 1845, during the Oregon difficulty, he organized the Montreal Light Infantry in three weeks. In 1850, he acted as Magistrate with the Troops in suppressing the fearful riots in Griffintown, when 207 houses were burned.

In 1855, at the re-organization of the active militia he was appointed Lieutenant-Colonel of the Montreal Rifles, now the Prince of Wales, and on his promotion his command the brigade was presented by the Regiment with a magnificent testimonial. In 1860, he was appointed Commandant of the whole active force in Montreal, and subsequently received the high rank which by special clause in the Militia he held to his death, that of full Colonel.

In 1861, during the "Trent" difficulty, the Force was through his efforts and the loyalty of the citizens raised in a few days from 1,000 to 4,000 men. In 1866, during the Fenian difficulties, he commanded the Second Brigade, the First being composed of all the Regulars, the Second of all the Volunteers.

On the 25th March 1871, he was presented by the Volunteer Force with a magnificent full length portrait of himself painted by the late well known artist, Mr. Bell-Smith, Sr.

To the last he was fond of all athletic pursuits, and was a keen curler. After a most eventful life and beloved by all classes of the citizens, he died at the advanced age of eighty-five and 11 months, 5 March, 1886. His wife, Elizabeth Henrietta, died 20 March, 1892, aged 85 years.

PREFACE

The record of John Walters and Mary deVessaille, his wife, of Ilfracombe and Dartmoor, Devonshire, England, and their ancestry and descendants, has been the subject of a number of investigations which have succeeded in bringing out many facts of interest.

The first inquiry of importance was undertaken by one of their great-grandsons: the late James Walters Mills of Montreal, Quebec. When he was over in England with his wife about 1887, he visited Ilfracombe, and other places of family history in Devonshire, and gathered considerable information of interest. This work was later supplemented by his sister, the late Miss Kate deV. Mills, who, when in England about 1900, spent a week in Ilfracombe, and met some of her English relatives.

In the nineties another great-grandson: the late Robert Walters MacDougall, when travelling in England with his wife, spent some time at Ilfracombe and Lynton, Devonshire, and there met several members of the family, who gave them some very interesting books and diaries of John Walters and Mary deVessaille.

About 1910, another great-grandson: the late Robert Henry Walters of London, England, made a careful investigation into the earlier family history, and learned many facts of interest.

More recently, Mr. John S. Kendall of Berkeley, California, who married one of the great-great-grand-daughters of John and Mary (devessaille) Walters, put much valuable time and labor gathering data concerning the Walters and Rodds.

It may be added here that hardly any member of a Canadian or American branch of the family who has been in England at any time has failed to visit Ilfracombe, Lynton and Dartmoor for their family interest.

In the early part of 1942 the writer realized that if these valuable family traditions and records were to be preserved, and made available to the various descendants, it would be necessary to gather them together, and arrange them in order. In the carrying out of this interesting work a constant source of encouragement and help has been the unstinted and generous aid given by different members of the family, in loaning articles of special interest, and in furnishing their own family records.

A chart of the names of the children and grand-children of John Walters and Mary deVessaille, as at present known, is given here. The family records and biographical sketches of some of them is given in more detail in about 18 type-written pages.

PREFACE

Second Edition 1952

In 1942, the writer, with the generous aid of various members of the family, started to gather together the valuable family traditions and records concerning John Walters and Mary deVessaille, his wife, of Ilfracombe and Dartmoor, Devonshire, England, and their immediate descendants, and to arrange them in order. In 1944, the accompanying chart with the names of the children and grand-children of John Walters and Mary deVessaille, together with the family records and biographical sketches of a number of them were given in a Record of about 18 typewritten pages, which was widely circulated among members of the family.

In 1947, a Book of Memoirs by Lieut. Samuel Walters, R.N., was brought to public notice at a meeting of the Liverpool Nautical Research Society by Captain Neligan, in whose possession the manuscript was at that time. The Memoirs were probably written between 1815 and 1819, from a rough diary kept by Lieut. Walters when he was at sea between 1798 and 1815. It was after this Nautical Research Society meeting in 1947, that Capt. Neligan allowed Dr. C. Northcote Parkinson to borrow the manuscript with a view to publication. In 1949, these Memoirs, edited with an introduction and notes by Dr. Parkinson, were published by the University Press at Liverpool, England.

While the introduction and notes added to these Memoirs include much of the biographical information contained in the Record of 1944, it is desirable that the original unabridged Record should be preserved, and the genealogical record of the family brought down to the present time, by including the history of its later generations.

The scheme adopted is that which is in use by the New England Historical and Genealogical Society. The figure which precedes the name of the head of a family refers back to the family of the immediate ancestor, where the same person is designated in the list of children by the same number at the left of the Roman numeral. The Christian names and figures which are given in parenthesis after the head of a family denote the ancestral line and generation in consecutive order.

The authorities and sources of information utilized in compiling the book have been given in the Bibliography at the end of the volume.

Among those who have rendered valuable assistance, outside of their own immediate family line, the special thanks of the author are due to Mr. John S. Kendall of New Orleans, for his many researches into the family record; Mr. Frank W. Mills of Pointe Claire, Que., for the loaning of valuable family papers regarding the earlier history of the family, and the supplying of pictures of various family possessions; also to Mr. Harold M. Cribb of Vancouver, B.C. for a copy of the original oil painting of Lieut. Samuel Walters, R.N.,; to Mr. Percy R. Walters of Montreal, for the loaning of his father's papers, and the photographs of his grand-parents: Samuel Walters the marine painter, and his wife: Betsy S. Pilly. Among others who have been very helpful, mention must be made of Mr. Peter Crombie of Montreal, who kindly took photographs of the sea-chest of Lieut. Samuel Walters, R.N. and other objects of interest; the Record Office of London, England; The North Devon Athenaeum at Barnstaple, Devonshire, Eng., and of a number of the librarians in England to whom the writer is indebted.



GENEALOGICAL RECORD

Of the ancestry of John Walters of Ilfracombe, Devonshire, England, we know comparatively little. The family is said to have originated in Pembrokeshire, Wales, and to have gone from there to Swansea; later going to Bideford and Ilfracombe, Devonshire.

l. John Walters, was born about 1748, and was possibly the son of Miles Walters, baptised at Ilfracombe in 1720. He married at Ilfracombe, 5 April, 1773, Mary deVessaille. She was born 13 April, 1748, and died 10 March, 1819, and was buried in the church cemetery at Dartmoor, Devonshire. John died about 1826. He apparently spent the earlier part of his life at Ilfracombe, later going to Dartmoor, where he has been referred to as Clerk of Works. There is a tradition that he was an officer in the British navy, and that he was in charge of the French prisoners at Dartmoor during the Napoleonic wars. As far as can be ascertained, he was a builder, and drew plans for the church at Dartmoor, and some of those of Dartmoor prison.

John's wife, Mary deVessaille was of Huguenot stock, and is said to have been descended from an officer deVessaille in the French Army, who was brought with other French Huguenots to Plymouth, Devonshire, 20 Oct., 1685, (four days after the Revocation of the Edict of Nantes), and who is said to have later married Margaret Higginson of Ilfracombe.

- 2. Miles Walters 2, (John Walters 1,) was baptised at Ilfracombe, Devonshire, 22 May, 1774. Family tradition says that he was born at sea on a smack on the way from Bideford to London, it being in those days cheaper to travel by sea than by coach or post horses. He appears to have begun his occupation as shipwright and carpenter at Bideford; later joining the Royal Navy. After 1805 he settled in London, Eng., where he became a maker and gilder of picture frames, and did some painting. About 1807, he is said to have been married at St. Sepulchre's Church, Shoreditch, London to -----. In 1825 he was still in London, but in 1834, (according to an address in the diary of his sister Henrietta), he was living at 11 Dunkin St., Great George St., Liverpool, Eng. He died in Liverpool, and was buried in the Necropolis.

3. Myra Walters 2, (John Walters 1,) was born in 1776, in Devonshire, England. She married 1st about 1796, Robert Dyde of London, England. By him she had two children: Col. John Dyde and Samuel Walters Dyde. The former was born at Altona, in the Duchy of Holstein in Dermark in 1800. The French Revolution was then at its height, and his father being compelled to come to Paris, where he had large business relations, sent Mrs. Dyde to Altona, a town on the river Elbe, which was soon after taken possession of by the French, under whose flag the Colonel was born. Mrs. Dyde disguised as a sailor, with her young son concealed in a clothes basket, escaped to Hamburg and afterwards reached Paris, where her husband was a prisoner, with many of his countrymen, for having too openly expressed opinions hostile to the powers that were.


He was subsequently released, and about 1805 came with his family to New York, N.Y., by way of Long Island. Here his two children were baptised 3 July, 1809, by Rev. Thomas Lyess, D.D., Rector of Christ Protestant Church in the city of New York. While living in that city he was in the hostelry business. In 1813 he moved to Boston, Mass. and in 1814, the family came to Montreal, Canada. He died there 22 June, 1818, aged 61 years.

His widow, Myra (Walters) Dyde, was married to George Savage of Montreal, watchmaker, by license, 29 May, 1824, by John Bethune, Rector of Christ Church Cathedral. The marriage was witnessed in the presence of John Dyde, son of the bride, and Joseph Savage, son of the bridegroom. George Savage died 22 July, 1845, aged 77 years. He was born in Huddersfield, Eng., 27 July, 1767. He married Louisa Farr for his 1st. wife, and by her had nine children. Myra Walters died 22 Oct., 1866, aged 90 years.



- 4. Samuel Walters 2, (John Walters 1,) was bapt., 10 June, 1778. He was at sea from 1796 to 1798, and entered the Navy as Lieutenant 8 March, 1805. In March, 1811 he presented a beautiful painting on ivory of himself in naval uniform to his mother at Stone House, Plymouth, Devonshire, to perpetuate his memory, and as a token of sincere affection and esteem. (This painting is now in the possession of Mr. Harold B. Cribb of Vancouver, B.C.). In one of the books kept by Lieut. Walters at this time we find the following entry in his own handwriting: "Hamo Isle, between it and the Main, the Road where all the Foreign Licensed ships assembled for Convoy of the British Ships of War:- was there in H.M. Ship Courageux 1811-1812". (Note: The place is marked with a cross not far from Christianstadt, near the southern tip of Sweden). Again in December 1813 he was off the Coast of Brazil, in the Windham Transport, and alludes to passing a great number of birds there. There is also a very interesting chart of the list of ships in the American Navy at this time. (Note: Book was kindly loaned by Mr. Frank W. Mills of Pointe Claire, Que.).

In December, 1815, Lieut. Walters appears to have been still connected with the Royal Navy. Afterwards he received a grant from the British Government of a piece of land in what was then Bytown, now Ottawa, Ontario, as a reward for his services. The exact date of his coming to Canada is uncertain, though at the time of his death from cholera, 29 July, 1834, he was living in Montreal, Que. He was buried in Papineau Cemetery, Montreal. Later in 1861, after the burial of his sister, Henrietta in 1861, his brother-in-law, Capt. John Rodd had his bones moved to the same lot in Mount Royal Cemetery.



Reference has already been made, in the preface to this volume, to the publication of a book of Memoirs of Lieut. Samuel Walters, R.N., by Dr. C. Northcote Parkinson. Careful investigation of the history of the original manuscript has led to the almost certain conclusion that the manuscript was left to Henrietta (Walters) Rodd by her brother in his will. Later, on her last visit to New Orleans previous to her death in 1861, she left it to her youngest son: Samuel Miles Rodd, who was named after his uncle: Lieut. Samuel Walters, R.N. None of the other descendants who lived in New Orleans seem to have had any knowledge of the existence of this manuscript.

5. Henrietta Walters 2, (John Walters 1,) was bapt. 2 May, 1788. She married at Stoke Damerel, the parish church of Plymouth Rock, Devonshire, England, 4 Dec., 1809, Capt. John Rodd, son of John and Elizabeth (Richards) Rodd. John Rodd, the father, was a cordwainer in South Molton, Devonshire, England. John, his son, was a mariner, and the first twenty-fours years of his married life his wife and family lived at Plymouth and Dartmoor, Devonshire. In the spring of 1833, he brought his wife, and five of his children, to America in the barque 'Mint'. According to the Quebec 'Gazette' of July 5th, 1833, the 'Mint' landed at Quebec on July 4th with 121 settlers, and some ballast. Not long after his arrival Capt. Rodd was in command of the Quebec Steam Boat Company's Barge Hesione, which was rigged as a three masted schooner. She could accommodate a limited number of cabin passengers, being intended as a regular trader between Quebec and Halifax. John handling rafts of logs; and later in 1841 was master of a ferryboat plying between Montreal and Laprairie. This ferry was named 'Princess Victoria'.

Account of Trip by Capt. Rodd and his wife, Henrietta (Walters) Rodd, to New Orleans, La., to see their son Edwin Walters Rodd and his family, in 1843-44. (Taken from Diary of Henrietta Rodd, kindly loaned by Harold M. Cribb of Vancouver, B.C.)

'Christmas day 25 December, 1843. Left Montreal to proceed to New Orleans, La., at 1 p.m. Arrive in the evening at St. Johns, Que., and spend the night there. Reach Burlington, Vt., next evening, and sleep there. Proceed on and sleep at St. Albans, Vt. Start the next morning for Albany, N.Y. Rode all night, and got to Albany Friday three o'clock in the afternoon. 29th left this next morning for New York, N.Y., where we stopped till New Year. 1 January, 1844, Set out by steam-boat at 5 a.m., got to Philadelphia, Penn., at 12 o'clock. Set out at 4 o'clock for Baltimore, Md. Rode all night and got there the next day. Slept there and next morning at 7 o'clock set out by railroad for Wheeling, W.V., Rode all day by railroad, and in the evening we got in a stage-coach and went all night over the Alleghany countains. Got to Wheeling, W.Va., at half-past eleven Wednesday night, and stayed will Friday at 10 o'clock, at the Virginia Hotel. Sailed by steam-boat: Little Pike, ander Capt. Mason for New Orleans. 5th January, got to Portsmouth, Ohio, Saturday th. Sunday 7th got to Cincinnati, Ohio, and Covington and Newport. Finally we arrived all well on Tuesday 16 January, 1844, at New Orleans, La.'.

Henrietta Rodd left a number of interesting diaries, several of which are in the possession of her descendants of the MacDougall branch of the family.

Henrietta died 13 May, 1861, aged 72 years. Capt. John Rodd died 17 November, 1765, aged 76 years. Both of them were buried in Mount Royal Cemetery, Montreal, Que. A tablet has been placed there to their memory and that of their daughter, Ellen Henrietta.

In regard to Samuel Walters' paintings the earliest picture known was one painted in 1840, representing the Fire at St. George Street Chapel, Liverpool. Mr. Ernest Royden, of Bidston Court, Birkenhead, has a collection of pictures relating to Liverpool, and amongst them several by Samuel Walters.

At some time in the fifties Samuel Walters went to London, and lived in the Kingsland Road, which was then a suburb. He rented and painted at a studio in Leadenhall Street. In the sixties he came back to Liverpool, and lived at Merton Road, Bootle, for many years.


Three of his paintings are in the possession of Mrs. Hawksley, at 115 Fellows Road, London; one being "The Loss of the London". (G.V. Brookes, an actor, and his company went down in it). Another "The Bessimer's Trial Trip", and the third - "Rock Ferry, New Brighton" showing the Lighthouse and Fort. "The Port of Liverpool", painted about 1870, with several other of his paintings, are in the Permanent Collection, Walker Art Gallery, Liverpool. A number of his pictures are in the possession of the Leyland, Cunard and Pacific Lines, and also a great number in the Picture Gallery at Boston, U.S.A.

During his life he had several command pictures from various crowned heads of Europe.


He died 5 March, 1882, and is buried with his wife at Anfield (Liverpool) Cemetery.

7. John Dyde 3, (Myra Walters 2, John Walters 1,) was born at Altona, Denmark, 4 March. 1800. He came to New York, N.Y. with his parents in 1805, later in 1814 oing with them to Montreal, Que. Here he became installed in the Militia, subseuently becoming Sergeant Major and Ensign and Adjutant. In 1817, he obtained a siation in the North West Company, and then set out for the Red River Country, going s far as the Rocky Mountains. In 1819 he returned to Montreal.

On 8 June, 1822, he married Elizabeth Henrietta, daughter of W.J. Holt, a veteran fficer who had been taken prisoner at Saratoga while serving under Burgoyne. He Iterwards made two trips to the West Indies and was twice ship-wrecked. After sufring great hardships he arrived in 1829, in New York, and immediately came to Montal where he had been given up as lost by all but his wife.

In 1831, he went to Quebec as Inspector of Ashes, and was subsequently made mager there of the Towboat Company, retaining his place as Inspector. In 1833, he s appointed Lieutenant and Adjutant of the Garrison Artillery. In 1835, in addition his other appointments, he received the position of Manager of the St. Lawrence eamboat Company.

At the outbreak, in 1837, of the political troubles he raised the Company of enadiers in twenty-four hours after the order had been issued to raise a regiment a thousand strong, "The Loyal Quebec Volunteers", and thus became senior officer.

In 1845, during the Oregon difficulty, he organized the Montreal Light Infantry IN three weeks. In 1850, he acted as Magistrate with the Troops in suppressing the arful riots in Griffintown, when 207 houses were burned.

In 1855, at the re-organization of the active militia he was appointed Lieute-NA Mt-Colonel of the Montreal Rifles, now the Prince of Wales, and on his promotion HIS command the brigade was presented by the Regiment with a magnificent testimonial. IN 1860, he was appointed Commandant of the whole active force in Montreal, and subse-QUE intly received the high rank which by special clause in the Militia he held to his th, that of full Colonel.

In 1861, during the "Trent" difficulty, the Force was through his efforts and + loyalty of the citizens raised in a few days from 1,000 to 4,000 men. In 1866, during the Fenian difficulties, he commanded the Second Brigade, the First being composed of all the Regulars, the Second of all the Volunteers.

On the 25th March, 1871, he was presented by the Volunteer Force with a magnifint full length portrait of himself painted by the late well known artist, Mr. Bellith, Sr.

To the last he was fond of all athletic pursuits, and was a keen curler. After most eventful life and beloved by all classes of the citizens, he died at the

advanced age of eighty-five and 11 months, 5 March, 1886. His wife, Elizabeth Henrietta, died 20 March, 1892, aged 85 years.



In 1814, he moved to Montreal, e., with his parents, returning some years later to New York, where, on the 2 August, 29, he married Elizabeth Weight of New York, eldest daughter of James Weight, of Inchester, England, at St. Paul's Anglican Church, by Rev. Dr. Berrian. In October, 40, he and his wife were still living in New York, but shortly afterwards, they wed to St.Pie, Que. From there, he went to Ottawa, Ont., going with his family to ronto about 1880.

Robert Mills joined Zion Church by letter from the Baptist Church, at St. Helen St., Montreal, 26 July, 1853. Mr. Mills was a clerk in the City Bank, Montreal for some years, and later was employed in the firm of Mills and Hutchison, wholesale drygoods.

Robert Mills was Ensign - 6th Battalion Montreal Militia - June 25, 1853 - from Earl of Elgin & Kincardine - Gvr. Gen. of B.N.A.; Lieutenant - 1st Battalion, Montreal Militia March 20, 1856, from Sir Edmund Walker Head Gov. Gen. of B.N.A.; Captain - 1st Battalion Montreal Militia 20 March, 1863 - from Rt. Hon. From here he moved to Plaque-ine, La., where he remained about a year, employed as a druggist. Thence he removed to Bayou Goula, La., where he lived about six months, until his death from scarlet fever, 20 Sept., 1853.

His widow, Ellen Henrietta, returned to Montreal in the fall of 1853. On March, 1855, her two children: Ellen Henrietta and John Edward were baptised by Dr. Henry Wilkes of Zion church, Montreal, with her father John Rodd and her ather-in-law Elisha Cribb as witnesses. Mrs. Cribb lived for many years in Montreal with her children, and later visited them at Winnipeg, Manitoba, and Halifax, S. She died at Dartmouth, N.S., 20 May, 1904, and was buried in Mount Royal Centery, Montreal, in the same lot as her parents, Capt. John and Henrietta (Walers) Rodd.





Is George Stanfield Walters 4, (Samuel Walters 3, Miles Walters 2, John Walters 1,) was born 5 Dec., 1837. He married first, in 1868, Margaret Amelia Vinell. She died in 1872. He married secondly, in 1874, Annie Harris, who died in 1932. George S. Walters died in 1924. He was educated at Liverpool Grammar School, and at a very early stage showed signs of becoming an artist. At the age of about 14 or 15 he was working in his father's studio, principally in painting ropes and rigging of the ships in his father's pictures. He was a member of the Royal Society of British Artists and the Langham Sketching Club, and also for some time was a member of the Savage Club. He exhibited in all the London Exhibitions, and for many years was represented at the Royal Academy.

The following article appeared in the "Collector" Nov. 15, 1896. ---- a semi-monthly magazine on art, published at that time, by Alfred Trumbull of New fork. For many years Trumbull was one of the leading lights in art criticism.

The pictures in Boston are all notable for their purity of tone their admile drawing, their complete mastery over the form and aspects of water, and the their atmospheric effects. The artist uses his brush broadly and freely, his pictures are none the less clear in their details while in point of color play of light and shade they are wholly charming. One of the largest and best them, "Dutch Craft Getting under Way at Sunrise" is masterly in the effective li with which the vessels are grouped, the beauty of the sky, the motion of the er and the harmony of tone which pervades the whole. Another charming picture a "Misty Evening in the Channel" and yet another "Fresh Weather of the Maas". the whole collection, twenty-six drawings in all, are full of interest and th, the only point on which criticism is justified in passing an unfavorable gment being the artist's portrayal of rock forms."

They did not call them Waacs in those days. They called them The Ladies of the United States Sanitary Commission. But these women were a genuine army auxiliary corps, doing for the army much that the army now does for itself. What they did to mitigate the horrors of war makes one of the most heroic stories in American annals."

Dr. Charles B. Dyde, well-known physician and surgeon, died Tuesday night at Bonell Retirement Community. He was almost 96.

Dr. Dyde came to Greeley in 1905 and practiced here until

he retired.

He was born in Ottawa, Canada, April 27, 1872, and received his M.D. degree from Queen's University at Kingston, Ont., in 1897. He also held A.B. and master of surgery degrees from Queen's and received the degree of M.C.P. and S. (Member of the College of Physicians and Surgeons) which was conferred by examination in Ontario. Following graduation he served as house surgeon at Kingston General Hospital and was qualified by examination as I demonstrator of anatomy. During this period he took post graduate work at Johns Hopkins Hospital.

He opened his first private practice in Ottawa, then came to the United States in 1900, where he served as a country doctor at Wood River, Neb., until he came to Greeley.

He married Bessie Yeomans on April 27, 1898. She preceded him in death.

During his early years in Greeley he was county physician and was in complete charge of the Weld County Hospital then located at Island Grove Park. He also covered all county cases in the country, some of which required two days of traveling over rough wagon trails.

He was a charter member of the staff of the Weld County Hospital and served with the late Drs. N. A. Madler, W. E. Thompson and E. W. Knowles in performing all major operations at the hospital which had pre-viously had no staff organiza-tion. When the Weld County Hospital and the Greeley Hospital were combined the staff was continued and expanded, and Dr. Dyde served as the first staff secretary, a position he held for several years. He served as chief of staff in 1934-35.

Dr. Dyde was instrumental in the establishment of the medical library at the county hospital, which came to be known as the best of its type in northern Colorado. Through the years Dr. Dyde did special study on cardiovascular diseases, including work at Harvard University, in London and at the University of Edinburgh, Scotland and the Mayo Clinic.

He was appointed to the Colorado State board of medical examiners by governors of both parties and served for a dozen vears prior to 1928.

In recognition of his record, the Weld County Medical Society nominated him in 1948 for the gold medal award of the American Medical Association for "General Practitioner of the Year.


Dr. Dyde was a member of Trinity Episcopal Church, the Masonic Orders, and the Post Graduate Club of America.

Survivors include two daughters, Mrs. M. E. H. (Dorothy) Smith and Miss Marjorie J. Dyde, both of Greeley; two grandchildren, Marc E. H. Smith III of Helena, Mont., and Mrs. Jackson S. (Carol) Pecaut of Sioux City, Iowa, and four great-granddaughters.

Funeral services will be held at 10:30 a.m. Saturday at Trinity Chapel, 8th Avenue at 21st Street. Interment will be in Linn Grove Cemetery. Macy Allnutt Mortuary is in charge of arrangements.

If friends wish, memorial gifts may be sent to the Dr. Charles B. Dyde Memorial Fund in care of Trinity Episcopal Church.

Robert Dyde married Myra, daughter of John Walters of Ilfracombe, Devonshire, towards the end of the eighteenth century. He was a member of the Fox club in London. In connection with his business as a merchant, he went to Paris with his wife; and here he was imprisoned for speaking too freely on the subject of the revolution; in the mean time his wife fled to Altona in the duchy of Holstein, Denmark, where she gave birth to a son, John Dyde, on the twenty-fourth of March, 1796. Altona was then in possession of the French, and Myra Dyde, disguised as a sailor, escaped with her infant son to Hamburg, where she was rejoined by her husband. They immigrated first of all to the United States, but in the year 1814 came to Montreal. Robert Dyde, according to the registers of Christchurch cathedral, Montreal, departed this life on the twentieth of June, 1818. He left two sons, John and Samuel. His widow afterwards married a man named Savage, whom she also survived. When she was ninety-eight years old, she was going up to Ottawa and caught cold on the train; her death followed as the result.

Nurses school

Dr. Kenneth Fenwick, house surgeon at Kingston General Hospital was credited with the founding, in 1886, of a training school for nurses.

From the opening of the hospital in 1845 until Dr. Fenwick's time, nurses had "come up through the ranks" as volunteers from the community who got their "training" on the fly, as they lent a hand here and there, or they were

brought in as persons trained outside. Dr. Fenwick was convinced the time had come for KGH to establish its own formal training program. A visit to New York clinched the idea. "He was very impressed with the results obtained by properly trained nurses and was determined that his hospital should also have a training school."

With the approval of the governing board he advertised in the daily newspaper for "two young women to be trained as nurses, ages 18-30 years"

Fifteen women applied in May, and two were selected: a Miss Macarow, (2) daughter of a judge, and Miss Margaret Hall, daughter of Rev. Thomas Hall.

The terms of their relationship were simple: they were to be on a month's trial, and if they were found satisfactory they were to receive free board and a small "salary". They were to be instructed by the head nurse, house surgeon and visiting surgeon for a two year period, on the pattern of a training school at St. Catharines, the oldest in Canada.

In addition to their training in the hospital context they were to be sent out to learn private nursing in the homes of sick persons getting home medical care.

At the end of two years they were to receive a diploma which would qualify them to nurse in hospitals and homes.

With the acceptance of the two candidates came the intimation that a third, a Miss Mary O'Hara of Smiths Falls, wou'd begin a month later.

The hospital indicated that while it could not accommodate at the moment more than these probationers, other ap-



plicants could attend the lectures given by the house sur-

According to Mrs. Crothers, who writes as a nurse who came into the system much later, those first probationers, as well as the regular nurses, served a 13-hour day and a seven - day week. At the end of three months the probationers moved into full nurse status and their pay was four dollars a month. When they had served a year the pay scale advanced to six dollars a month, and if they survived to graduation at the end of two years they received a \$25 honorarium and a silver medal.

The first head nurse, responsible for supervising the probationers and other nurses, was a Miss Steele who had come from Bellevue Hospital, New York.

By October of the founding year she had a fourth probationer, which meant that she was able to keep two within the hospital and farm the other two out to homes calling for nursing services.

Miss Steele didn't last long and when there was a general staff shuffle following disagreements over who should give orders she resigned and was succeeded by Miss Margaret McMillan of the Toronto General Hospital.

She was paid \$18 a month, plus room and board. Coming from Toronto, she had "big ideas" about how things should be done in Kingston: the female nurses were to have charge of the male wards as well as the female wards - a new feature for KGH; and the nurses were to have charge of preparing the serving patients' food. This gave Miss Mc-Millan charge over male nurses, the cook and the maids.

"She also listed rules for student nurses, which the board approved along with her other suggests." (3) She remained for five years and put the training school on a firm basis, according to Mrs. Crothers.

The training school had its first graduation ceremony in 1889, and medical superintendent Dr. Ephraim Hooper, pronounced the school a complete success. He said there were now over 50 applications.
