T. ENTY-SECOND ANNUAL MEETING.

The twenty-second annual me ting of the Canadian Society of Biblical Studies was held concurrently with the sixteenth annual meeting of the Canadian Section of the Society of Biblical Literature and Exegesis, at Emmanuel College, Toronto Ontario, on May 27th and 28th, 1954.

FIRST SESSION THURSDAY EVENING, MAY 27th.

The president, Principal R.Lennox, was in the chair, and opened the meeting with prayer. The minutes of the previous annual meeting, as contained in the eighteenth bulletin, were by motion duly seconded, taken as read and approved.

The Secretary, Rev. C.J. de Catanzarc read the names of those who had written to express their regret at being unable to attend the meeting. He reported a total membership of 91, of whom 35 were fully paid up. Two of the members had written to resign their membership because of advancing age.
