Dear Members and Friends,

In spite of all of our efforts, it looks as if the Government is determined on September 10th to push their demand that the Israeli High Court cancel their March 2000 restraining order which determined that the cave dwellers of the South Hebron Hills must be allowed to live in their homes unless the Government can prove that they are not residents of the area. The army's Civil Administration has stated clearly that this is a political, not a security decision, and that Defense Minister Benyamin Ben-Eliezer must determine what the Government will demand. Ben-Eliezer has sent mixed messages, even saying at one point that he has no interest in expelling long term residents, but only those "hitching a ride." Unfortunately, he has not defined what he means by this, and the prosecutor's office continues to demand full evacuation of at least some of the generations old cave settlements. We must therefore do everything we can to request Ben-Eliezer to do the just thing and obviate the need for a High Court discussion. Please take a look at the additional information, sample letter and addresses below. Please write a letter and send us a copy both of the letter and any responses.

A number of people have made inquiries about the RHR Yom Kippur Vidui. The English is reproduced here. Both the Hebrew and English can be found as an attachment.

Urgent International Letter Campaign

Stop the Expulsion of the Palestinian Cave Dwellers from the South Hebron Hills

After few times in the past, we launch again a letter campaign to stop the expulsion of the cave dwellers south of Hebron. Our efforts resulted in the government's request to postpone deliberations in the High Court of Justice. Their intention was to hold the deliberations when public attention was diverted. We believe that this terrible act of expulsion can only be achieved when there is no public attention. Therefore we appeal to you again to write to Israel's ministers, to Israeli Embassies in your countries, and to your own Foreign Ministries demanding that no expulsion of Palestinians from the South Hebron Hills be allowed. Your assistance is very important to the struggle.

In the first third of the 19th century (1830s), poverty-stricken Palestinian families left their villages in the South Hebron region and went to eke out their livelihoods in the surrounding hills and fields on lands they could afford to purchase on the outskirts of the existing villages living in the numerous and spacious caves spread throughout the area (today the south West Bank). In the generations that followed these families developed a unique culture and way of life based on their sheep herding, agriculture and cave dwelling. the occupation led to expropriation of the Palestinian farmer's land due to establishment of military bases, declaration of certain areas as "drilling zones", closed military zones. From the early eighties, the israeli government confiscated more land as it began building settlements in the area. Today this scattered pastoral palestinian population numbers a few thousand - but their very existence is now in danger. THEY ARE FACING IMMINENT EXPULSION BY THE ISRAELI AUTHORITIES.

In November 1999 the decades-long harrassment of this population reached a new level when the Israeli army violently expelled some 750 inhabitants (mostly children and women) from their homes and land. Israeli peace and human rights organizations mounted a major public campaign to return the cave-dwellers to their homes, and the High Court of Justice issued an temporary injunction to this effect in March 2000. As a result of the Court ruling things remained relatively quiet until July 2001 when, without any warning, the Israeli army and Civil Administration tore through a wide area with bulldozers - destroying caves and other dwellings, stopping up water wells with rocks and dirt, mowing down crops and livestock, and expelling hundreds of people. Since then Israeli and Palestinian peace and human rights organizations have mobilized in defense of this vulnerable population WE NEED YOUR HELP!

IT IS CLEAR THAT THE ISRAELI GOVERNMENT ASPIRES TO EXPEL THE POPULATION OF CAVE DWELLERS, TO REINFORCE ITS OWN SETTLEMENTS IN THE AREA, AND TO EVENTUALLY ANNEX THIS TERRITORY TO ISRAEL

Lately we have been hearing from Palestinians who have been repeatedly haraassed and harmed by settlers. Their complaints to the police receive no attention and are ignored. Complaints to the military authorities and to the government are no more successful. It must be remembered that even now the settlers continue to build new settlements in the region, as they do in many parts of the occupied territories.

PLEASE WRITE TO ISRAEL'S PRIME MINISTER, DEFENSE MINISTER AND FOREIGN MINISTER, TO THE ISRAELI AMBASSADOR IN YOUR COUNTRY, AND TO YOUR OWN FOREIGN MINISTRY - DEMANDING A STOP TO THE HARRASSMENT AND EXPULSION OF THE PALESTINIANS FROM THE SOUTH HEBRON HILLS.

A sample letter:

Dear Minister....

I am saddened by the ongoing strife between the Israelis and the Palestinians and by the many victims it has created.

I find it difficult to understand Israel's intention to expell the Palestinian population - many of whom live in caves - from the South Hebron hills. I was amazed to learn that the Barak government expelled 750 residents from this area at the same time that it was promoting the Peace Process. Other expulsions committed by your government between July and October of 2001, as well as the construction of new and expansion of old settlements throughout the period do not lend credibility to Israel's desire for a cease fire and for peace.

I consider the expulsion of defenseless civillians as contrary to the spirit of Judaism and a violation of the Fourth Geneva Convention.

In so far as we take the traditional vidui of Yom Kippur seriously, we find that we are obliged to look upon ourselves in a way that will cause us unease. Reciting the vidui is not the occasion for a "balanced" view or for repeating the accepted version of events. Rather it is an opportunity to examine those matters which we can find the courage to deal with only when we are strengthened by the intensity of Yom Kippur. Rabbi Avraham Joshua Heschel said: "In a democracy there is a small group of guilty people, but each one of us must bear responsibility". The vidui which we have written is intended to remind us of our sins (transgressions), in the hope that we will find the wisdom to do better in all that we touch in the coming year. Our soul searching on Yom Kippur is what permits our joy at the spiritual harvest of Succot.

The state of Israel has been transformed from a welfare state with one of the smallest gaps in the world between the rich and the poor to one which has one of the greatest rifts between these two groups in the West. We ignore the recommendations of the Parliamentary Committee to halt the collapse of the health system and refuse to seek out the funds essential to its survival. The level of unemployment is on the increase. Instead of engaging in some much needed soul searching and taking constructive action we prefer to blame the victims: the problem, we say, arises from those "pretending" to be unemployed. We propose that foreign workers be expelled, rather than seeing to it that the laws relating to them are enforced. This step would reduce the temptation employers face under current circumstances to take on foreign workers rather than Israelis. We arrest the escort agency "girls" instead of those responsible for the trafficking in women and accuse those women, who have been refused a divorce of breaking up their families.

For the sin which we have sinned against You by indulging in food and drink
As the social gap has grown

For the sin which we have sinned against You by insensitivity
When we permitted a cut in funds for the weaker sections of society

For the sin which we have sinned against You through Lashon HaRa (slander)
Claiming that the unemployed were "faking"

For the sin which we have sinned against You by rashly blaming others

As we blamed the victim, declaring war against the unemployed rather than against unemployment

For the sin which we have sinned against You by shortsightedness
In transferring funds intended for health care elsewhere at a time when the health system is collapsing

For the sin which we have sinned against You by casting aside the weak
By neglecting those requiring assisted living and the mentally ill in the health care budget

For the sin which we have sinned against You by desecrating your name
By abandoning the "agunot" and those women who were not granted a divorce in the name of our religion and by ignoring the solutions which exist in the Halacha

For the sin which we have sinned against You in doing business
Rather than fighting those operating as pimps and trading in women

For the sin which we have sinned against You by chasing material gain
Through the exploitation of foreign workers

For the sin which we have sinned against You intentionally or unintentionally
By ignoring or turning our heads away from the disabled

For the sin which we have sinned against You by scoffing,
Denigrating new immigrants and failing to honor their traditions and cultures

For the sin which we have sinned against You by intentionally forgetting
When we chose to ignore poor neighborhoods and development towns

For the sin which we have sinned against You by giving into the evil impulses
Of materialism and selfishness

For the sin which we have sinned against You by withdrawing our hand
from the outstretched hand of a person in need

For the sin which we have sinned against You knowingly or unknowingly
Because we did not want to know how we might be of help

For the sin which we have sinned against You by thinking to ourselves and by whispering in closed rooms
About that which we should have shouted from the rooftops
For all these sins, forgiving God, forgive us, pardon us, grant us atonement.

Two years into the current intifada there is not a one of us who is not angry and traumatized in the face of ongoing Palestinian violence. While not excusing Palestinian terror, You Kippur is a time to rise above the unchallenged assumptions and justifications which prevent us from looking honestly at ourselves. It is all too easy for us to be trapped in our own real and justified pain. However, life is not a zero sum game in which admitting our shortcomings weakens us or negates the shortcomings of others. Finding a way out of crisis requires us to add the conclusions of our own painful keshbon nefesh (soul searching) to those truths which are more readily clear to us.

The examination of our deeds tells us we also have much to atone for. Israeli Arabs have been systematically under represented in all areas of Israeli society, while their communities have been disproportionally over represented in terms of poverty and unemployment. In the Territories, unfair allocation of

water, land expropriations, harassment by settlers, humiliation and despair left Palestinians with little faith in the peace process or hope for a better future. While common wisdom says that Palestinians threw away the chance for peace, we often ignore these sources of pent up anger which were more real to many than the details of the latest offer. While we are all too aware of the terrible ongoing attacks which we suffer, we prefer not to know about our actions which cross our tradition's red line between self defense and harming innocent civilians.

If we take the traditional Yom Kippur vidui seriously, it forces us to look at ourselves in ways that make us feel uncomfortable. The vidui is not a time for "balance" or the repeating of common wisdom, but for examining that which the power of Yom Kippur can give us the courage to face.

For the sin which we have sinned against You by hardening our hearts -
To grinding poverty and despair.

And for the sin which we have sinned against You by exploitation
Living well while others live in poverty.

For the sin which we have sinned against You consciously or unconsciously -
Preventing fellow Israelis fully and equally participating in Israeli society, and
leaving them under represented in government, academia and business.

And for the Sin which we have sinned against You knowingly or unknowingly -
Allowing the Israeli government to continue expropriating land, demolishing homes,
building roads, uprooting trees, besieging towns and denying water to innocent civilians
in our name, even while publicly speaking words of peace.

For the sin which we have sinned against You by causeless hatred -
Demonizing the "other."

And for the sin which we have sinned against You with our words -
Of incitement.

For the sin which we have sinned against You by desecrating Your Name -
By abusing others and calling it Your Will.

And for the sin which we have sinned against You through insolence -
Saying that only Jews have rights to the Land.

For the sin which we have sinned against You by silence -
When we knew that human beings were being mistreated, and said nothing.

And for the sin which we have sinned against you by standing by -
Protecting those who took the law into their hands.

For the sin which we have sinned against You by failure to distinguish-
Between legitimate self defense and the collective punishment of innocent civilians

And for the sin which we have sinned against You by justifying -
The use of collective punishment and excessive lethal force.

For the sin which we have sinned against You by narrow mindedness -
Feeling only our own pain, closing our minds to the agony of bereaved Arab mothers and fathers.


Dear Alfred,

Re: Fisher Collection 00.01.286, *The Alchemist*, after David Teniers.

This cradled panel painting, in very poor condition, warrants restoration as a faithful, sensitive and lively copy of a well-known Teniers Alchemist scene.

The painting is not by Teniers himself, as its technique and style differ from his. The original has not surfaced, and this may be the only surviving copy. A c.1740 engraving by Michon and Lorieux reproduces this original work exactly and corresponds to ours in all details, in reverse. Such large and fine engravings were often made only of famous paintings.

Furthermore, the original work is reflected in another version in the collection of the Earl of Crawford and Balcarres (1959 catalog, pg. 21), shown at the Royal Academy in 1871 and 1888. It, in turn, was closely copied in the work in the collection of of E.W. Sachs in Schweinfurt in 1962, and another at the O. Strauss sale at Helbing, Frankfurt, May 21, 1935 (Schwartz portion). These last three works show the same Alchemist figure as the Fisher painting, but are a more close-up view and include a large cow's skull in the right foreground, while excluding the cluster of paraphernalia in the center-left foreground as well as the second assistant, the cat and the mouse.

The pattern of cracks, however, which are now so prominent, are already clearly visible in the c. 1928 photo (now in the Witt Library, London) and the c. 1938 photo supplied by Fisher to D.D. Berolzheimer for his Percolator Series of Alchemical and Historical Reproductions (#93) [CHF Archives].

Like Eddleman Collection CHF 00.03.23 *Physician bleeding a patient with Leeches*, the Fisher painting ranks among the most faithful and elaborate copies after Teniers produced in the 17th or early 18th centuries.

Nica Gutman has performed the technical examination of this painting and her findings are included in the forthcoming survey. In conversation, she related that the painting has an alizarin-coloured underdrawing throughout, highly uncharacteristic for Teniers and unlike the three Teniers alchemist scenes she examined for comparison (00.03.23, 00.03.07 and the one in the Johnson Collection, PMA.) She also was confident the signature was not original to the work, the traces of an original being no longer legible. Nica was enthusiastic about the undamaged surfaces of the painting and the potential for restoration.

Comparing the style of this painting to known Teniers works reveals it to have a characteristically too long and broad brushstroke, in imitation of his dashing style but lacking his delicacy. The color scheme may have (been) altered over time and therefore not reflect the original appearance of the work, but what is visible does not correspond to the cooler tonalities in the other three works.

THE ALCOVE

The painting depicts a woman in a red dress and white apron, seated in a room. She is looking towards the viewer. THE ALCHEMIST

By David Teniers, the Younger

Through the very kind coöperation of Mr. Chester G. Fisher, we are able to reproduce as No. 93 in the Berolzheimer series of Alchemical and Historical Reproductions the fourteenth painting by those prolific Dutch painters, David Teniers, Father and Son.

The original painting was privately owned in England for many years until it was acquired by Sir A. S. Hunter in 1852. Last year while in England, Mr. Fisher purchased it from a private home at Mortimer Hill, Berkshire, and brought it to the United States, where it hangs in his office in Pittsburgh as a part of his extensive collection of prints and pictures.

The original is signed in the lower right-hand corner, where also will be found the date "1648."

This painting greatly resembles one of the previous Teniers' reproductions, No. 2 in the series. These two paintings have more frequently been the subjects of engravings, in part by world-famous engravers, than all the other Teniers' paintings. Only recently the Eaton-Clark Company of Detroit issued a very handsome bronze medal in commemoration of their Hundredth Anniversary. With Mr. Fisher's permission the obverse of the medal depicts a part of this Teniers' painting most excellently executed.

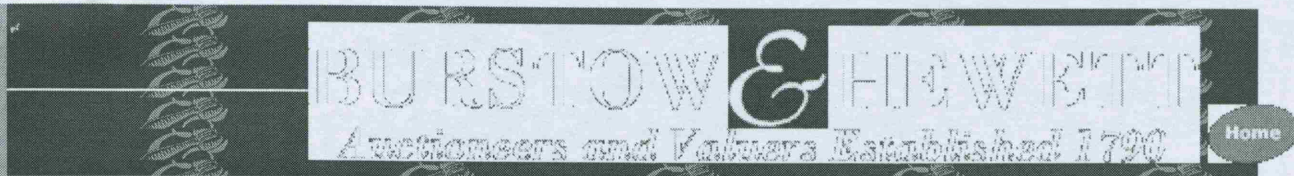

Dear Dr. van der Veen,

I am sorry that a long trip to Europe has delayed my responding to your e-mail of June 27th, regarding ABFA #1514, the painting of Jacob Blessing His Grandchildren by Trautmann.

I sold this painting to a private collector in Jerusalem. I have this collector's permission to send you a good black/white photograph as well as a color snapshot, but I would like to know whether I should send the photographs to Dr. van de Heer or to Dr. Koelsch. If the latter, please send me Dr. Koelsch's address.

You have a painting that I have loaned to your Rembrandt exhibition, RRP C-18, and Dr. van den Boogert told me at the Symposium on May 27th that he would return my painting by hand early in August. 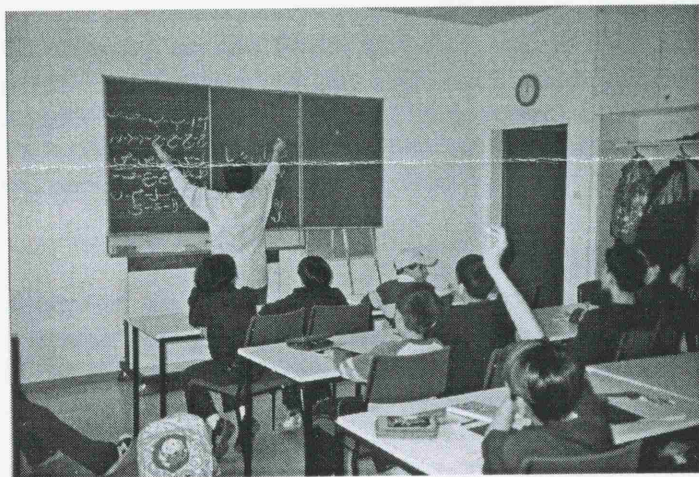

Mehran besuchte einen **therapeutischen Kurs**, der ihm konstruktivere Möglichkeiten für mit seinen Energien eröffnete, was sich sehr positiv auf seine schulischen Leistungen auswirkte.

Hassan, 33 Jahre, aus Somalia,

absolviert die Ausbildung zum **diplomierten Krankenpflegehelfer**. Hassan ist eigentlich bereits ausgebildeter praktischer Arzt. In seiner Heimat übte er seinen Beruf jedoch nur kurz aus. besuchen beide **Deutschkurs-Intensiv-Kurs**. Aleksandra ist seit eineinhalb Jahren in Österreich. Nach Abschluss des Kurses wird sie sich um die Aufnahme in einer Krankenpflegeschule bewerben.

Serifa lebt seit drei Jahren in Österreich. Sie gehört der Volksgruppe der Gorana an, einer islamischen Minderheit im Kosovo. Vor dem Krieg führte sie ein kleines Gasthaus, welches vorwiegend von Albanern besucht wurde. Im Krieg verdrängten serbische Polizisten die früheren Gäste, bis auch diese vor den anrückenden UCK-Einheiten flüchteten. Als Abschiedsgeschenk zerstörten sie das Gasthaus. Fliehen musste Serifa allerdings vor der UCK, weil sie Serifa als serbische Sympathisantin bezeichneten und drohten, sie umzubringen.

Serifa erhielt kein Asyl in Österreich. Ihr Asylverfahren ist beendet. In ihre Heimat zurück kann Serifa nicht. Doch ihr Leben muss weiter gehen. Sie lernt darum Deutsch, um vielleicht später wieder im Gastgewerbe Fuß fassen zu können. Aleksandra und Serifa sind übrigens im Heim Freundinnen geworden.

Viktoria, 18 Jahre, aus der Ukraine,

besucht ebenfalls einen **Deutschkurs-Intensiv-Kurs**. Viktoria flüchtete vor einem Jahr mit ihrer Mutter nach Österreich. Sie besuchte in der Ukraine die Maturaschule. Viktoria hat besonderes Interesse an der EDV und möchte später in diesem Bereich beruflich tätig werden.

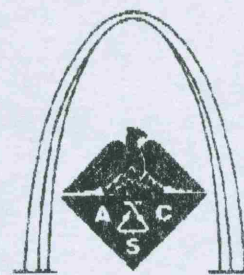

Dear Alfred,

A few days after sending off my letter of Shana Tova wishes, I received your letter of August 29th with enclosures of rather substantive nature.

In regard to the school issue, I have one caveat to add. Both the Reform and Conservative movements have over the last few years founded a great number of Day Schools as a result of the ongoing deterioration of the public school system and their realization of the urgent need to stem the proliferating assimilation of our young people.

This, of course, has created competition with the more traditional community schools such as the Hillel Academy, but at the same time it attracts youngsters who otherwise would be in the public schools devoid of any Jewish content.

My friend Rabbi Mort Green of Hamilton, Ontario held on to a monopoly of his Orthodox community Day School for more than thirty years, but is now competing with a Reform Day School which was started within the last two years.

I do not know the statistics, but presume that the new school has attracted students who surely otherwise would be in the public school system.

This does not fully address your sense of frustration, but is an interesting by-line to the problem.

Incidentally, I do support the idea of Conservative and Reform Day Schools, realizing that many children do not fit in an Orthodox Day School but for intellectual and social reasons should be in a Jewish surrounding.

You know, Alfred, there is a story of a Rabbi who had to rule on a dispute between two litigants. He first agreed with the claim of one and then agreed with the opposing claim and when the Rebbetzin asked how come, he responded "You are right, too!".

We live in a very complex time and are a very complex people ever since the beginning of history.

Your friend Adina Shapira has a point in trying to work for better understanding between Jews and Arabs – particularly children. We are all human beings, but at the same time, as you so eloquently wrote to Johannes Zang, Israel and the world Jewish community are being subjected to the most poisonous campaign of hate, of violence and of utter hypocrisy. Israel is fighting for its very existence and for the continuity of the Jewish people.

This confrontation makes reason, logic and morality an almost impossible task.

I attended last week a talk at Toronto's foremost Reform Temple – Holy Blossom – at which Prof. Benny Morris, the well known historian, gave a talk admitting that his strong support of Oslo and of the left-wing approach to the Israeli-Arab conflict was a great error in judgment and that he now realizes that it was never in the cards to create a peaceful existence with the Arab and Moslem world under present circumstances.

In his view, the occupation of the territories is not the issue at all, but the existence of the State of Israel in the midst of the Moslem world. Prof. Morris did not offer great hope for any kind of early solution to the problem, but he very strongly disavowed the philosophy which he so forcefully espoused in the past.

In three weeks from now on Simchat Torah we will be reading King Solomon's somber book of Ecclesiastes, decrying the injustice and hypocrisy of the world. Sadly we are witness to the daily suffering of humanity as a consequence.

When in Israel next week, I will visit my friends at the Shalem Institute and will discuss our correspondence.

Have I ever introduced you to the world of the Shalem Institute? On your next visit to Israel, you should make their acquaintance.

Once more, very best wishes for a better year than 5762.


We hope that you and your family are well. We here are well, trying to be optimistic and keep our hopes up for a peaceful future. Let us hope that our new year will bring us just that.

Thank you very much for your last call. Since then I did not have an access to the Internet in order to write you.

Some days ago I met Doc. Skursky. I have not seen him for a couple of years and both of us were happy to meet each other. He gave me a wonderful book: "History of Jews in Czech land and Moravia". Next summer I would like to visit some synagogues in Moravia. Many of them are beautiful but most of them are not used and that is painful.

For several Shabbats in August I was in Prague and visited Old-New shul and Jubilee synagogue. It was very good and satisfied a little my connection to the Hebrew. Upon my arrival in Prague I contacted the social department of the Jewish community. I wanted to help with something. For one week I was bringing food to old and sick people and talked to them. In July I was also accepted to the Jewish studies at the Potsdam University. If I will start it in the fall 2003, I still would like to find a 1-bedroom apartment in Prague and come as often as possible in order to do something for the future of Judaism in my country.

Of course, I still want to teach biochemistry and organic chemistry and hope that the Jewish high school and perhaps some special lectures at the biochemistry department of the medical school will satisfy my interest for the science and simultaneously my degree in the Jewish studies will enable me to find a qualified position in the Jewish community – as many of my friend at Pardes try to do too.

Today morning I arrived in Jerusalem. Despite the situation and death of my dear roommate and another friend in Pardes, I am very happy to be back here. Perhaps I am

not afraid not to exist but more I feel a passion to study – this year even with Judy Klitsner. I am very grateful to you and Isabel for this unique opportunity. *Toda raba!*

Dear Friends,

As we prepare to bid farewell to the old year and welcome in the new, we too feel called upon to "balance our accounts". There is no need to remind either ourselves or you of the terrible events and suffering that marked this year. Yet, as we take stock of NISPED's activities, we find that this has been a year of progress and achievements – and yes, of active affirmation of our commitment to peaceful coexistence and cooperation with our Arab fellow-citizens and our neighbors across the border.

After the traumatic events of September 11th, and the continuing Intifada, we feared that this spelled the end of NISPED's **international training program**. However, the six one-month courses, conducted in cooperation with the Israel Ministry of Foreign Affairs, took place without a hitch. 180 participants from more than 25 developing countries attended our courses on peace education and on development of comprehensive support services for small and medium enterprises. We also conducted a study mission for a group of Nigerian parliamentarians. Our international program is already in place for the coming year.

October 2001 marked the beginning of "*Youth and the People-to-People Peace Process: Educating for Peace and Community Service*", a three-year joint project of NISPED and the Palestine Dialogue Center in Gaza, sponsored by the U.S. State Department's *Wye River People-to-People Exchange Program*. The support of the Greek Andreas Papandreu Foundation and Delphi Ecumenical Union has enabled us to hold joint meetings and training programs in Greece for Palestinian and Israeli youth leaders. They in turn, will direct educational initiatives in their respective communities. This month, a group of 10 Palestinians and 10 Israelis (including 2 Arab-Bedouin) will meet again in Delphi to plan parallel community projects – which, hopefully, will one day turn into joint projects.

The jewel in our crown is of course **AJEEC – the Arab-Jewish Center for Equality, Empowerment and Cooperation**, which, under the direction of Amal Alsana Elhajooj, has in the brief year-and-a-half of its existence moved from strength to strength. AJEEC's programs include:

- *Otzma Mekomit* ("Local Empowerment") - a leadership training program for Negev Bedouin municipalities and volunteer organizations. This is an innovative 9 month course supported by Mafam, the Ministry of Interior's training arm and the Goldman Fund. 23 men and women from the seven recognized Bedouin townships in the Negev recently completed the first course. The JDC has joined us as a major partner in our second course due to start this month.
- *Still and Video Photography and Entrepreneurship* - 26 Bedouin women have completed a training course organized together with MATI, the Small Business Development Center in Beer-Sheva. They are now eligible for small bank loans to start their own photography business (enabling them to photograph female participants at weddings and other community and family events – something that men may not do in this traditional society). Over the coming year, they will receive additional in-service training and individual counseling and support services as they proceed with their enterprises. The media has been captivated by this course. In fact, Channel One of Israeli TV filmed the recent wedding of one of our photographers

which was being photographed and videoed by her co-students. The piece will be screened shortly on prime time!

- *Parents as Partners Community-Based Early Childhood Education Program*- 25 Arab-Bedouin women from both the recognized townships and the 'unrecognized' peripheral villages completed a 60 hour basic training course for paraprofessional early childhood counselors, and are poised to begin on-the-ground implementation of the program. This program is being supported by the Jewish Community Federation of San Francisco, the Steinhardt Family Foundation and U.S.-Israel Women-to-Women. The Trust for Programs in Early Childhood, Family and Community Education in Arab Society has joined us in facilitating this project. Under the direction of a professionally-trained early childhood educator from the community, the women are about to begin organizing mothers' and infant and toddler's groups in four non-recognized villages and one township.
- *Leadership Training Course* - 39 women from Laqia, aged 23 to 66 (in some cases, mothers and daughters) took part in a 12-session-long program conducted by AJEEC in partnership with the Laqia Women's Association and supported by the Gimprich Family Foundation. At the conclusion of the course, the participants established a *Mothers' Committee for Education*. We are hoping to replicate this pilot program in other communities.
- *Training Program for Community Mediators* - 8 Jewish and 8 Arab-Bedouin professional women recently completed this program conducted jointly with the B'nei Shimon Regional Council and the Joe Alon Center.
- *Pupils Creating Change* – an Arab-Jewish project bringing together 10th and 11th grade student council members and teachers from 2 Bedouin and 2 Jewish high schools in a year-long program of co-existence workshops and joint community projects. We are conducting this project jointly with the Givat Haviva Jewish-Arab Center for Peace with the support of the Abraham Fund.
- *The Community Service Tent* - a project for Arab-Bedouin and Jewish volunteers in cooperation with the Scouts Youth Movement and the Alon Association. Following intensive training, 20 high-school graduates (10 Bedouin and 10 Jews) will spend a year devoted to community service, building Jewish-Arab cooperation and benefiting the community through educational projects they will conduct for children and youth of neighboring communities.

To make all this possible, the original AJEEC team of Amal Elsana Alhajooj and Nabhan Macawi has been reinforced by three new members: Ibrahim Abu Gever, who is completing his B.A. in Middle Eastern and General History at Ben Gurion University is coordinating the Community Service Tent. Nasser Abusrichan, a professional social worker with an M.A. in Public Administration from Ben Gurion University is coordinating the second Municipal and NGO training program, and Nada Abuganem, trained in Early Childhood Education at Achva College is coordinating the Parents as Partners program.

As you can see, despite the political and security situation, we've had a year filled with achievements and progress made possible by the help of our friends and supporters in Israel and abroad – and for that we are indeed thankful. We pray and hope that all of us will be granted the strength and health, and above all the peace, to continue striving to make our world a better place for our children, our fellow men and women, and ourselves.
