Dear David:

Thank you for your letter of March 18th. Isabel and I look forward to being at Queen's for the Board meeting in May.

Please allow me to share a disturbing matter with you.

As Donald Duff is leaving, I asked him for the balance in the account which will become the capital for the fellowships in art history. His reply (A) is enclosed.

Every figure in this is in error.

When last I enquired, in 1987, the total stood at \$514,000.90 (B). Since then, there have been three changes; namely, the Canadian \$140,000.00 for the Wrights of Derby, a U.S. \$40,000.00 purchase of paintings and whatever income accrued on the balance. Hence, the balance cannot be less than \$310,000.00, not \$170,774.82.

The Dale purchase was in Canadian dollars, \$140,000.00.

The error that worries me the most (because it may be money actually lost, rather than just sloppy accounting) is the statement that U.S. 40,000.00 was Canadian 58,094.25. This suggests that the Canadian dollar was U.S. 68.9¢, but it was never that low. It was 0.7616 on November 30, 1987, so that U.S. 40,000.00 was Canadian 52,500, a difference of about Canadian 5,600.00. That is an enormous bank charge; is Queen's being overcharged?

Unfortunately, this is not the first time that I have received grossly wrong figures. Note that in a previous accounting (C), the addition was wrong, and that was corrected in (B).

You will share my main worry: Queen's must have hundreds of such accounts. How many are in error? The person responsible (surely not Donald Duff) is incompetent, but should there not be audit procedures?

You may have heard of my argument with the Friends of Queen's in New York who refused to turn over to Queen's the very substantial interest earned on my gifts over many years (estimated at \$100,000.00). That matter was never resolved to my satisfaction, and I was so happy when new U.S. I.R.S. regulations allowed graduates of Canadian universities to make gifts to Canada directly. I never dreamed that at Queen's not just interest, but the capital would be endangered.

I am deeply worried.



Dear Mr. Duff:

I am sorry that my visit with you last week had to be so very brief. I plan to be at Queen's for two days at the time of the next Board of Trustees Meeting and hope that we might then have a more leisurely visit.

You realized that the accounting in your letter of August 25th contained a clerical error, and that the balance should now be \$280,475.93. To that should be added the U.S. \$160,000+ which you will receive from Baird for the sale of Manpower stock.

I am concerned by the letter of August 28th which states "the sale of 1181 shares of Manpower shares as requested by Dr. Alfred R. Bader". This is factually incorrect and could get me into real difficulties with the IRS. Please let me explain: I have and will always donate stock and leave the decision whether you should keep the stock or sell it, entirely to you. Under no circumstances can I request that you sell it. In this specific instance, I had given you the alternatives and had actually thought that Queen's might do what, in fact, I am doing with my stock, simply, tender the stock to Blue Arrow for \$82.50 per share. Please don't think that I am just nitpicking, but my attorney has pointed out to me that I must never request that you sell stock.

I am now negotiating with a local dealer to purchase approximately U.S. \$40,000's worth of paintings recommended by the acquisition committee at the art center. The invoice will be received by you well before my next visit.

This Fund was established by the Baders to finance the purchase of works of art for the Agnes Etherington Art Centre. Alfred and Isabel Bader have offered to establish a fund that will accrue interest until their deaths. Upon their deaths the income of this fund is to be used for the restoration and conservation of the old master paintings belonging to the Agnes Etherington Art Centre at the discretion of the Director of the Art Centre.

Dr. Bader has indicated he will put \$50,000 in this Fund.





### LETTER OF INTENT

Through my donations and in accord with my expressed wishes, Queen's University at Kingston in Ontario, Canada has established a fund which during my lifetime is to be used for the purchase of works of art for the collection of the Agnes Etherington Art Centre at Queen's University.

It is my wish that on or before December 31, 1997, whether I am alive or not, the unexpended and uncommitted funds in this account be employed as follows:

If, by December 31, 1997 or earlier, Queen's University establishes a Ph.D. program in art history, the money in the account at the time of the establishment of the Ph.D. program is to be used for the endowment of one-year travelling fellowships to Europe, to be awarded to graduate students in art history working for their Ph.D. degrees at Queen's.

If, at the discretion of the Department of Art History, there are no sufficiently qualified Ph.D. students for all the awards, the department may leave the unused portion with the capital, or may use it to improve the library of art history or other suitable services of the department. For example, if \$15,000 is the amount deemed reasonable for a travelling fellowship, and the income is \$100,000 that year, but there are only four qualified students, then the Department of Art History may at its discretion leave the balance of \$40,000 with the capital or use part or all to improve the library or other art historical services.

Failing the establishment of a Ph.D program in art history by December 31, 1997, the money in the account is to be distributed equally between the Department of Art History to establish undergraduate and graduate scholarships (the latter for M.A. students), and the Department of Chemistry to establish scholarships and fellowships in organic chemistry. The awards in chemistry are to be divided between undergraduate and Ph.D. students in the ratio of one to two in dollar amounts. The division between undergraduate and M.A. students in art history is to be left to the discretion of the Department of Art History.

Thus, for example, if by December 31, 1997 no Ph.D. program has been established, and the income available in 1998 is \$100,000, then \$50,000 shall be used for scholarships in art history, \$16,666 for undergraduate scholarships in organic chemistry and \$33,334 for fellowships for graduate students in organic chemistry working for their Ph.D. degrees at Queen's.



I am sorry that my visit with you last week had to be so very brief. I plan to be at Queen's for two days at the time of the next Board of Trustees Meeting and hope that we might then have a more leisurely visit.

You realized that the accounting in your letter of August 25th contained a clerical error, and that the balance should now be \$280,475.93. To that should be added the U.S. \$160,000+ which you will receive from Baird for the sale of Manpower stock.

I am concerned by the letter of August 28th which states "the sale of 1181 shares of Manpower shares as requested by Dr. Alfred R. Bader". This is factually incorrect and could get me into real difficulties with the IRS. Please let me explain: I have and will always donate stock and leave the decision whether you should keep the stock or sell it, entirely to you. Under no circumstances can I request that you sell it. In this specific instance, I had given you the alternatives and had actually thought that Queen's might do what, in fact, I am doing with my stock, simply, tender the stock to Blue Arrow for \$82.50 per share. Please don't think that I am just nitpicking, but my attorney has pointed out to me that I must never request that you sell stock.

I am now negotiating with a local dealer to purchase approximately U.S. \$40,000's worth of paintings recommended by the acquisition committee at the art center. The invoice will be received by you well before my next visit.


