Dear Laurie Winters:

Good to speak with you today. Thanks for so promptly getting back in touch with me.

As I told you, almost a year ago, I came to Milwaukee to visit with Alfred and Isabel Bader. My intentions were to discuss with them the possibility of a loan of pictures from their splendid collection for an exhibition at the Albany Institute of History & Art. While in Milwaukee, I inquired about *The Grocery Seller with a Boy* by Hendrik Bloemaert, formerly in the Bader collection.

Alfred told me that it was now in the permanent collection at the Milwaukee Art Museum; and he urged me to visit while I was in the city. I spent a most enjoyable Saturday morning there. But, of course, I did not find that picture on view then.

The exhibition, for which I am a guest curator, is *Matters of Taste: Food and Drink in 17thcentury Dutch Art and* Life. The Albany Institute of History and Art will mount *Matters of Taste: Food and Drink in 17th-century Dutch Art and Life,* in September 2002. That year, Albany will be celebrating its 350th anniversary having been originally established as the Dutch settlement of Beverwyck, some years before the English gained control.

Peter Rose, who is a culinary historian, and I will jointly serve as guest curators. We will utilize still life and genre works including kitchen scenes, market scenes, tavern scenes and depictions of festive occasions in which food and/or drinks plays an important role.

The exhibition of art works, drawn from American museums and private collections, will be supplemented with a display of decorative arts objects -- redware pottery, pewter plates and a pewter tankard, a silver standing salt and silver brandy bowl, a glass wine roemer, flute, and beer beker, a glazed earthenware kan, wafer and waffle irons -- used by Dutch households and depicted by Dutch artists. Furthermore, a small selection of historic Dutch cookbooks and advice manuals on food and drink will be displayed.

Peter Rose is the translator of the 17th-century cookery book, De Verstandige Kock. She

traces its influence on the perpetuation of Dutch foodways in New Netherland and the American kitchen. An early edition of that book, printed in the more extensive collective volume, *Het Vermakelijk Landtleven*, will be displayed along with Stephanus Blankaart's *De Borgerlyke Tafel*, for which Jan Luyken provided the frontispiece.

Jointly, we will offer a different "take" on the art works, underscoring the ways in which they offer feasts for the eyes, food for thought, and a sampling of Dutch foodways.

As I told you in our conversation, Alfred and Isabel have agreed to lend the Constantijn Verhout, *Portrait of Cornelis Abrahamsz. Graswinckel*, and Pieter Claesz, *Still Life with Shrimp* from the collection at their home. Alfred has also agreed that should he still have the Anthonie Palamedesz, *Merry Company* in his gallery, he'll lend that, too.

You know that it is our hope that the Milwaukee Art Museum will also lend the Bloemaert picture to the Albany exhibition. I very much want to explore the issue of genre-fied portraits in which foodstuffs appear, and that Bloemaert is a splendid example.

Alfred and Isabel have asked the Albany Institute to allow them to make their usual arrangements with the Milwaukee Art Museum for the packaging and transport of their pictures. I would hope that the Bloemaert might also be included in that shipment.

You've indicated that there should probably be no obstacle to including the Bloemaert in Albany's show, but that 2002 promises to be a very busy year for your Museum, too. I hope you will take up this matter soon with your loan-request committee.

Thank you very much for your cooperation. I have one further favor to ask. Could you arrange to have a color photo or transparency of the Bloemaert sent to me at my home address? I'd be most appreciative.



Dear Mr. Bikker,

Thank you so much for your fax of yesterday which I would like to answer in detail right away.

Under separate cover I am sending you a black/white photograph of Drost's *Young Boy*, Sumowski 259A. I am happy to know that I own at least one Drost.

Some months ago I wrote to you about the painting of Hendrikje as Venus with Cupid, of which there is another version at the Louvre. Could this painting be by Drost?

On November 21, 1933 it was sold in Berlin, at Lepke, #120, there given to Ferdinand Bol with a note that the painting is signed with the signature difficult to read. Unfortunately, the painting was subsequently cut down and the signature disappeared. Naturally I would very much appreciate your comments.

Isabel and I plan to be in Holland from the 5<sup>th</sup> to the 12<sup>th</sup> of November, and then in England until the 22<sup>nd</sup> of December, when we return to Milwaukee. We will be here most of January, though if there are some really exciting paintings in the New York auction, we may attend.

There are very good flights on Midwest Express from Toronto to Milwaukee and if you fly over a weekend they are really quite inexpensive, costing about \$250. Naturally I would pick you up at the airport and hope that you would stay with us at home.

Did you know that I had a really strong argument with Queen's about the University charging Bader Fellows full tuition.<sup>1</sup> The University then agreed to raise the Bader fellowships from C\$20,000 to C\$30,000 and only to charge half the tuition. Did you receive a refund?

Did Christie's in London send you a photograph of a second version of my Sweerts self-portrait that turned up at Christie's, only for study? The original was seen by Malcolm Waddingham, Axel Ruger and Lindsay Shaw-Miller, Otto Naumann and myself and our opinions vary greatly. Of course I would appreciate your opinion.

I plan to bring a little panel with me to Holland in November, Bredius 261. I do not think this is by Drost, but you might enjoy looking at it anyway.

Dear Mr. Bikker,

I just spoke to Professor Manuth by telephone and he told me that he had spoken to you about my very long letter to which I have not received a reply. Professor Manuth told me that you did reply and so sadly we can only conclude that your reply got lost in the mails.

I hope that you have your reply in your computer and could perhaps send me a copy, either by fax to (414) 277-0709 or by e-mail to <u>baderfa@execpc.com</u>.

After hearing from you that you considered Horst a possibility for my painting, I wrote to the RKD – of course, without mentioning your opinion – to inquire what they think about my painting. Dr. Jan Kosten replied on May 19<sup>th</sup> and I enclose a copy of the relevant opinion.

More important, I do of course hope that you will have a chance to visit us in Milwaukee before you send your manuscript on Drost to a publisher. There is at least one painting here which you accept as a Drost. Maybe on seeing the collection you will accept two or perhaps even three.


You may also want to look at my self-portrait by Sweerts. Incidentally, another version of my painting – with significant differences – turned up at Christie's in London. It is there not for sale but for study; surprisingly, it was previously attributed to Lely.


Due to my being abroad (Spain & Hungary) and being ill with the flu during April and May, I did not have time up till now to answer your letter. From Marijke de Kinkelder I gathered that you particularly wanted to here from me concerning 2000-1. I must say that I think the Sumowski attribution to Willem Drost to be a very convincing one. The painting is to my mind very compatible to the firm and manly painting style of Drost. I do not see any links to the oeuvre of Carel Fabritius: just put it e.g. next to Fabritius'female portrait in Hannover (Sumowski II, p. 995 nr. 608) and this attribution falls through with a bang. The Van Meegeren attribution of Blankert that you mention is a complete mystery to me. This artists week pastiches have nothing to do with your painting, apart from the fact that it is a genuine 17th century work. I was unable by the way to locate this pencilled notion that you mentioned in your letter of July 20, 1981 to him: maybe it has been removed already I beg to differ on the other hand with Prof. Sumowski concerning the subject: I do not believe it to be Isaac and am almost convinced that the sitter is a woman in Oriental dress. Another contention of Prof. Sumowski that it is akin to the Prague Annunciation and datable to 1652=3 is also puzzling to me. The Prague work is so much more in the emotional, telling style of Rembrandt where your painting is stillness and serenity itself. I see much more Italianate influences in it (or even something of a George de la Tour) that the work must originate from Drost's Italian period (1656- before 1663, by which time he was back in Holland). I do not believe the medal of Don Inigo d'Avalos as mentioned by the late Prof. Middeldorf to be the only example: Drost must have seen many sixteenth century portraits of the profile type in Venice from which he could possibly have taken his inspiration (see for Drost in Italy: B. Aikema, 'Een Venetiaans schilderij van Willem Drost', Oud Holland 163 (1989) 2, p. 115-117. The Italian provenance through George Frederick Watts could be seen as further corroboration of this Italian period origin.

#### CONDITIONS

All information and conclusions about art objects, provided upon the owner's request by the RKD, are the result of the particular art historian's investigation and the RKD's latter containing such information is not intended as an expertise.

All liability for consequences

The 2000-2 portrait never convinced us as by 'follower of Nicolaes Maes' as the Sotheby's 9 November catalogue stated. And although we (my colleagues of the foreign art department and myself) appreciate your Levecq suggestion we are more in favour of a French attribution. Levecq puts more light in and emphasis on his faces, while his sitters are usually your typical Dutch merchants with big hats.








When I was in Brno in June Ms. Zora Pelouskova showed me a number of paintings in the Moravian Gallery there.


One of those, of an old man, an allegory of the passing of time, is I believe by an artist I know, Pietro Bellotti, an Italian who worked for quite a while in Munich.



### Dear Joe,

In reply to your e-mail of yesterday evening it seems to me that Otto's arithmetic is correct. He is using your calculation that we should pay him a commission of \$2,435,243 and therefore he would pay me the difference of \$1,564,757 for repayment of his personal \$4 million loan.

Incidentally, the next date for interest payment is March 19th not, as he thinks, March 17th. The problem I have of course is that the loan to Otto of \$4 million was made by me personally and we cannot just have ABFA pay Alfred Bader the commission. Rather, I think I should send Otto an ABFA check dated March 19th for \$2,435,243 and then have him send me personally two checks: one for the \$4 million principal and one  $f_{G_i}$  \$60,000 interest.

I will call you in a little while to discuss this.

I do believe that we will have a good year this year and of course we have already received \$1 million from Mark Fisch. Therefore, I do not think we should complicate matters, but simply charge the commission in 2007.

I will talk to you soon.

When I asked you if you had an abstract on The Detective's Eye slide talks I & II for the Art Dept. Chairman, I was expecting a brief abstract and not the elaborate catalog you sent for which I thank you very much. I read some of the interesting stories about the paintings before loaning it to the Art Dept. Chairman for his perusal. It looks as if we would like to hear those two slide talks, The Bible through Dutch Eyes, History of the Aldrich Chemical Co., and one more to be chosen- making a total of five talks. It looks as if someone else in the science field also finds old Dutch paintings of interest. There are direct flights both from LaGuardia and Toronto to Milwaukee, both non-stop and I do hope that before long you will be able to visit us in Milwaukee also.







In response to your letter of August 1st, I must tell you that I have never seen that reproduction before, and I am certain that I would remember if I had seen it.

It is a relatively modern painting, painted early this century, of course before 1934, the trademark date of the Quasung Rubber Company.

We called Massachusetts Directory Assistance and the Massachusetts Secretary of the Commonwealth (equivalent to Secretary of State), and the company is neither there nor known.

As the painting was copyrighted in 1934, you could write to the Copyrights Office of the Library of Congress to request a search of the copyright records. The original copyright would have been for 28 years, through 1962 if 1934 was the original, and may then have been renewed for an additional 47 years. They can also provide information on any transfers of copyright ownership and the current address (if any) of the current copyright holder. However, they estimate the cost at \$40 (2 hours at \$20/hour), payable with your request. I don't believe it would be worth it.

The painting is like that of a number of American illustrators, such as Frank Hoffman, for instance, who did the painting on the cover of AccuStandard catalog, details enclosed.

Please allow me to keep the print you sent me, and I will ask a number of historian of chemistry friends who are even older than I am to see whether they remember any details of this.


