I so appreciated your thoughtful letter of November 6th.


Isabel and I are just leaving on our long trip to the major old master auctions in England and Holland, and we much look forward to seeing you and your wife after our return on the 26th of December.

Of course, every author and prospective author appreciates the kind comments which you made, and I really look forward to discussing them with you when next we meet.

A great deal has been published about my dismissal from Sigma-Aldrich, and I enclose two papers from the leading chemical magazines in the United States and Britain. You may be particularly amused by the letter written to <u>Chemistry in Britain</u> from two of England's ablest organic chemists.

Also, I received hundreds of letters, faxes and phone calls and didn't really know how many friends I had around the world, until I was dismissed. Perhaps the most instructive is a letter written by an old friend who has known Tom Cori and me for years. That letter, copy enclosed, probably gives the real reason for my dismissal.

Of course, there have been silver linings: had I not been dismissed I would probably not have purchased the Rembrandt which I sold to the Rijksmuseum, nor would I have had the funds for that beautiful castle in England, Herstmonceux, which now belongs to Queen's University. As you will see from the enclosed document from Harvard signed by another Nobel laureate, E. J. Corey, chemists around the world still do appreciate me and I try to help wherever I can.



Enclosed please find my autobiography, which was published in London last year and which has had some good reviews, mainly in scientific journals.


In any case, Isabel and I very much hope that you will visit us again and that we will really get to know each other.



I had much hoped that you and your wife might come to Milwaukee to look at paintings, but the weather has been so horrible.


Isabel and I will be in Florida the first two weeks in February, but after that time I do hope that you will come; I have many new works to show you.

You must have realized how very much Isabel and I enjoyed meeting you yesterday.


