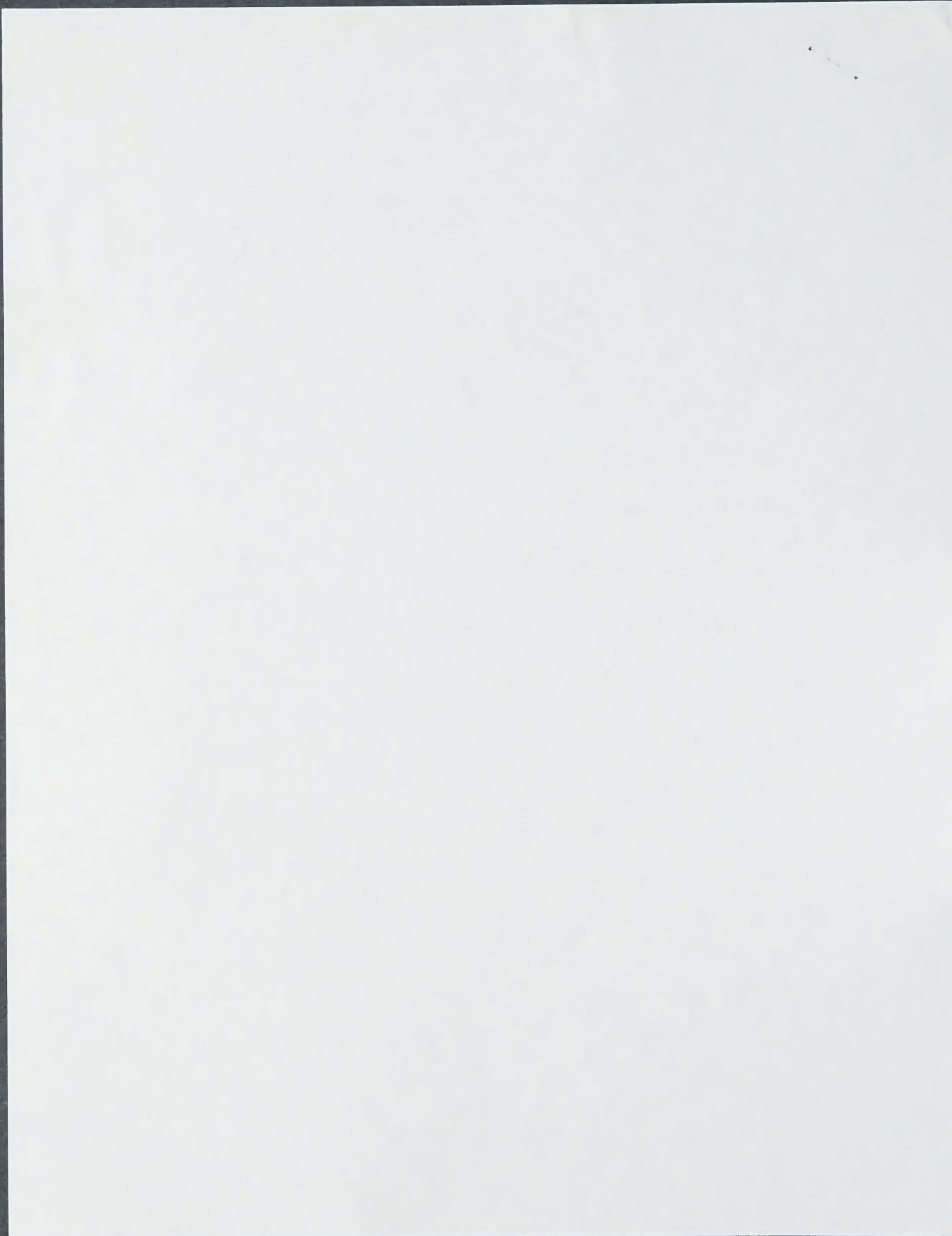

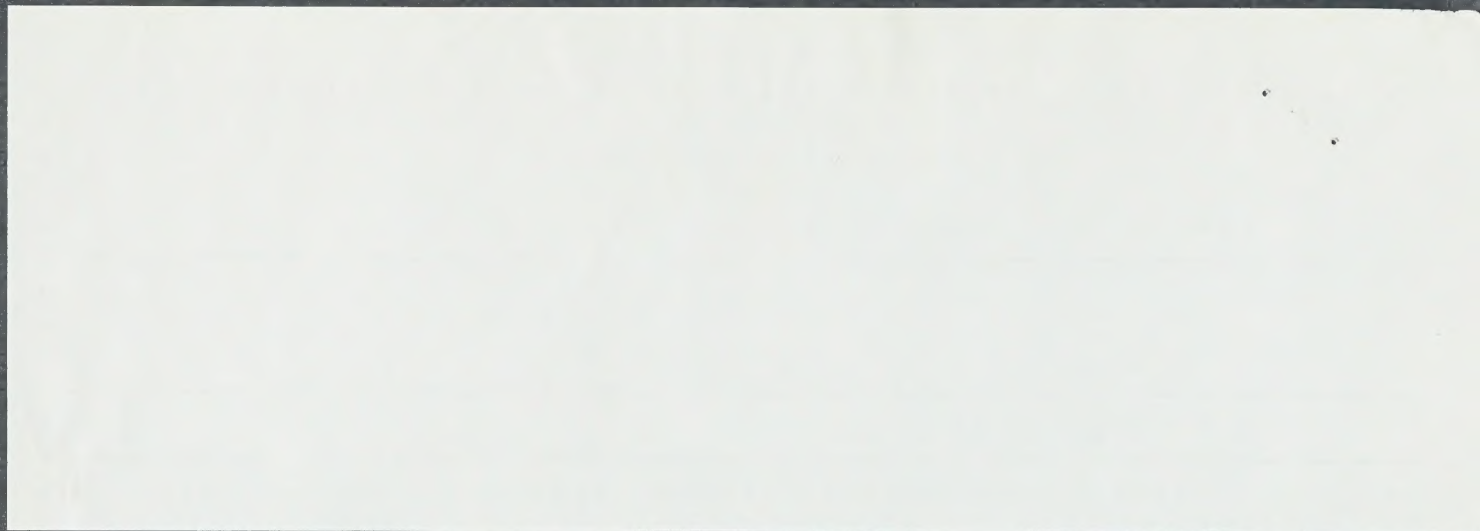

Please do let me know when they are coming up for auction, as I would not like to miss it.

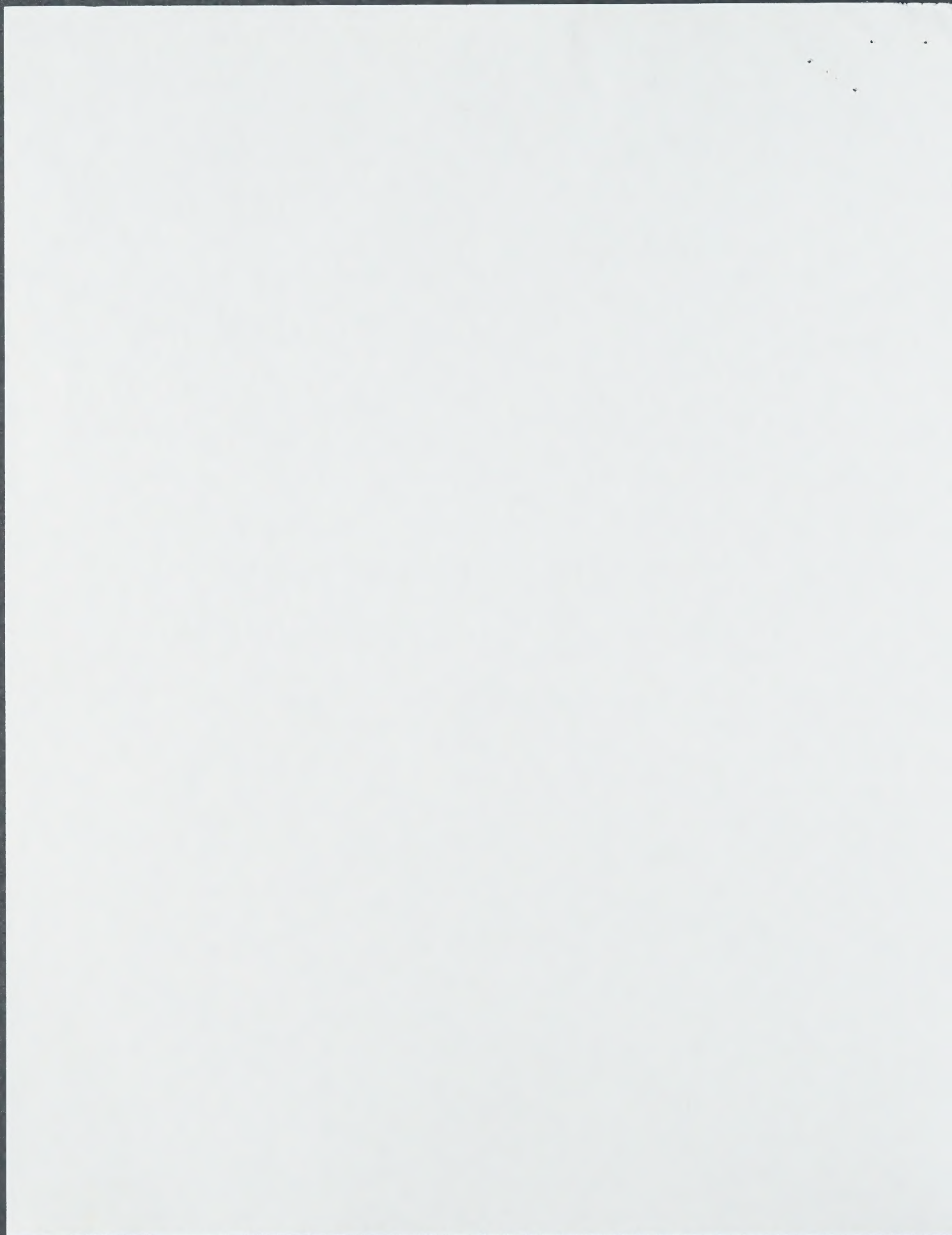

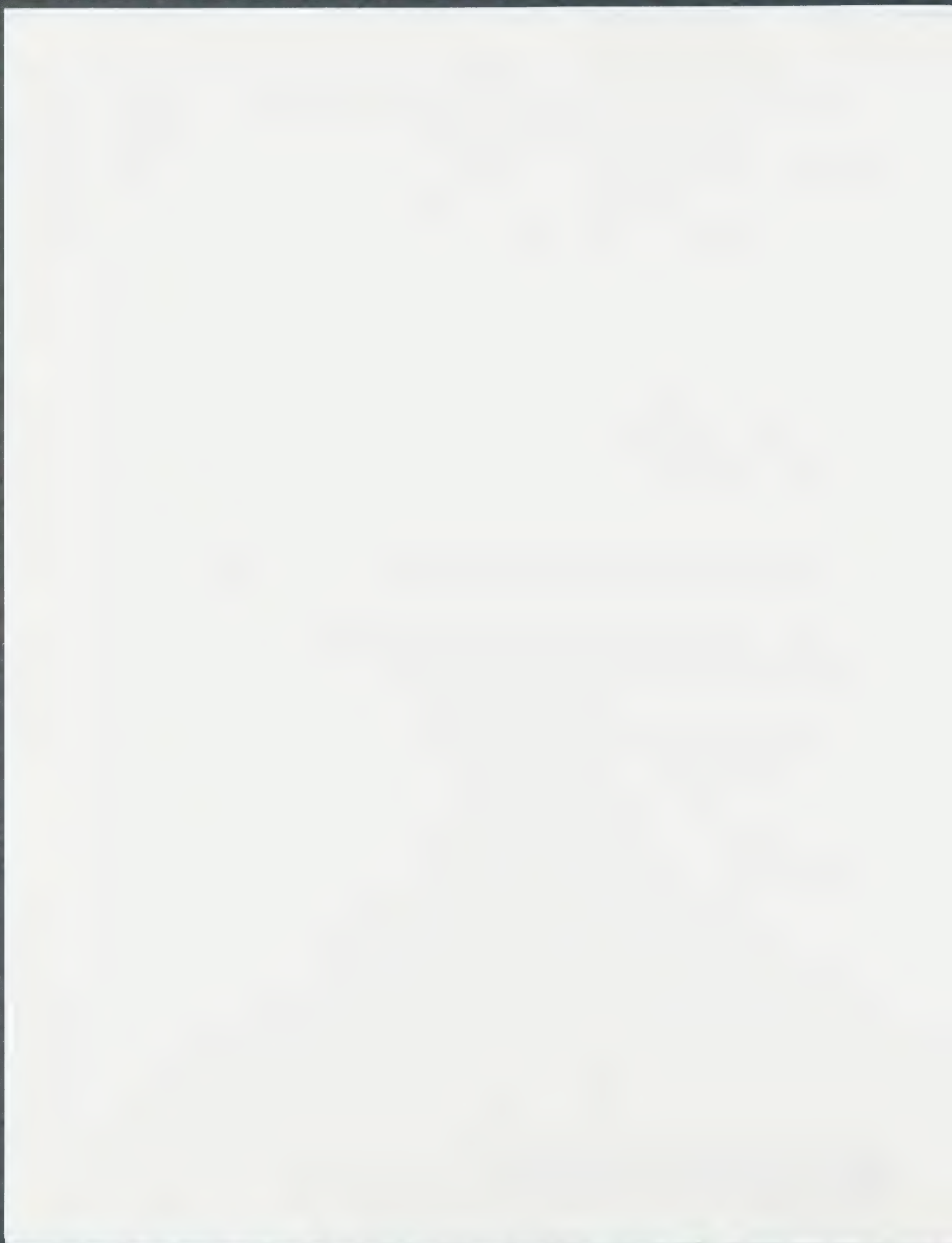
I would love to be able to buy more old master pictures at your auctions, and perhaps our meeting will lead to that.


Dear Dr. Bader:

I would love to have an opportunity to take you to lunch; please let me know if we can set up a mutually convenient time.

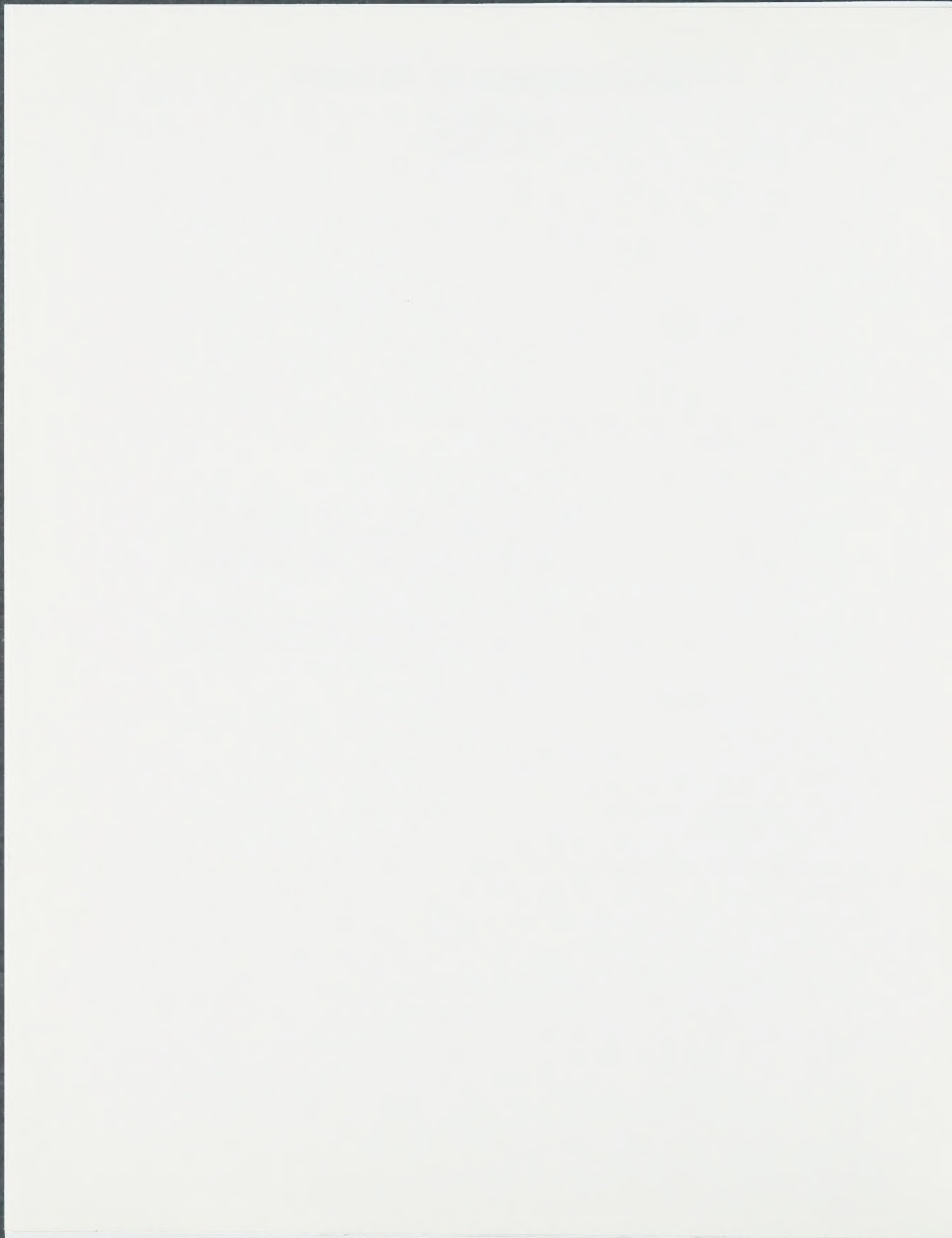
