

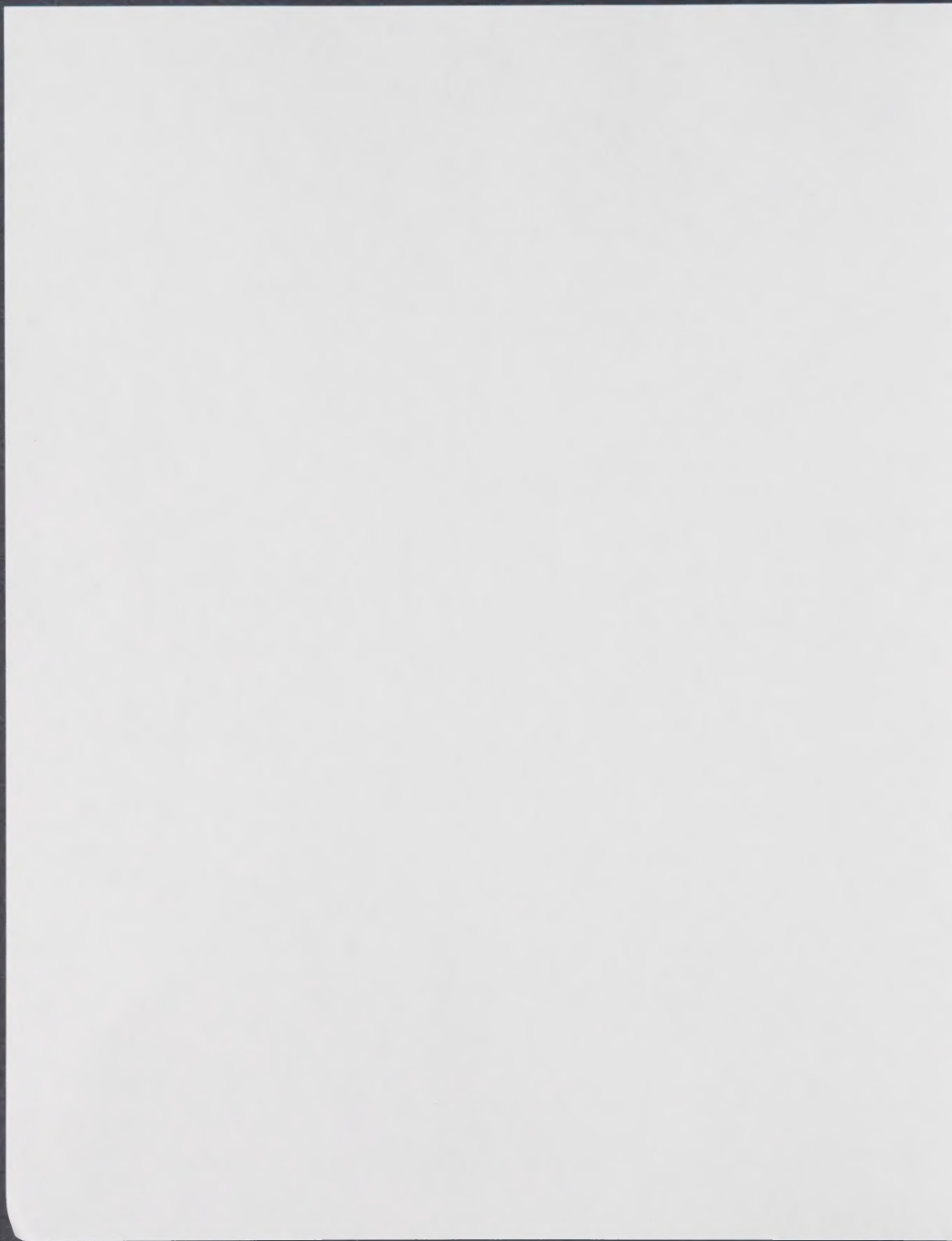

Thank you for sending the check so promptly.

As you will see, Isabel and I worked hard yesterday to pack your three paintings, and they are leaving tomorrow by 2-day UPS, insured for \$7000.

I took the glass from the front of the drawing and packed it separately. We put some plastic around the drawing and you should, of course, remove it.

We tried to back the Laurencin particularly carefully, and then put it into a black art-carrying case which I would like to pick up when next we visit you in Vero Beach. If on the other hand you visit us before then, please bring it with you.

Enclosed please find some paperwork which was back of the drawing. The insurance for this drawing was so low, \$3000, because the exhibition was quite a few years ago.

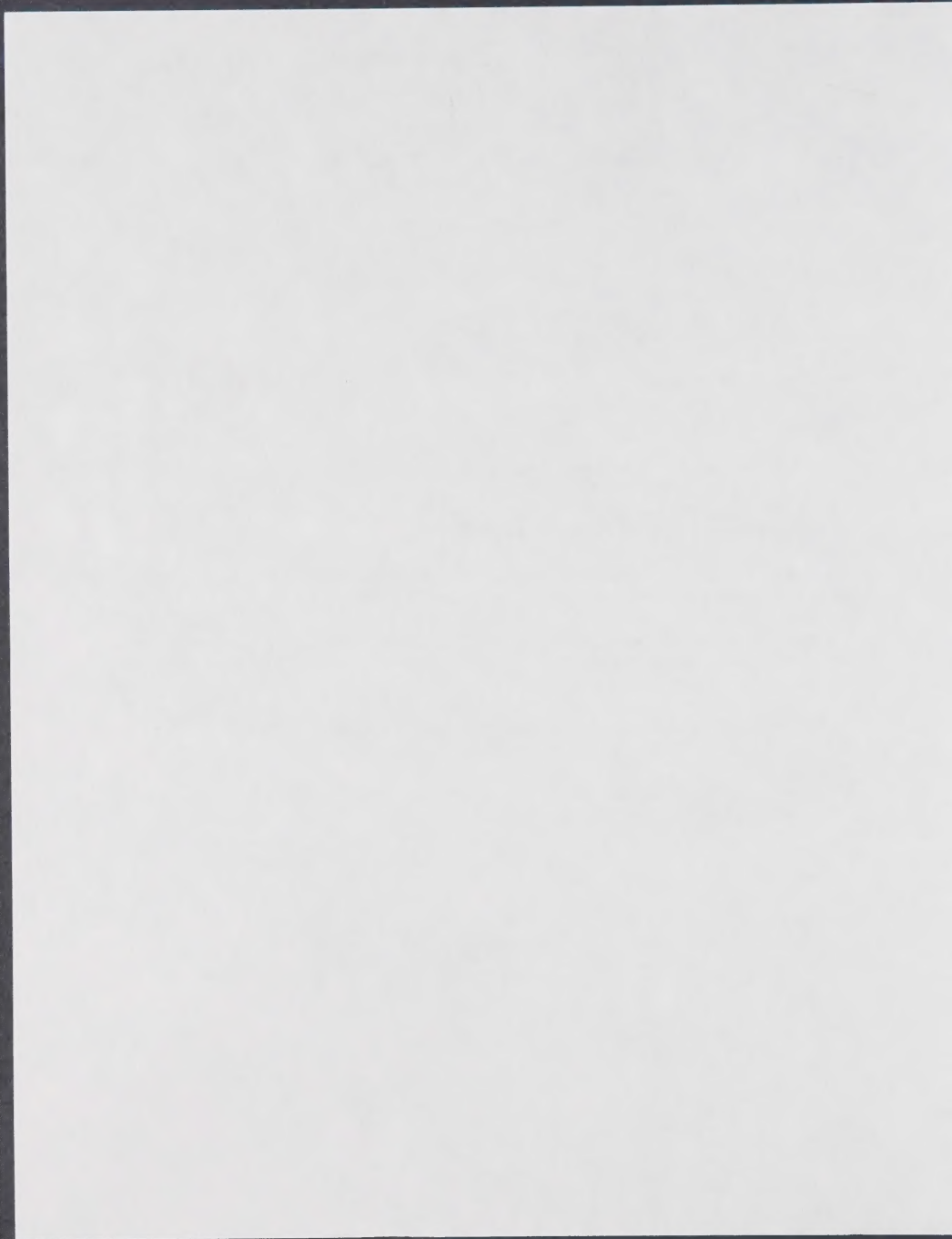
I hope that you will do so well with all three works that it will encourage you to come back soon. We will be in Europe from the middle of May to the end of July, but August is pretty free.

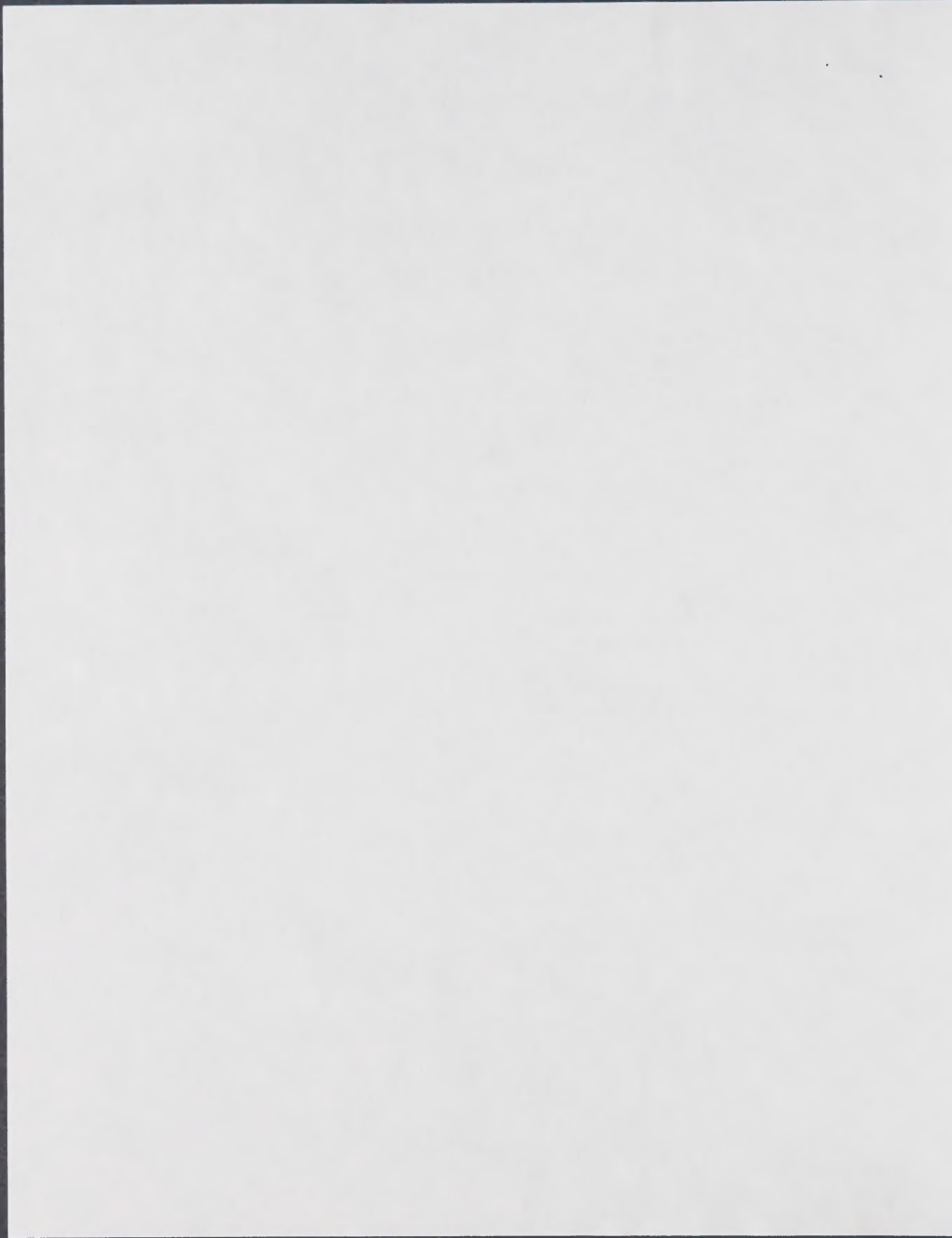

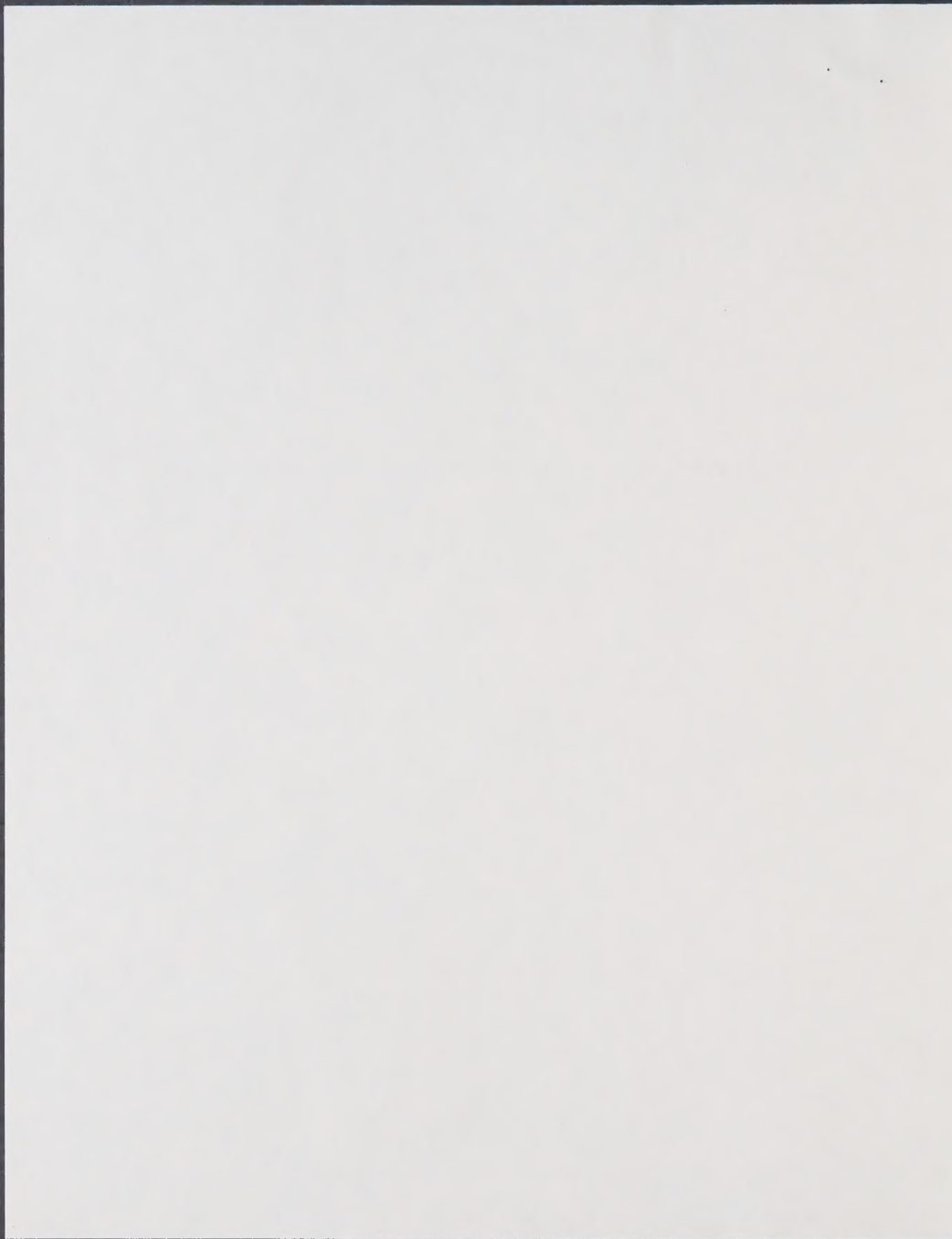

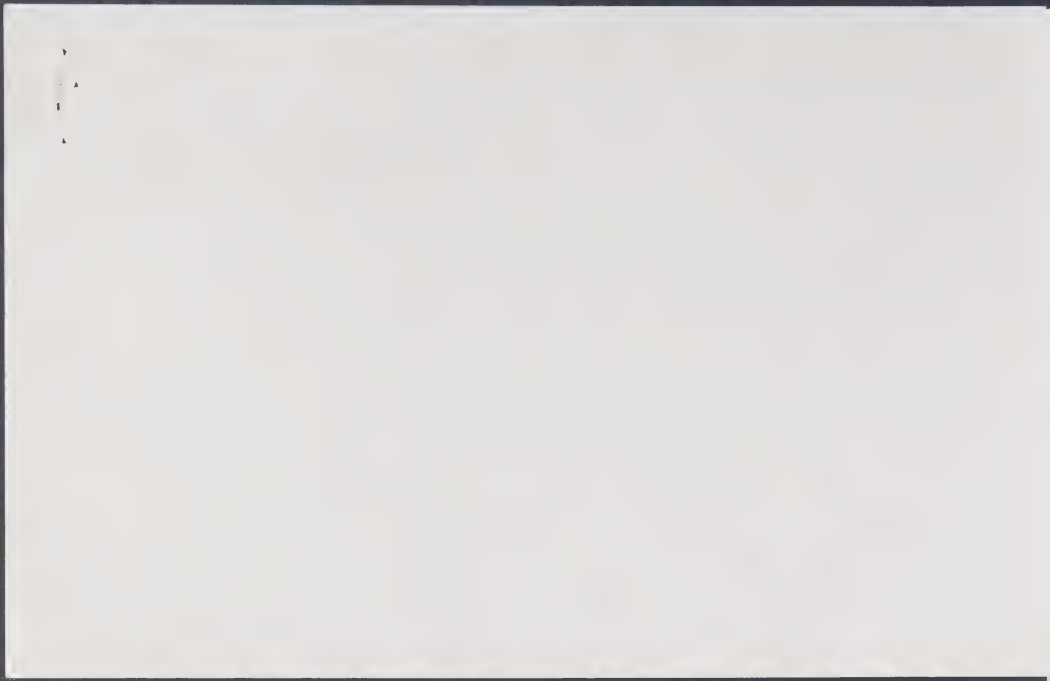

I have scheduled a photographer to photograph the four works that you liked and I will send them to you in the near future.

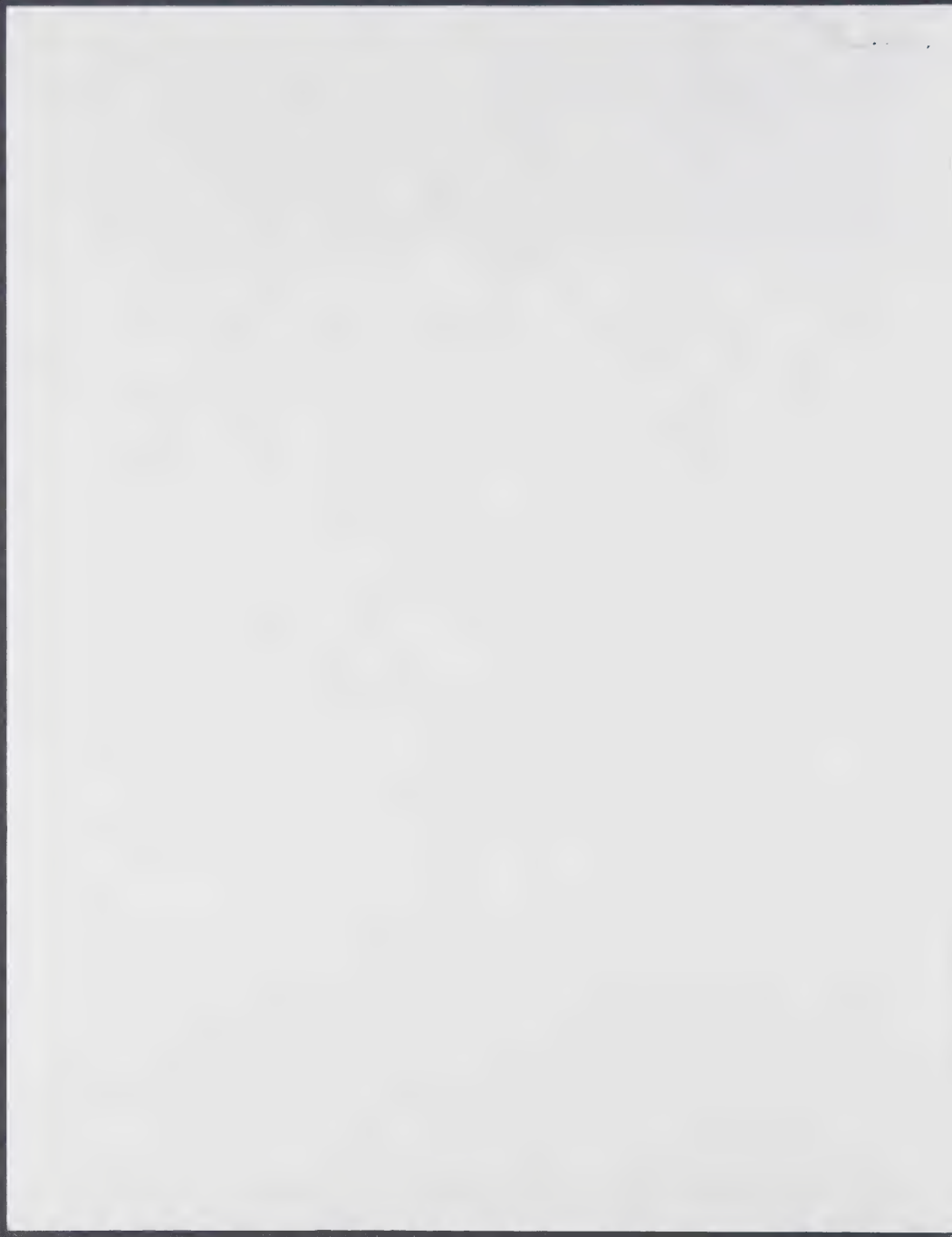
