



Dear Bronson,

I had hoped that the solvent of which you sent me a sample aight be some simple solvent that could be obtained easily. Actually, it is a mixture the likes of which I have not encountered before. It contains 5% concentrated sulfuric acid, a great many aliphatic and aromatic hydrocarbons and a surfactant to bring this mixture into one phase. It contains no ketones and no alcohols.

To duplicate this would take a good deal of work, and that, I am afraid, we just cannot do.

Danny and I plan to be in the San Francisco area, arriving on February 14 and leaving San Francisco on February 18. Of course we very much hope to see you.


