Just a hurried note to thank you for your letter of August 16th with those interesting nine estimates from Fischer.

Keep in mind that all the auction house do the same: They try to entice you with relatively high estimates, and when they have the painting, they often write and say that on closer examination, they find that the estimate of SF X,000 is somewhat too high and should be reduced.

The estimates for the 13 paintings do not strike me as unreasonable, but of course I don't know what your costs of most of the paintings were. Also, would Fischer pay for the transport, photography and insurance and not charge you any buy-back commission? The same question, of course, applies to the other auction houses.

Fischer's suggestion to take two still lives into their special exhibition is intriguing. How do their suggested prices compare with your cost?

Also keep in mind that these days often 50% of the lots of Old Masters do not sell, and the paintings are then exceedingly difficult to sell for several years.

I much look forward to chatting with you and then, of course, seeing you in Milwaukee.

Dear Bert:

I am sure that you understood that both of us were disturbed about the misunderstanding relating to the Everdingen.

The good news, which I learned from your phone call, was that you decided not to buy the painting. I love it and would not have offered it to anyone else.

The sad news was that you believed that I misled you. To do that would be both stupid and mean, and I certainly wouldn't do that to one of my best friends.

Let me explain: The painting came up at Christie's London as Lot 127 on Friday, July 10, 1992. The painting was very dirty, and the catalog did not state that it is listed and illustrated in Alice Davies' book on Everdingen. The catalog did state that a strip of one inch had been added at the top - and so it was, but that was almost certainly done by the artist himself.

The estimate in the catalog was very low, £4,000 to 6,000. I loved the painting and decided to go to £15,000 if needs be, but I didn't have to because I bought it for a total of £6,705, which translated to \$12,940.65. At that time, just two days after I had purchased the Rembrandt now in the Rijksmuseum, the pound was almost \$2.

My restorer, Charles Munch, cleaned the painting, and it proved to be in wonderful condition.

When the curator of the Metropolitan, Walter Leidtke, visited us in 1993, he told me that it was one of the most beautiful Everdingens he had ever seen. The art historian writing a book on Everdingen, Alice Davies, visited us specially to examine this painting, and she told me that if I ever thought of selling the painting, I should offer it to her - It is such a wonderful work.

What is such a painting worth? I don't know, but I suspect that when Alice Davies' book is published, with her comments about this painting, it would bring more than \$60,000 at auction.

Also, do keep in mind that I have very few landscapes and none by Everdingen.

I also recommended, before I left, that he should not let Erich Hammer visit any more customers, and that, where Erich has to go, he should accompany him. Also, that he should be copied on all relevant correspondance, and should follow up personally. Clearly, it is no longer my responsibility, although Mike will listen to me carefully when I bring something to his attention.

At the end of the year I could not arouse any interest in Dr. Michaelis' letter with regard to 'Stop Chemophobia'. I am returning it, along with the journal that you gave me, by separate mail. If it would not have been the holiday season at the end of the year, I don't think my efforts would have stimulated a different response. Johnson & Johnson don't see themselves as a chemical company - and of course they aren't.

We started the year quietly together with Lieve and Erik, and snow and wind. Friday we are off for about ten days to Belgium and Holland. We did not want to miss the exhibitions in Dordrecht, Rotterdam and Den haag.


It is such a good portrait that I asked him to take his time and do the work very carefully, and we would pick up the painting when we visit him in mid-February.




