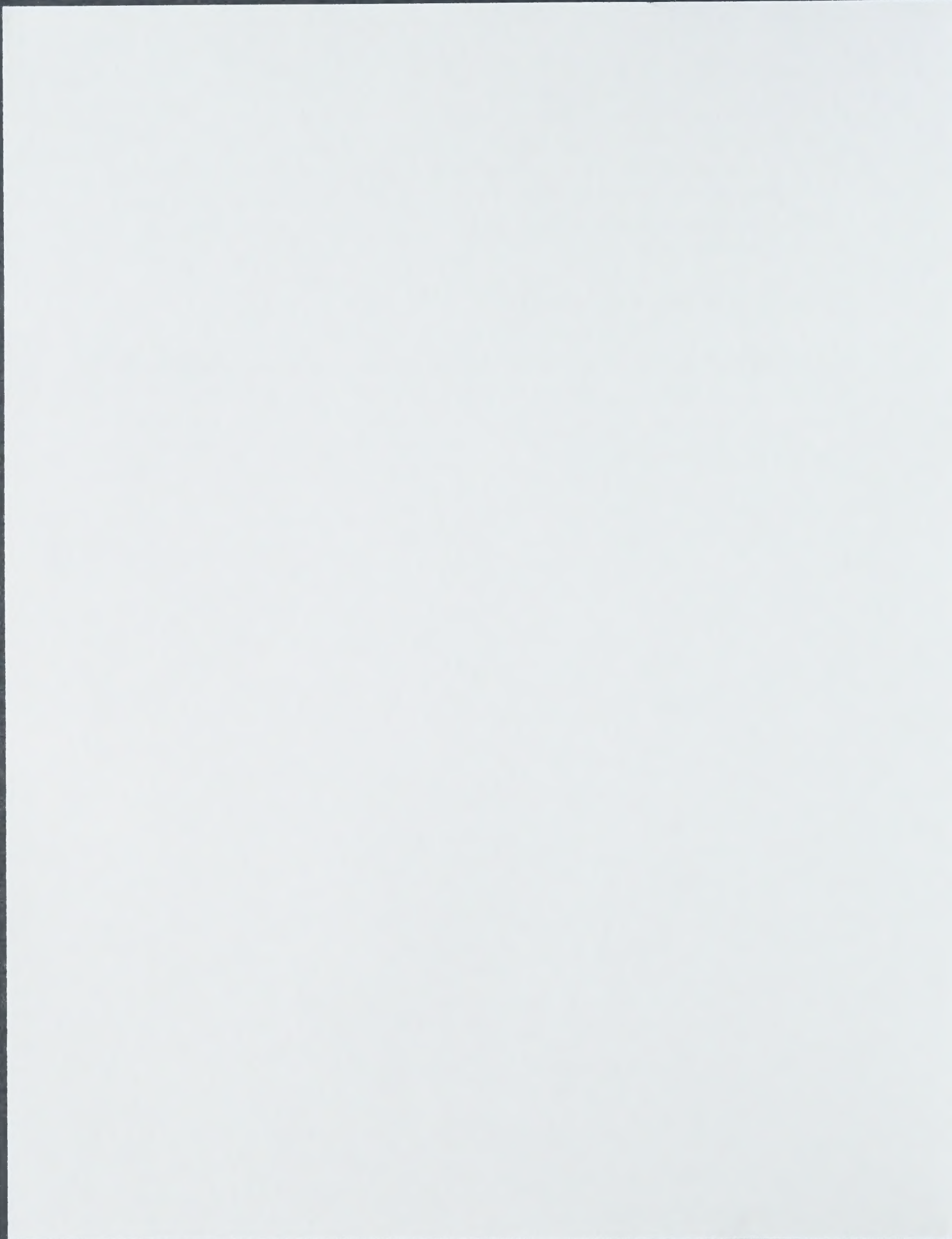



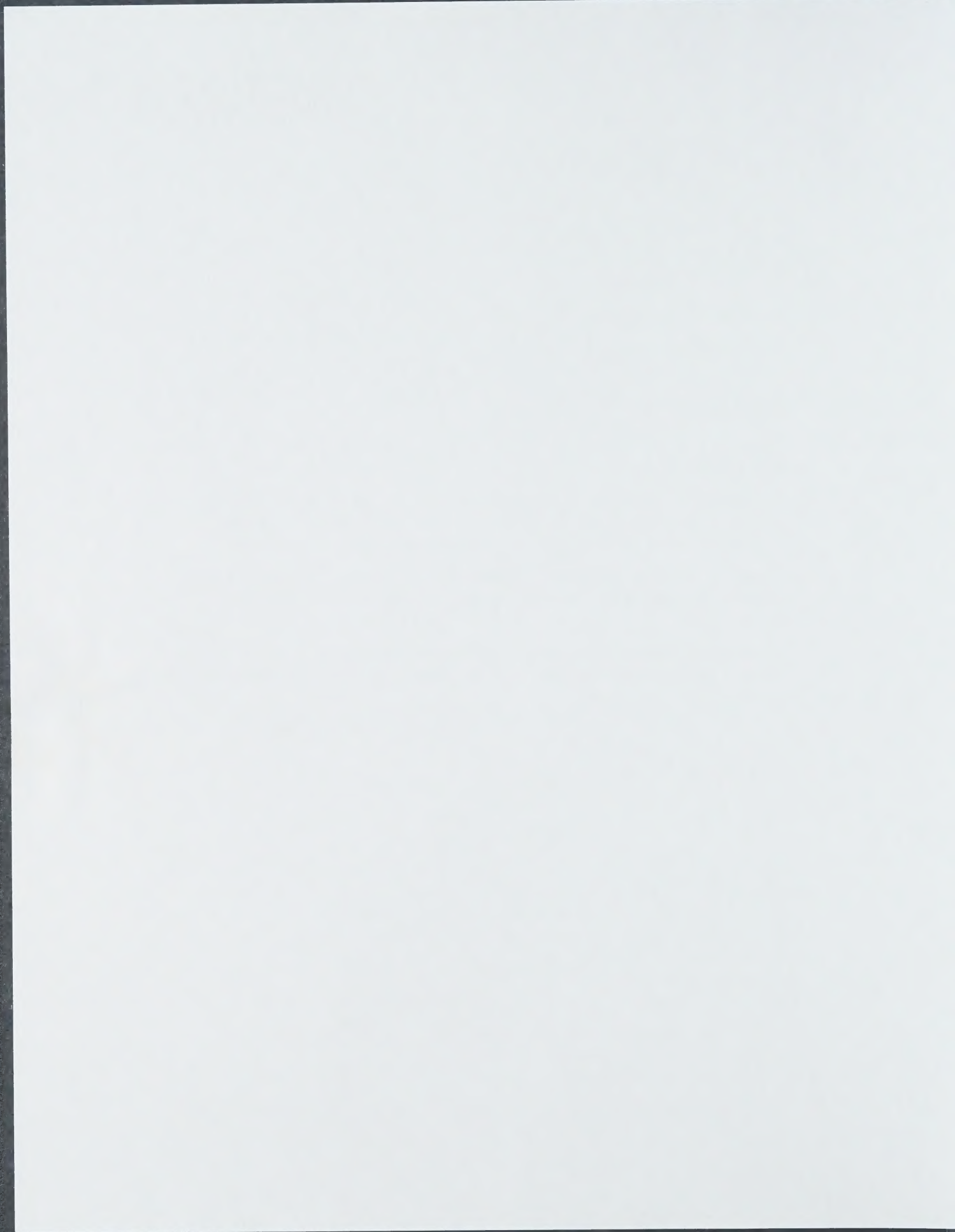
Thank you very much indeed for your most generous donation. The cheque has not yet arrived but the mere thought that it is on its way will make fasting that little bit easier !!!!

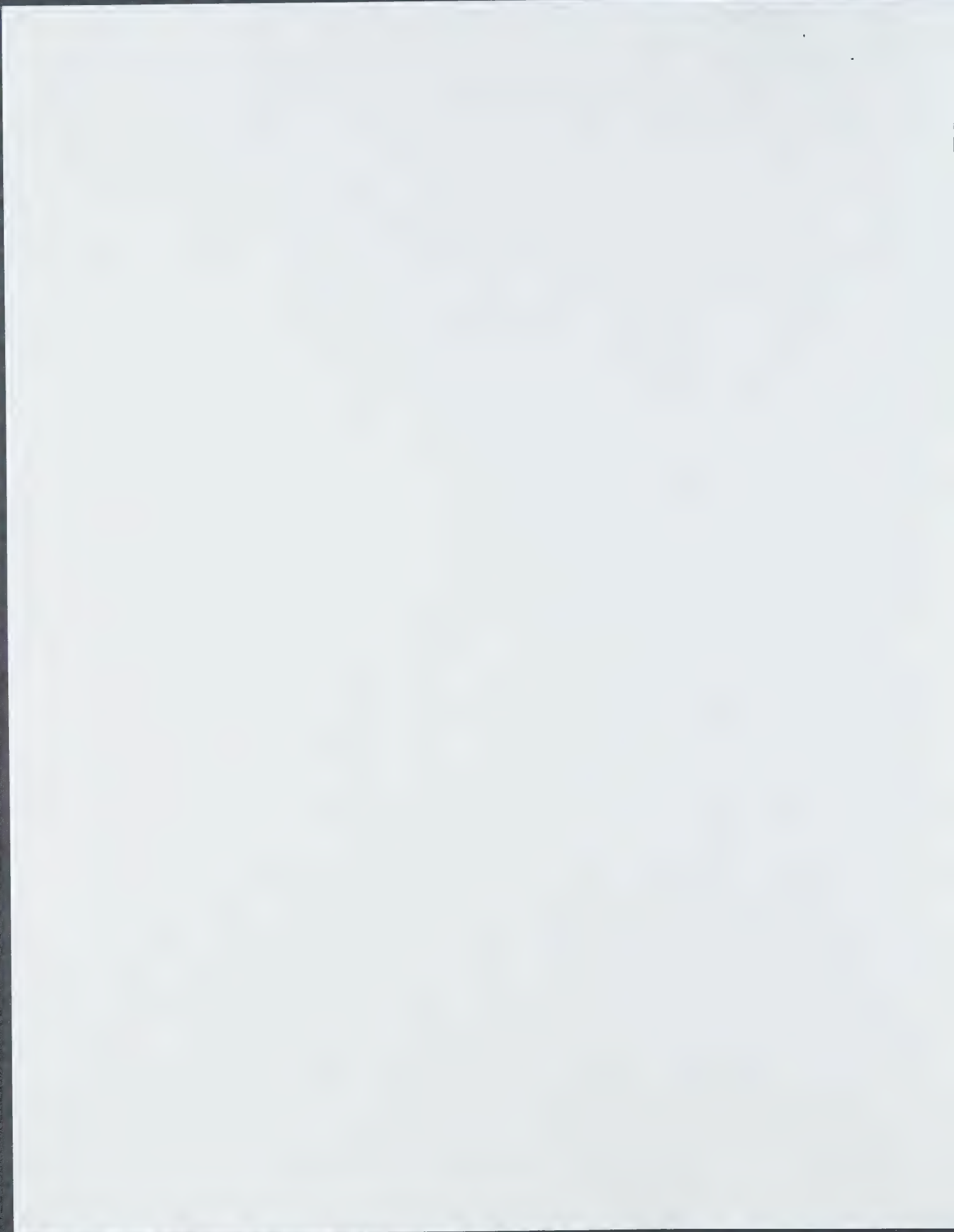
Mary Smith (invited you to dinner) from Queen's will call you at home tonight.

I will alert Christopher Apostle and Marina Phelan (who is there more regularly than Christopher) to the circumstances.

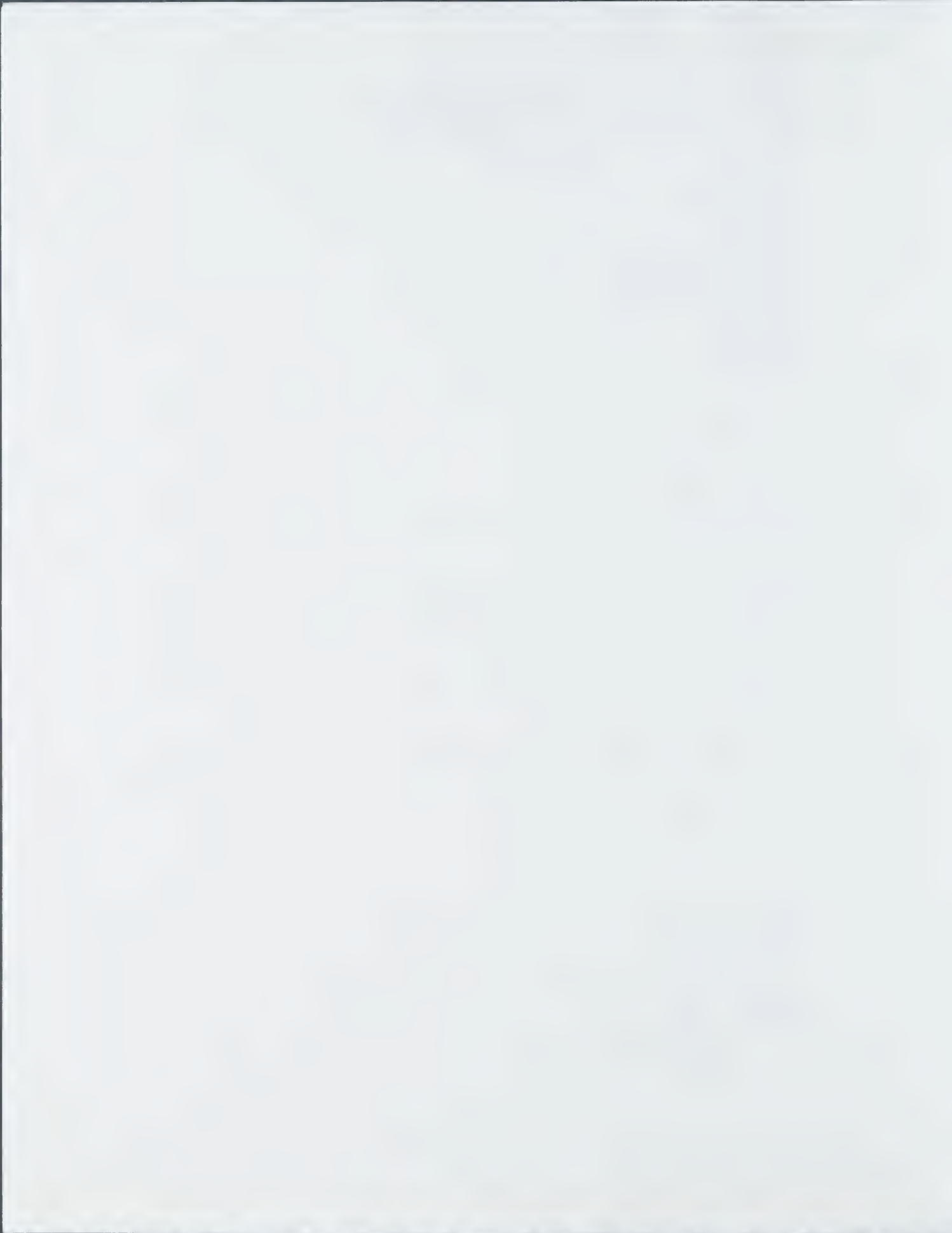

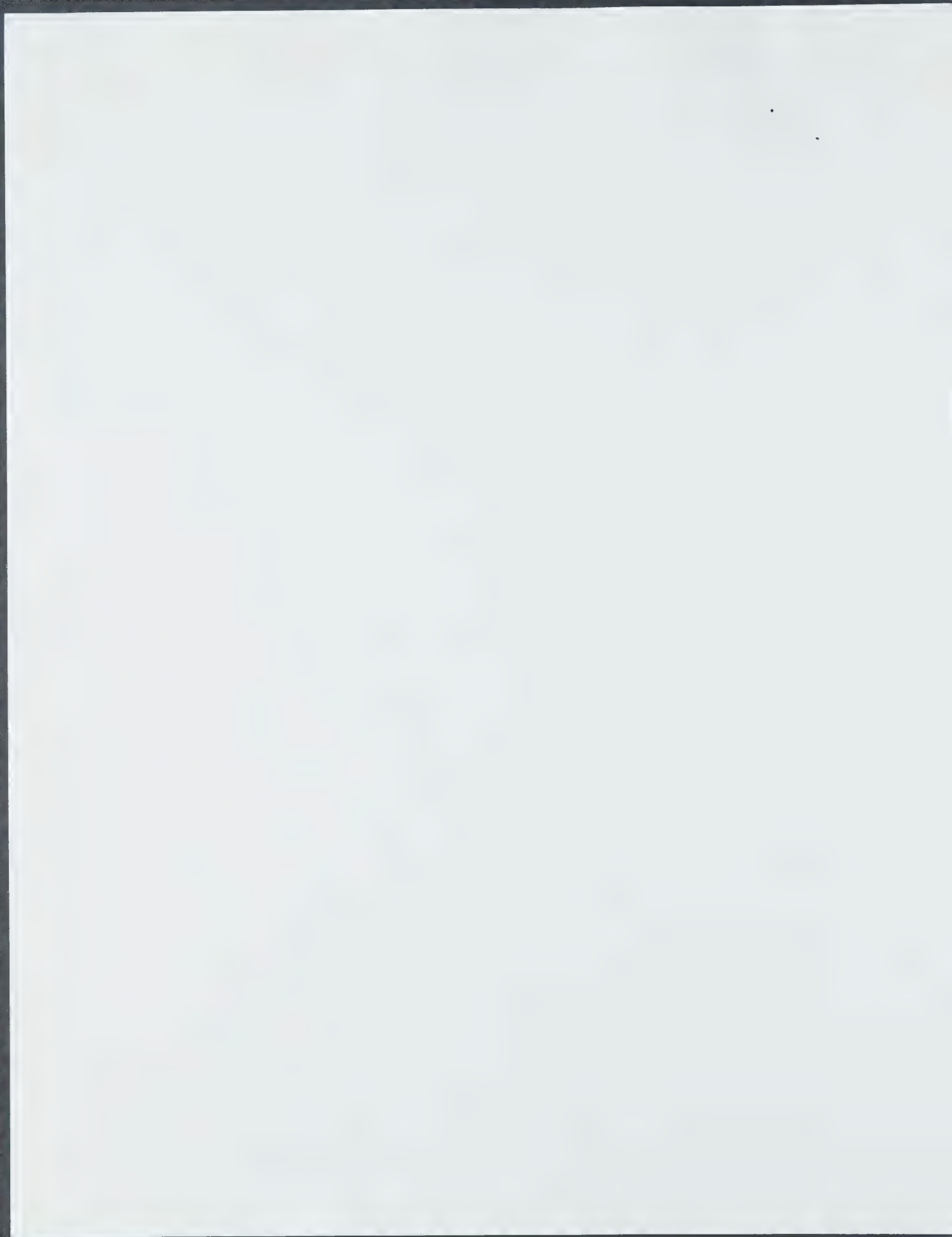
In response to your fax of last Friday, we will not be able to be with you on November 30<sup>th</sup> because I have been invited to give several talks in Scotland that week.

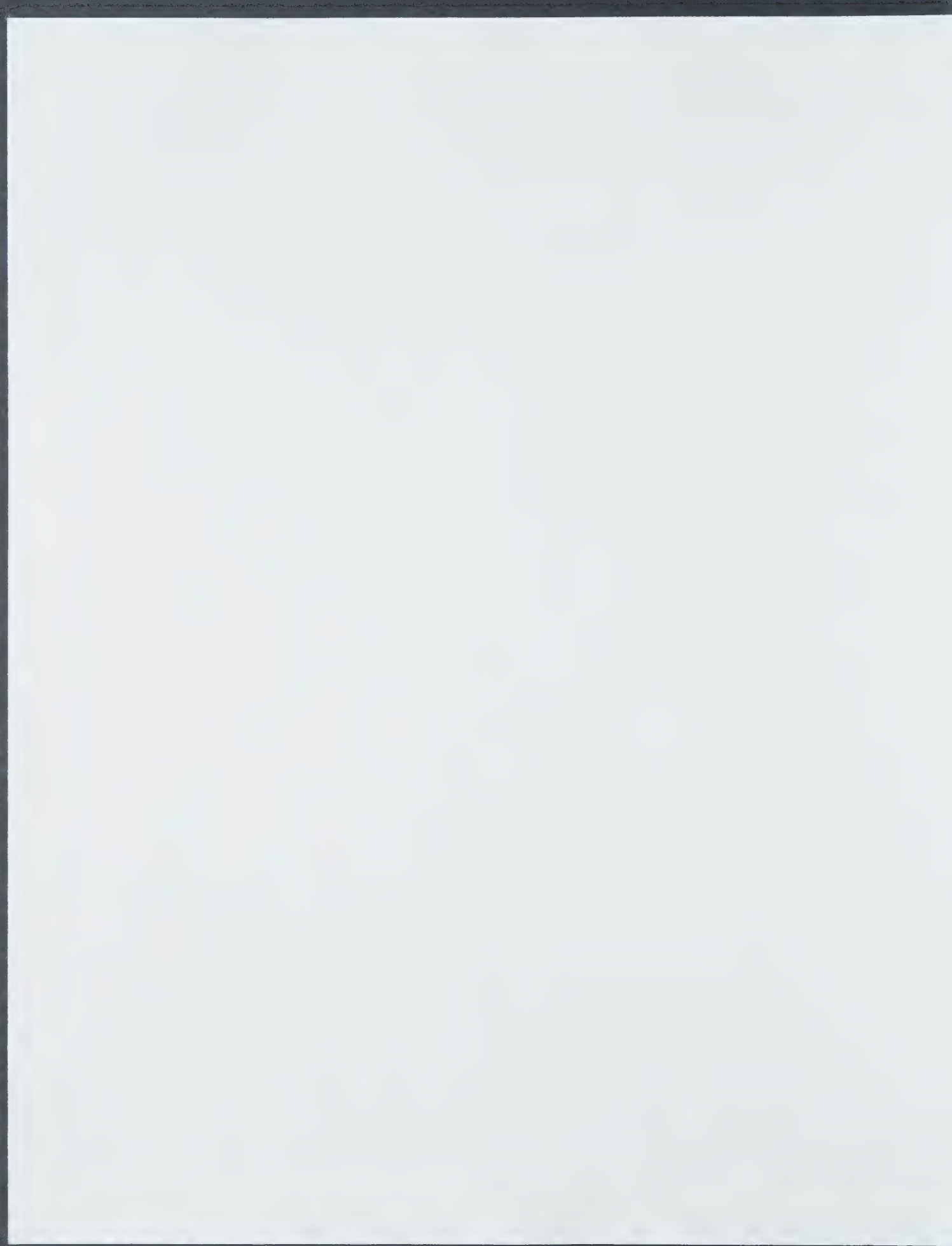
Dear Arnold,

Dr. Robert Tauber has been one of my best friend in Vienna for many years, and I look forward to seeing him during our visits to Vienna every June.


May I just correct one statement in your letter? My intention is that this money be used to help Roma and Sinti and not for other refugees.

Please don't misunderstand me: I am not against helping other refugees, but I feel that the gypsies have been treated so badly all over Europe that we would like to help them particularly.

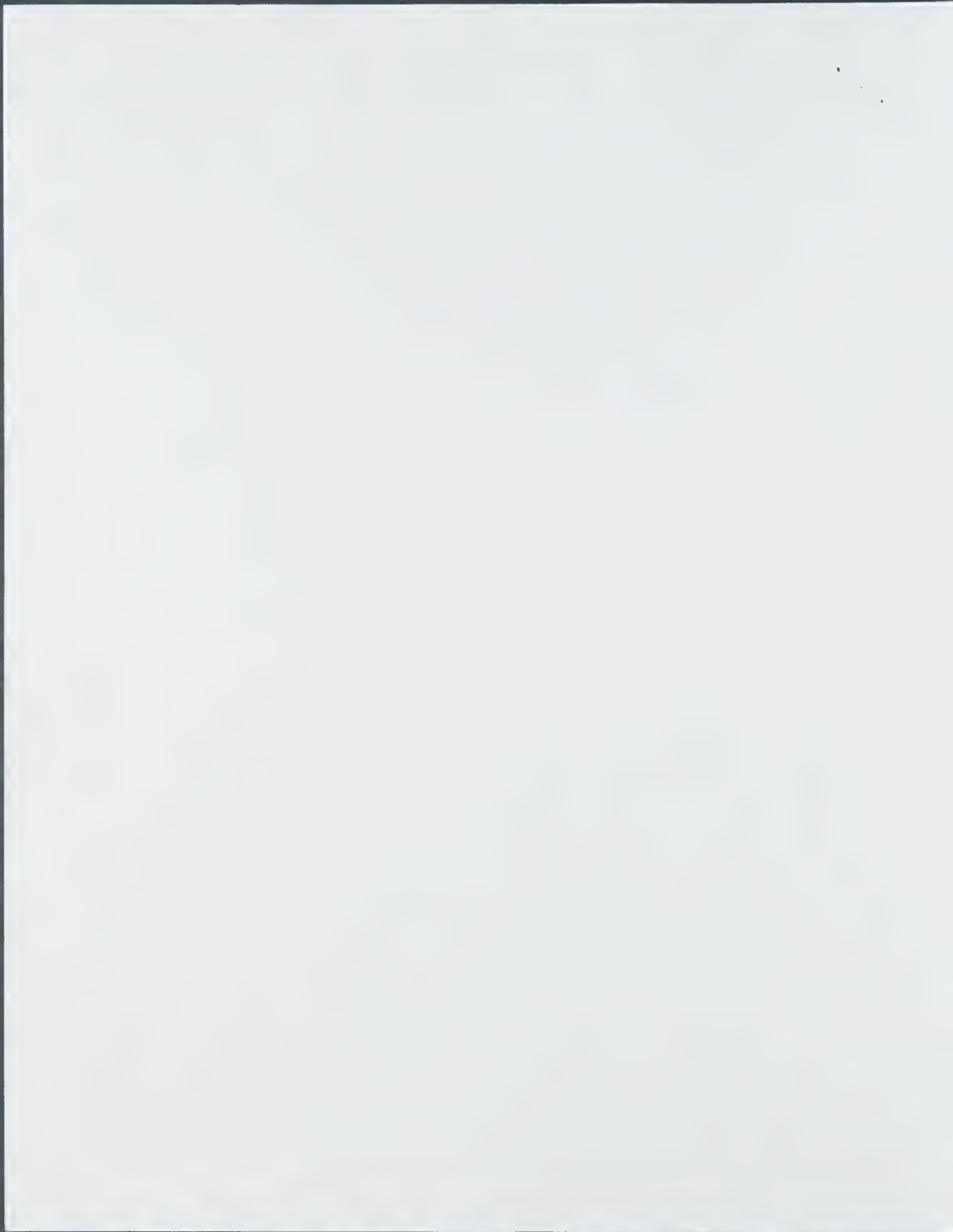

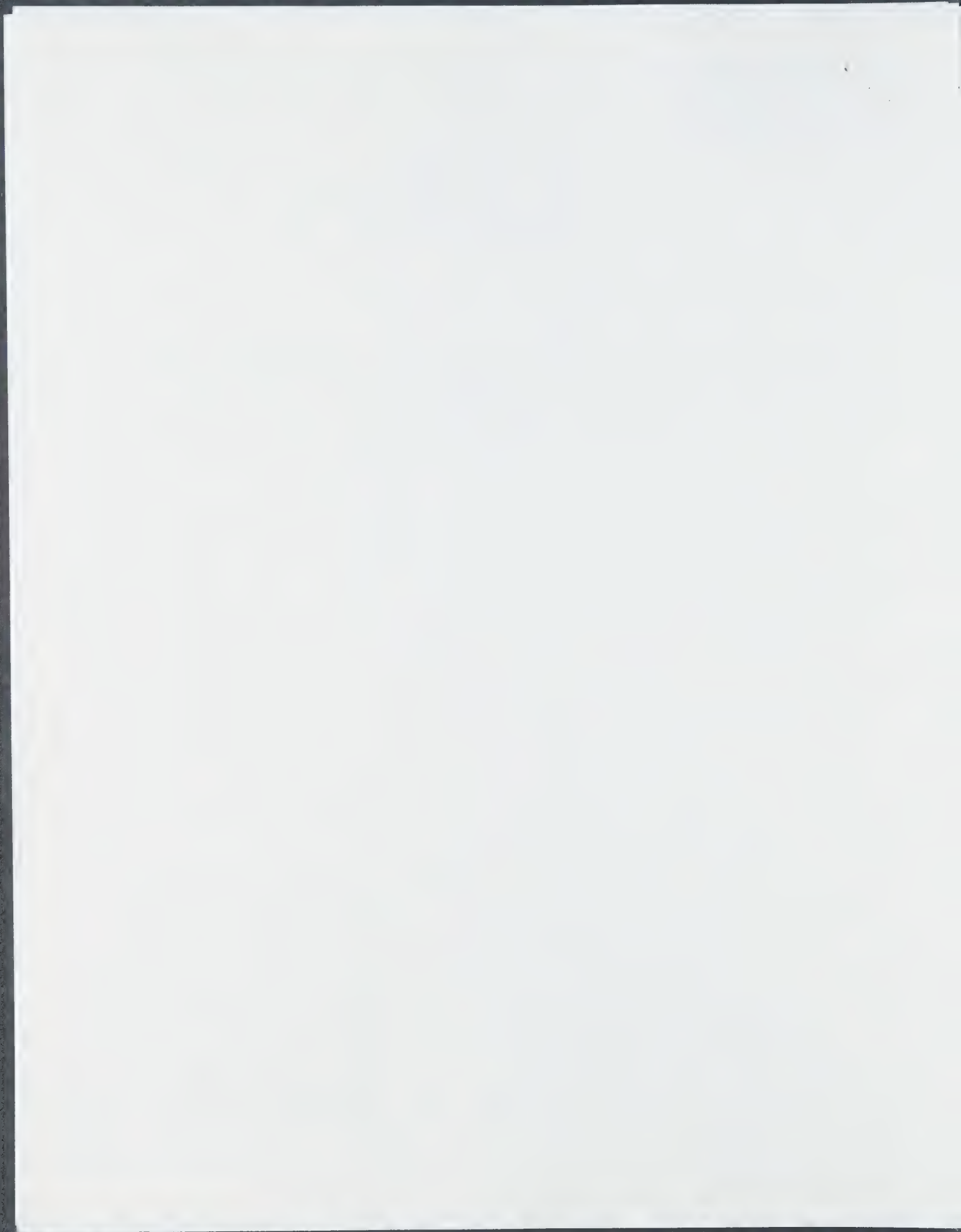

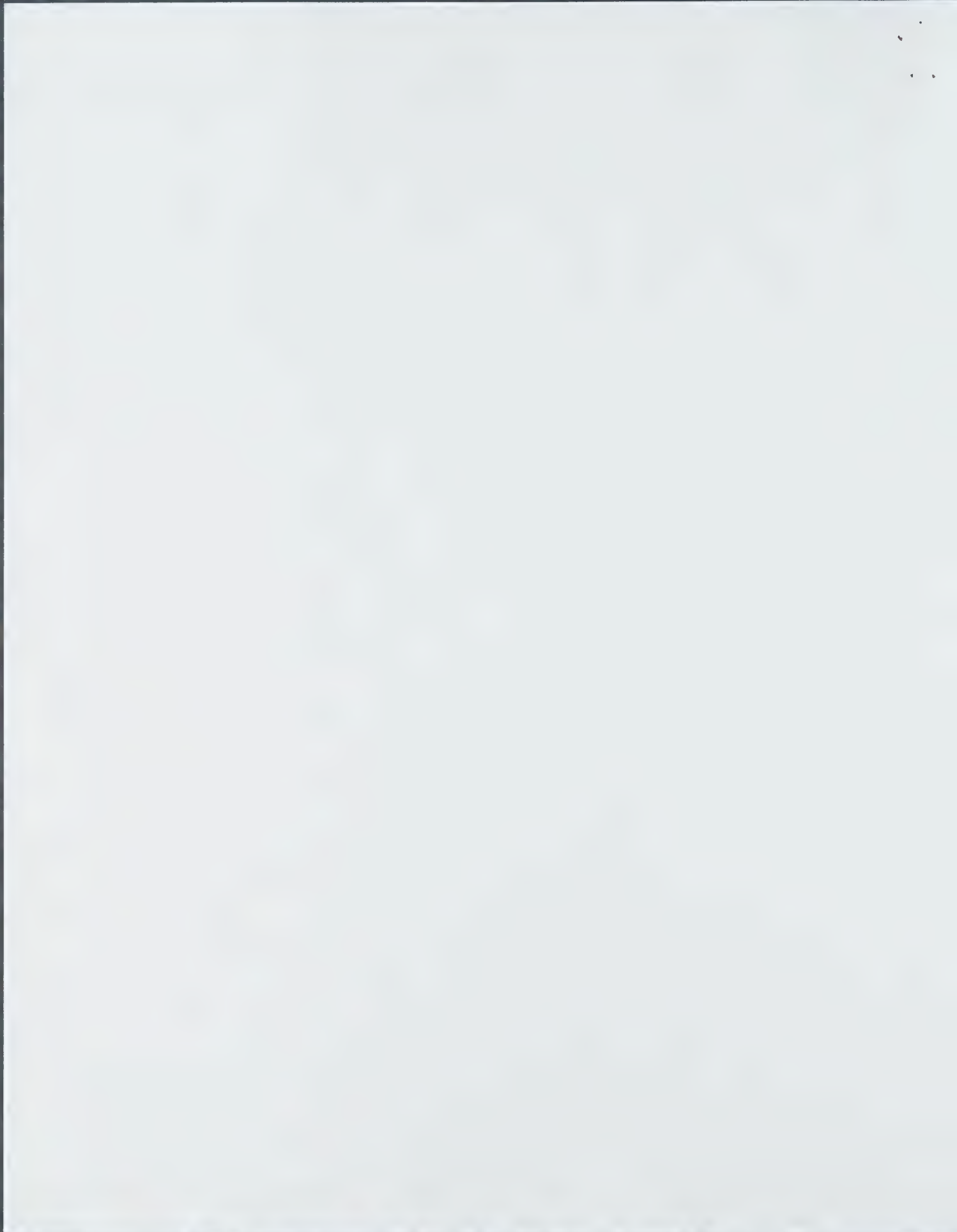
I know from past experience that you keep excellent records of customers buying your travellers' checks, and so you can easily determine that I buy your checks, usually \$5,000 at a time in \$100 checks and then cash these over a period of two or three years. I am sure that you have many customers like me and that this is very good business for you because my money is with you at no interest.

This has always been fine because whenever I have gone into any of your offices worldwide, I have always received a good rate of exchange and there was no service charge.

However, I must tell you that on June 19th I found the first exception to this.

At your office in Vienna, I received a rate of exchange of AS 11.82 per dollar when I could have walked in any Viennese bank and gotten more than AS 12 per dollar for \$100 bills. When I remonstrated with the teller, she told me bluntly that that was their rate of exchange and that was it.

A few days later, I walked into your office in Prague, and there - as always before, all over Europe - I received a rate of exchange somewhat better than given by local banks.

## DISILLUSION and DISINTEGRATION

"Distress makes even wise men unstable, unreasonable, credulous, eager for immediate relief, heedless of remote consequences."

Lord Macaulay

This is not a photograph of an elderly Jew being beaten by young hooligans in some Russian town; it is not taken from the archives of a Holocaust Museum, a reminder of what happened in Nazi Germany; it is not an incident that occurred in Crown Heights, New York. It is a picture taken this month in Jerusalem, showing an elderly Jew being attacked by Arab youths on his way to prayer at the Western Wall.

What meaning is there today in the Israeli national Anthem, which declares:

"As long as deep in the heart

"The soul of a Jew yearns,

"And towards the East

"An eye looks to Zion.



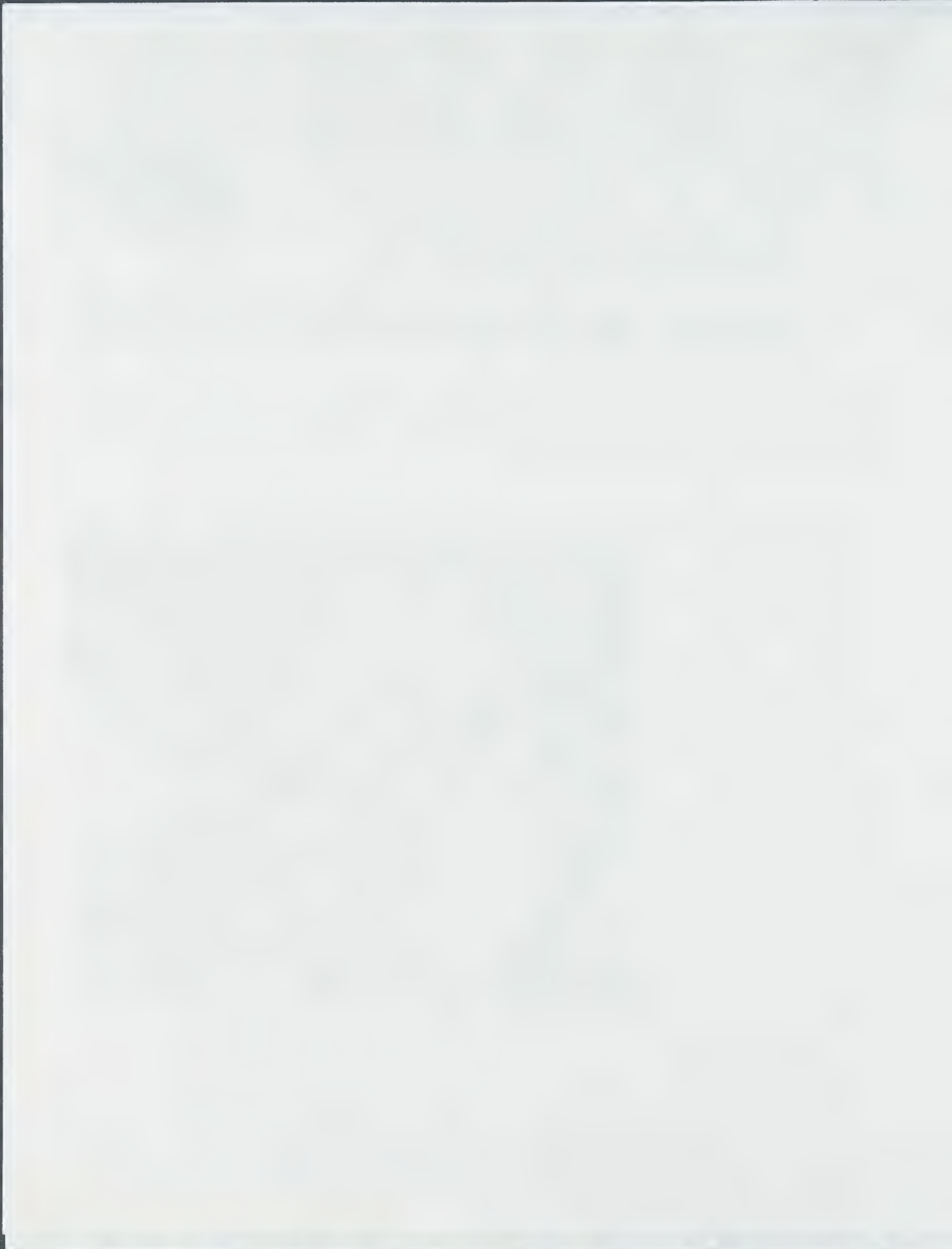
"Our hope is not yet lost

"The hope of two thousand years

"To be a free people in our land

"The land of Zion and Jerusalem."

If the incident had happened anywhere else, there would have been an outcry of protest at such a brutal display of racism and anti-Semitism (but not, I think, from the present Israeli government, which has come to regard attacks on Jews anywhere as a matter of routine.)

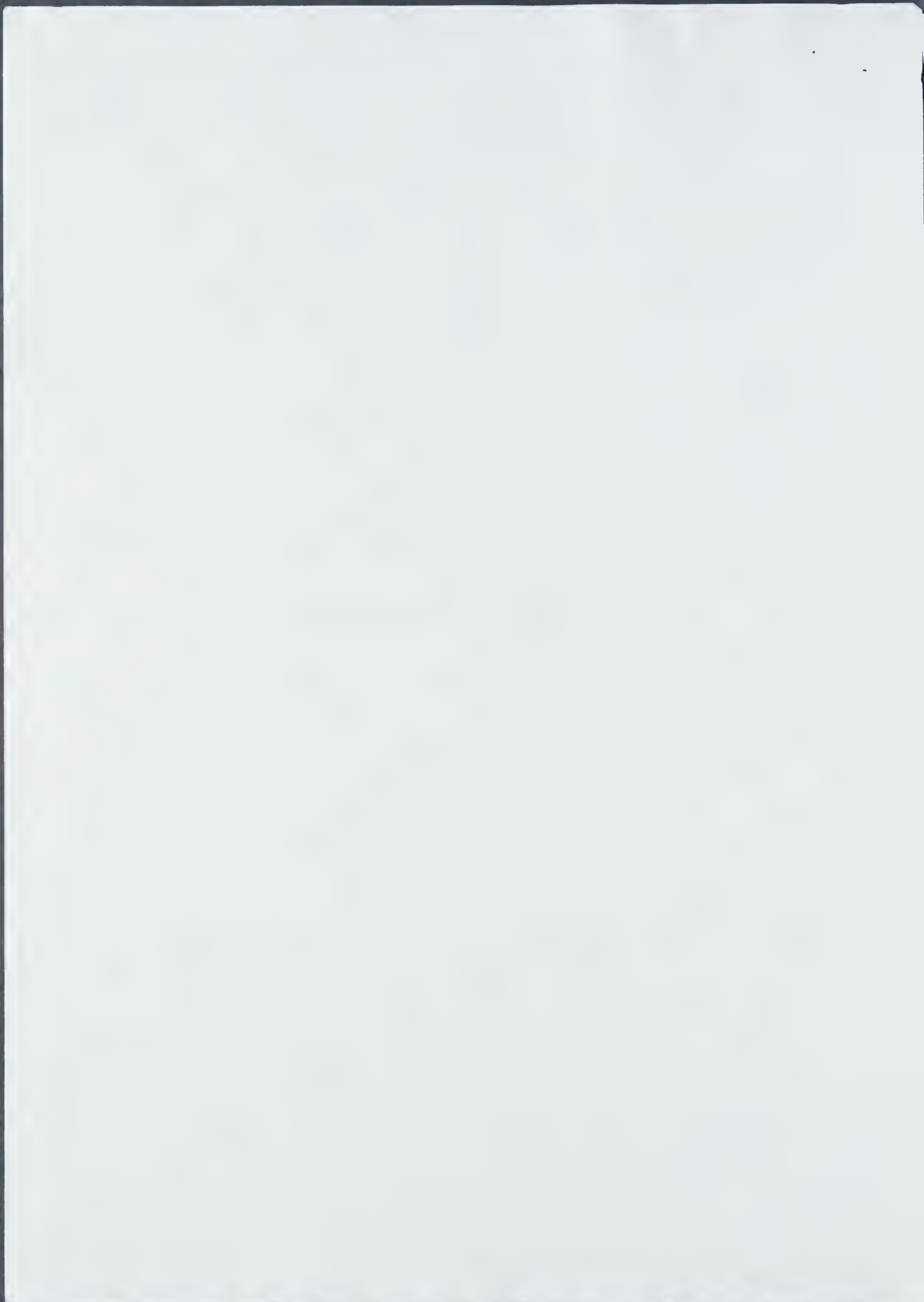
In our case, the U.S. Ambassador to Ghana introduced us to the Congressman who kindly took time to discuss some aspects of our project with us.

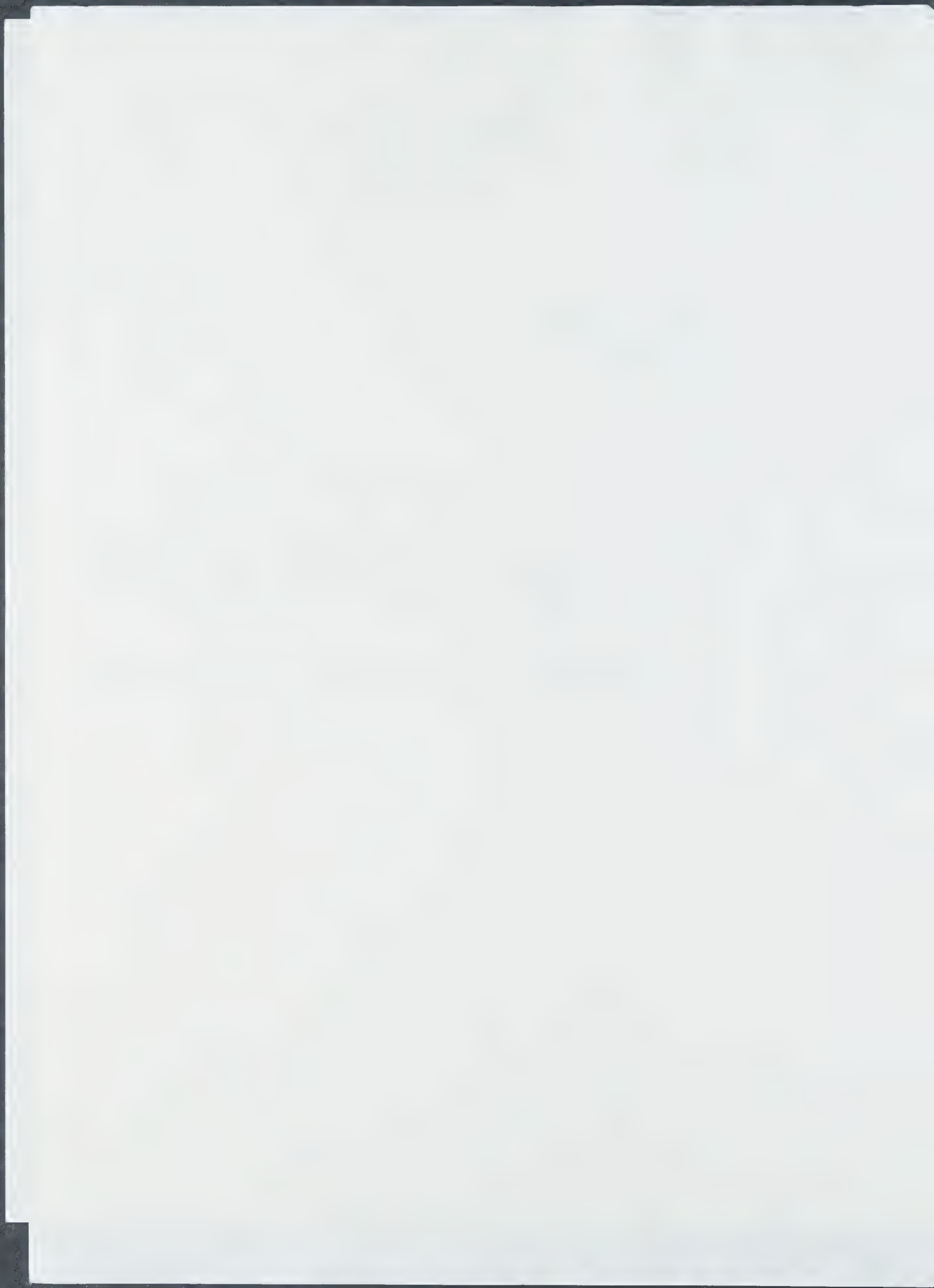
Thank you for your thoughtful and thought-provoking letter of August 25th.



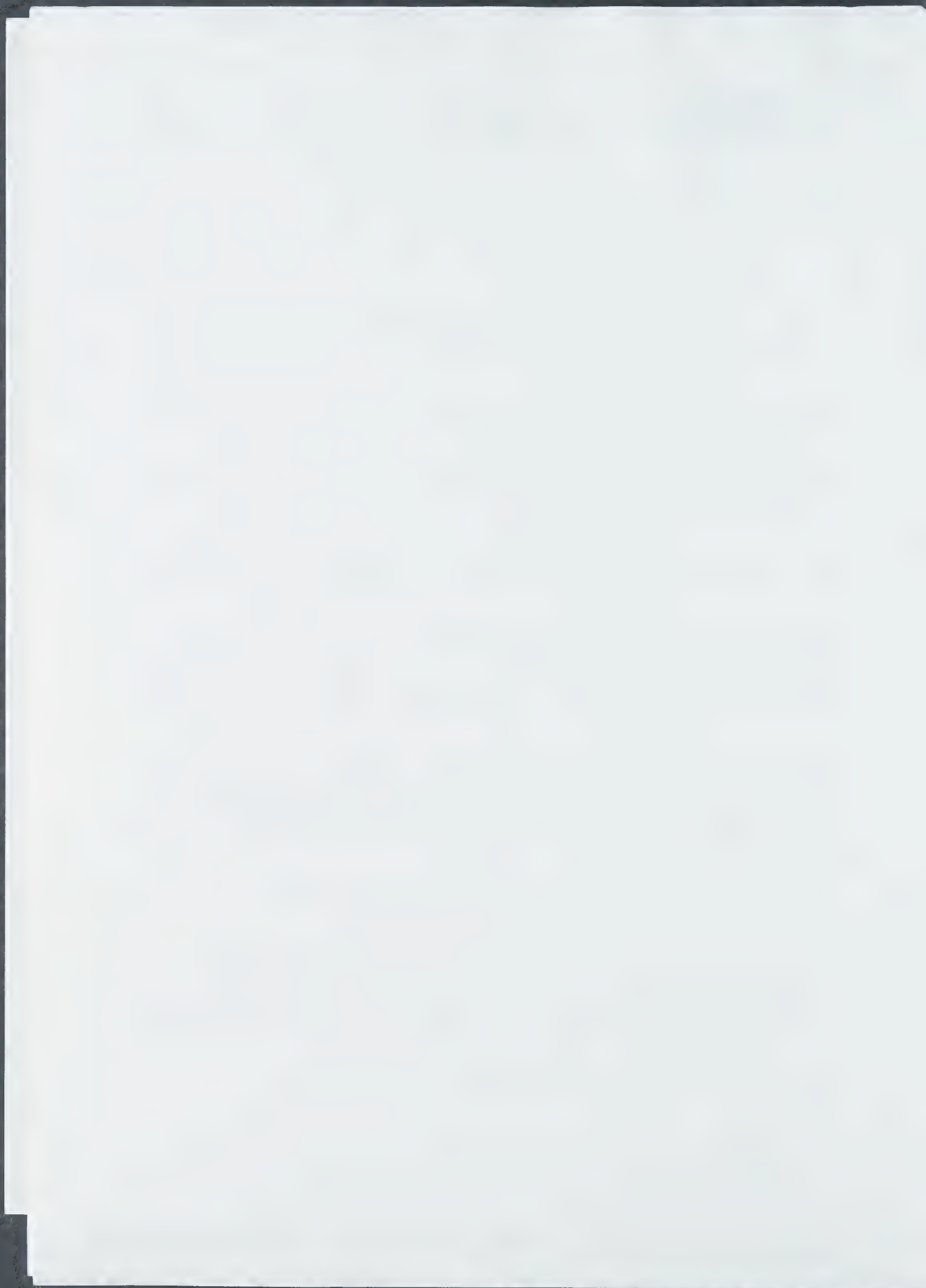

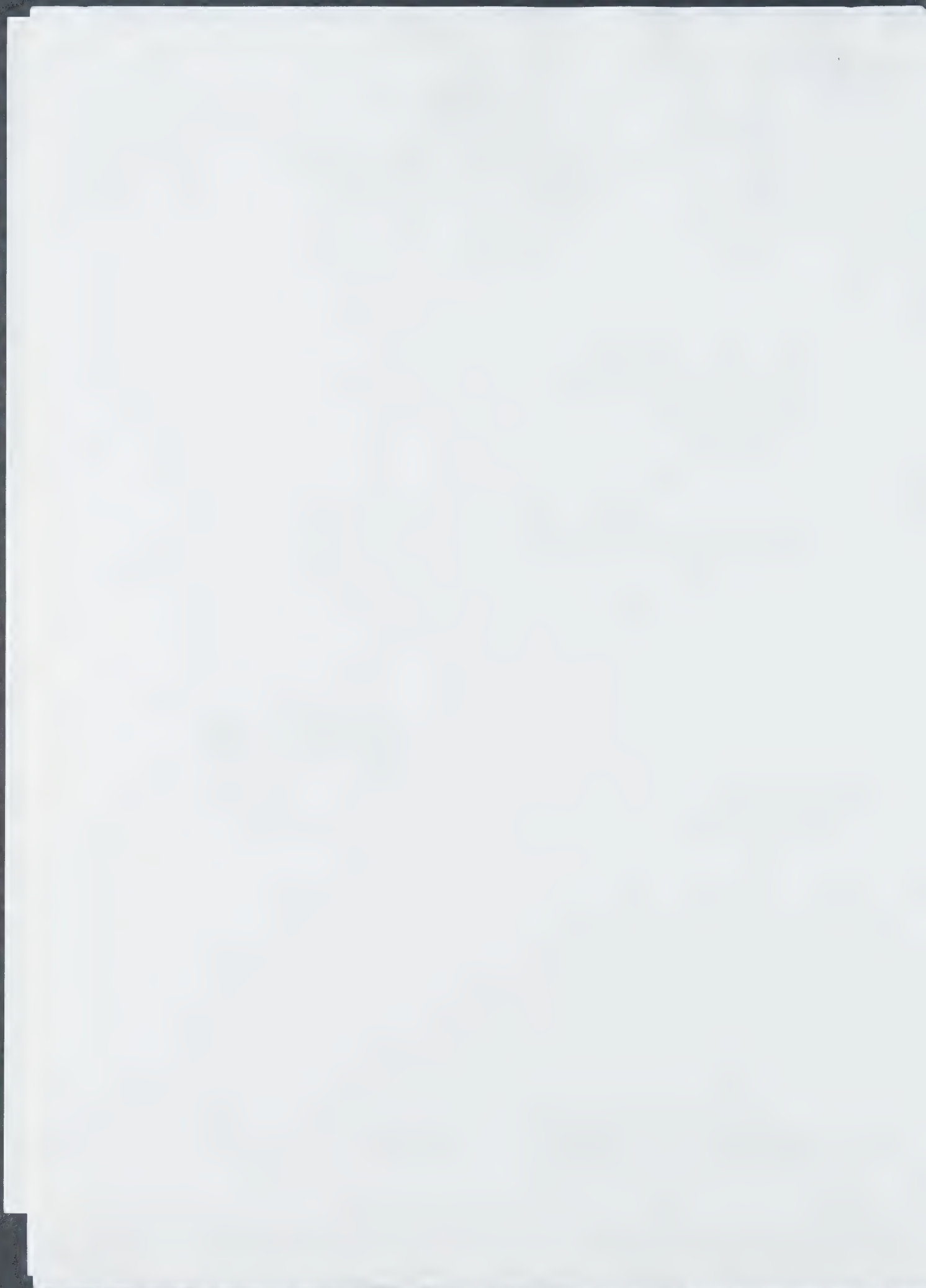

Dear Congressman Houghton,

Thank you for your letter of Aug 1, 1994. I am so glad you were able to write. We greatly appreciate your efforts and kind support.

Mr Miles' letter is still helpful because it defines Philip Morris' business interests and clearly shows that the company's strategic plans do not include food businesses in Ghana.

This and similar disclosures from other multinational companies steer us towards other financing sources. Unfortunately, local financing is very limited and highly biased in favor of large mining companies.


Fortunately for us, a five thousand dollar (\$5,000) or more loan or grant may be enough to supplement our own financial and technical efforts and demonstrate significant social and economic benefits.

So, if possible, we would appreciate the opportunity to initiate individual and/or community based fund raising drive, through your office or church, on behalf of our project in Ghana.

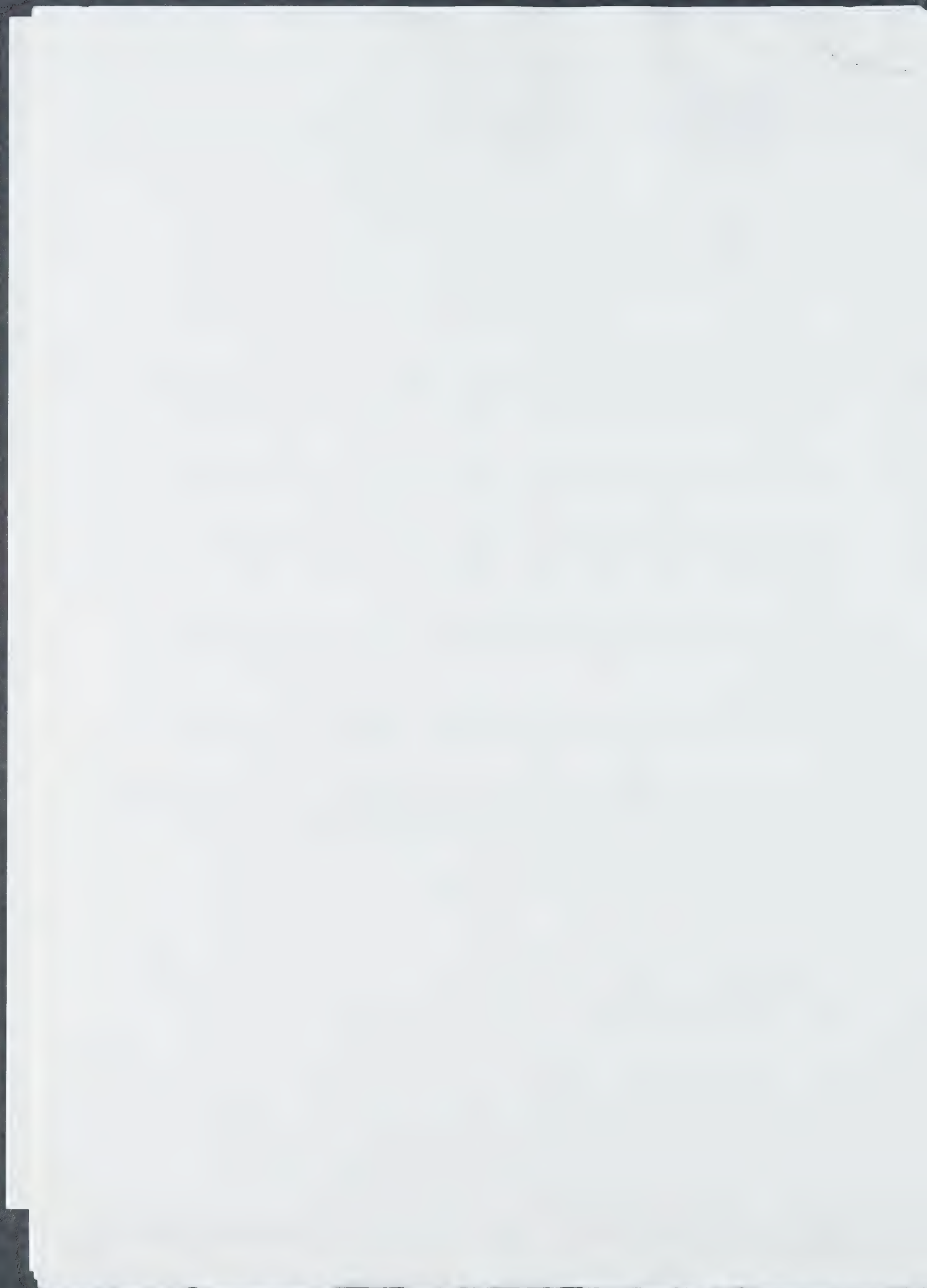
