Dear Dr. Bader:

You have indicated to me that you wish to change the persons who may make recommendations to JDC with respect to distributions from The Alfred and Isabel Bader Philanthropic Fund (the "Fund"). As currently drafted, the Trustees of The Alfred Bader and Isabel Bader Foundation may make these recommendations upon your and Isabel's demise.

It is now your desire that Yechiel Bar-Chaim be the person authorized to make recommendations upon your demise. Accordingly, paragraph 3 of the letter dated December 26, 2001 establishing the Fund shall be revised to read as follows:

"3. Distributions from the Fund of principal and/or income shall be made at such time or times and in such amount or amounts as may be determined solely by the JDC, to such organizations of the type described in paragraph 2 as may be designated by the JDC (including JDC and its affiliates); provided, however that Alfred Bader and upon his demise, Yechiel Bar-Chaim may from time to time submit to the JDC the names of organizations to which it is recommended by him that distributions be made, which organizations shall not be other than those described in paragraph 2. Such recommendations shall be solely advisory, and the JDC may accept or reject them, applying reasonable standards and guidelines with regard thereto. In no event may JDC honor a recommendation where such donation would be inconsistent with JDC's charitable mission."

The JDC receives its funds primarily from American Jewry through the Jewish Federations of the United States and the United Jewish Communities. JDC also receives funding from World Jewish Relief of Great Britain and UIA Federations Canada.



Re: The Alfred and Isabel Bader Philanthropic Fund

A fund shall be established in the JDC which shall be known as the Alfred and Isabel Bader Philanthropic Fund ("the Fund"). The American Jewish Joint Distribution Committee (JDC) may receive additional irrevocable gifts from time to time from the undersigned and from any other source to be added to the Fund, all subject to the provisions hereof.

1. The JDC shall have all powers necessary or in its sole discretion desirable to carry out the purposes of the Fund, including, but not limited to, the power to retain, invest, and reinvest the Fund in any manner it may see fit, without being subject to any investment restrictions, statutory or judicial, which would otherwise be applicable to it as a fiduciary, and the power to commingle the assets of the Fund with those of other funds for investment purposes. No person dealing with the JDC shall be required to inquire into its authority to act.

2. The principal and income of the Fund shall be distributed only to organizations of the type to which an individual taxpayer may make deductible charitable contributions, gifts and bequests under the income or gift and estate tax provisions of the Internal Revenue Code of 1986, described in section 501 (c) (3).

3. Distributions from the Fund of principal and/or income shall be made at such time or times and in such amount or amounts as may be determined solely by the JDC, to such organizations of the type described in paragraph 3 as may be designated by the JDC (including JDC and its affiliates); provided, however, that Alfred Bader and Isabel Bader and upon their demise, the Trustees of the Isabel and Alfred Bader Foundation may from time to time submit to the JDC the names of organizations to which it is

.mended by them that distributions be made, which organizations shall not be other than se described in paragraph 3. Such recommendations shall be solely advisory, and the JDC may accept or reject them, applying reasonable standards and guidelines with regard thereto. In no event may JDC honor a recommendation where such donation would be inconsistent with JDC's charitable mission.

4. It is recognized that the JDC in the administration of the Fund and in making distributions from the Fund will do all things that it deems necessary to comply with the Internal Revenue Code and regulations issued thereunder in order to maintain its status as a "public charity" and the status of this Fund as a "Donor-Advised Fund" and that by doing so it be required from time to time, to take action which varies from the terms and conditions hereof.

5. Neither the donor, Alfred Bader or Isabel Bader, or any other person may receive any tangible benefit or privilege in return for a distribution of the Fund. It is understood that no distributions will be used to discharge or satisfy a legally enforceable pledge or obligation of any person, including the donor or his family.

6. It is intended that the Fund shall be a component part of the MDC and not a separate trust, and that nothing in this Agreement shall affect the status of the JDC as an organization described in Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, and as an organization which is not a private foundation within the meaning of Section 509 (a) of the Code. This Agreement shall be interpreted to conform to the requirements of the foregoing provisions of the federal tax laws and any regulations issued pursuant thereto. The JDC is authorized to amend this Agreement to conform to the provisions of any applicable law or government regulation in order to carry out the purposes of this Fund. References herein to provisions of the Internal Revenue Code of 1986, as amended, shall be deemed references to the corresponding provisions of any future Internal Revenue Code.

In this appendix I would like to share with you some information about our most recent initiatives to respond to desperate needs arising from the wars in the former Yugoslavia. Most probably I will use the funds you donated to JDC to support my work for one or more of them.

First, let me share with you information about the initial success of the JDC's Roma Scholarization Project we began in Skopje. There are now 174 Roma youngsters (including refugee children from Kosovo) from the very poorest neighborhood of Skopje who were not previously in school and who are now enrolled in a special, intensive catch-up program. If they pass their exams in June they will become regular pupils in the fall.

With support from UKJAID and the founders of La Benevolencija-Skopje, I am now trying to expand the program to assist the Kosovar Roma refugees who are still in the camps. Please see attached.

A second event of note: Today we launch our first Entrepreneurship Training Courses in Belgrade. The courses, led by the same Israeli team that was so effective in Sarajevo, are for both Jews and Gentiles. Although loan capital is virtually absent in today's Yugoslavia and a pall of passivity hangs over much of the population, this initiative is stirring hope. A brand new and surprisingly enthusiastic Business Club has sprung up in the Jewish Community and they are co-sponsoring the program.

Together with World Jewish Relief and in cooperation with local partners we have also established in the Yugoslav cities of Belgrade, Novi Sad, and Subotice soup kitchens serving 800-900 meals a day to Jews and non-Jews. For your information, I enclose the descriptive material I am using to solicit funds. Here too we are finding that lighting candles is almost as contagious as cursing the darkness.

GOALS

To enable up to 200 Roma children, many of them refugees from Kosovo, who live in the downtrodden neighborhood of Skopje called Sutu Orizeri and who were not attending school, to study for six months in a special catch-up school program.

Successful completion of the program will allow these youngsters to become regular pupils in the 2000/2001 school year.

ACTIVITIES

During the summer of 1999, the International Rescue Committee (IRC), with substantial financial assistance (\$250,000) from JDC, established a Community Health Clinic in the poor Skopje neighborhood of Chair. As the number of Kosovar Albanian refugees living in Chair diminished and Kosovar Roma refugees entered the nearby neighborhood of Sutu Orizeri, the Clinic Outreach Team surveyed the needs of these families. They discovered that a sizable number of children, aged 7-15, do not attend school.

Once this need was identified, JDC responded immediately with the support of UKJAID by exploring --- through the efforts of IRC's supervisor Dr. Camilo Valderrama and La Benevolencija --Skopje's Goran Sadikario --- the possibility of having these children and others like them study at the Brothers Ramiz Elementary School (where La Benevolencija had previously donated shoes and classroom equipment in a separate project).

An agreement was reached with the School and the Municipality of Skopje. The Outreach Team discovered additional potential pupils and other children from the very poorest families in the area came forward on their own volunteering to begin their schooling. Since January 2000, 174 pupils are now studying part-time at the Braca Ramiz School the basic subjects they need in order to be able to join regular classes next year: Math; Science; History and Geography; and Language (Macedonian).

Eight teachers and a Supervisor are paid modest salaries to implement the program. Fifty chairs and twenty-five additional classroom tables have also been purchased to permit the school to accommodate these new pupils. All the pupils participating in this project receive special school kits, basic clothing, and a pair of shoes so that their abject poverty does not prevent them from receiving an education.

THE ROMA REFUGEES OF DAREBOMBO

About ten days ago I visited this camp (termed in international humanitarian parlance a "collection center"). Several hundred Albanian-speaking Roma refugees from Kosovo inhabit barrack-like structures in this Darebombo Camp high in the snow-covered mountains above Skopje. (The temperature sunk to -11 degrees Fahrenheit that night in Skopje, so you can imagine the weather conditions at Darebombo).

These refugees are among the most miserable people in Europe today. They cannot go back home to face the anger of the Kosovar Albanians. They cannot be assimilated into Macedonian Albanian society (relations between Roma and Albanians are extremely tense). Not knowing the Macedonian language, they have also no place in Slavic Macedonian society.

Largely uneducated, the women I saw at the camp learning about the menstrual cycle from IRC instructors have obviously suffered physically from births that came too early and too often. Fifteen is a normal age for marriage, and allegedly there is no saying "I have a headache tonight, honey." In response to our questions, the women first said they enjoyed coming to the class to get away from their husbands for a little bit and only then added that it was after all fairly interesting to learn something about their own bodies.

Meanwhile their official status as refugees has temporarily been extended through March, putting off temporarily an eventual confrontation on their status between Macedonia and the international community. The Macedonians want them out, and no one is prepared to take them. Well cared for medically by IRC, the Roma refugees in Darebombo wait idly, hoping against hope that some prosperous third country will accept them.

SOUP KITCHENS IN YUGOSLAVIA

I have just returned from Yugoslavia where, with the help of World Jewish Relief, we have set up soup kitchens in the Jewish Communities of Belgrade, Novi Sad, and Subotice.

The soup kitchens are one response to the appalling economic conditions now afflicting the citizens of that country and the hundreds of thousands of refugees living there after nine years of successive wars and sanctions.

- Average salaries are said to be about £25 a month. Teachers, for example, earn 5% of what they received a decade ago.
- Pensions, when they are paid, are £20 per month. Last year instead of pension checks Yugoslav retirees received several months' worth of vouchers to pay for sporadically available fuel and electricity.
- Lines form during the wee hours of the morning to purchase governmentsubsidized bread.
- Shortages of food afflict this normally rich agricultural country.
- Public transport in Belgrade operates at less than 15% of its pre-sanctions level. The main bridges crossing the Danube at Novi Sad have yet to be re-built and with the oil refineries now destroyed, there is no asphalt to repair the roads.

When we first launched the soup kitchens in November, our local partners thought that formerly middle-class people would be too shy or ashamed to come. There was no basis for those fears.

Every day 400-500 Community members come and either eat together or take the food home with them. People come because the meals are hot and tasty. They save money and time otherwise spent standing in line. And there is the added feeling of social solidarity.

From the very beginning JDC provided free hot meals to Gentiles as well. We are now financing up to 400 such meals a day (100 in Subotice, 100 in Novi Sad, and 200 in Belgrade).





When we met in London in November, it is true that I discouraged you from making a donation to JDC to help the poor Jewish elderly in the FSU.

However, the following developments have taken place:

JDC has recently been appointed by a United States court to administer \$67.5 million for welfare services for needy victims of Nazi persecution in the FSU over the next ten years from the Swiss bank settlement.

However, I did not realize when we spoke that the Swiss gold money has been designated specifically for victims of Nazi persecution. Only 55% of our caseload are victims of Nazi persecution; therefore, we are now pressed to find additional funds for the non-victims so as to avoid having to provide two levels of services, namely a better standard for Nazi victims and a lower standard for non-victims.

With this new challenge, I felt compelled to designate your \$100,000.00 to assist the Jewish elderly in Ukraine. The elderly needy Jews of the Former Soviet Union are the poorest Jews in the world; despite lack of funds, it is JDC's responsibility to help these men and women live out their lives in dignity and some degree of comfort. If you wish, I would be happy to discuss this further at your convenience.

I've asked for a detailed project report on Hesed Menachem for the year 2000, which I will forward to you when it arrives.

I hope that you and your family have enjoyed the Passover holiday. As always, please give my best to Isabel.



They had to compete against several thousand colleagues so their quality is assured.

#### And the proposais:

The next year I would buy each student from the last round a university textbook of organic chemistry. I recommond Francis A. Carey . Organic Chemistry, (We are working with this book at our department and it is very useful for students).

It would fulfill two needs. It would focus the attention of these young excellent chemistion organic chemistry. It would also help than to realize how important it is to read english (you would be suprized now many really good students underappreciate the necessity to master english adequately when they start to study at our university, they often think, I will be a good chemist so why bother with languages, they of course do change their opinion later). So approx, \$2500 would be needed to buy the book.

Now about your excellent idea with the equipment donation for the school, the winner came from. It would need a bit more thinking but the base idea:

I would call it Loshmidt prize. (It would popularize Loshmidt name in the Czech republic, Dr. Bader will be definitively fond of it).

I propose \$5000 grant to go with this prize.

\$4000 to be given to the school the winner came from, and \$1000 to the teacher as an appreciation of his work and compensation for the work connected with grant administration.

I do not recommend to buy directly an equipment as needs of schools can vary tremendously, but I would make a list of recommendation to make sure that the school really uses the money for chemistry

But then when I visited Vivienne Lewis in London she gave me a photograph of herself with Mr. Bar-Chaim, copy enclosed. I very much look forward to meeting him.

While in Prague I did meet the head of the Jewish community, Mr. Tomas Kraus. He is a pleasant man but he refused to give us an accounting on the funds coming into the Jewish community in Prague. Of course, realistically, I had no business to ask for it, but it would have been interesting to see how the millions of dollars coming in from tourists are spent. Certainly little is given to smaller communities outside Prague. Incidentally, Mr. Kraus told Isabel and me that he had some disagreements with the Joint, for the very same reason!

Isabel and I will be in England the last week of this month and then again in November and December. I much hope to have an opportunity to talk to Mr. Bar-Chaim about the Joint helping with the distribution of our gifts, which up until now were given through the Foundation for a Civil Society.

Vivienne Lewis and Jonathan Joseph in London urged us to contribute to helping in the Ukraine, but I don't think this is really for us. I would much rather give to help very focused efforts, like the orphanage in Odessa.

# New WJR strategy is to focus on Ukraine

#### **By JAMES KAYE**

WORLD Jewish Relief's newly-elected chairman has launched the organisation's new three-year strategic plan at a breakfast briefing held at the Royal Institute of British Architects.

Jonathan Joseph outlined the project's aims, which will focus on 10 Jewish community centres in Western Ukraine. A fund-raising increase of 10 per cent'each year is needed to finance welfare provision in the country as well as an extra \$1.5 million to fund community centres.

Mr Joseph said: "If it/is to be successful, it is increasingly important for a non-profit organisation to have a business-like approach - that's why we have developed our strategic plan. We have identified what we need to do and how we will achieve it. It means we are focused, with goals to work towards."

WJR has also declared its intention to help rebuild Jewish life in the former Soviet Union and assist the plight of poverty-stricken elderly Jews in Western Ukraine.

Mr Joseph said: "The economic and political situation in the Western Ukraine, where most of our overseas work takes place, is in a state of flux. WJR is a very flexible organisation and, while we have to look to the future, we know that it is not feasible to plan for more than three years ahead. The Strategic Plan will be WJR's blueprint for the next three years."

However, Mr Joseph was also quick to emphasise the importance of partnership, working in co-operation with other Jewish organisations who have specific expertise in different areas.

THE director of the Union of Liberal and Progressive Synagogues Rabbi Dr Charles Middleburgh has met the Dalai Lama at the Tenth Lambeth Interfaith lecture.

An audience of 250 guests listened to an address by the Dalai Lama in the Great Hall at Lambeth Palace, and Rabbi Middleburgh was able to have a short conversation with him following the talk.

Rabbi Middleburgh said: "I was overwhelmed by the

"I also asked him a number of questions about his thesis, which he knocked back convincingly.

"It is clear that the Dalai Lama feels dialogue between the faiths is the key to a more harmonious future and he said people like those present should regularly engage in such discourse. The impression he gave me was that, if conditions were right and serious efforts were made in future interfaith discussions to include him, he would be willing to participate. Dialogue seems an essential part of his make-up."

With considerable foresight, Rabbi Middleburgh had brought a copy of the Dalai Lama's latest book to the lecture and the Buddhist spiritual leader signed it with a special prayer for peace - in Tibetan.

The situation facing children with physical or mental disabilities in most parts of the former Soviet Union is appalling. The children are sent to an institution where they receive virtually no treatment They are left in wards all day long, with no stimulation, inadequate heating and poor food. They are dumped and forgotten.

But in 1995 the Jewish community of Dniepropetrovsk, a large city in the south east of Ukraine, pioneered a programme for children with cerebral palsy called The Tikvah Club. The children who attend receive therapy, massage treatments and medicines as well as taking part in a variety of educational and social events. Because the children come from poor families, food parcels are regularly distributed.

A team of experienced teachers help the children to develop their physical and mental abilities to the full.

The children are taught about Jewish festivals, celebrate Shabbat and Jewish holidays together. Many of the participants had not left their own homes for many years so for children and parents alike, the Tikvah Club has been an almost miraculous happening.

There are currently 80 children attending the club, but there are a further 120 children in desperate need of the care and support the club could offer.

World Jewish Relief will be supporting the programme by making a grant towards running costs which will enable the Club to help more children. But, the Club is in desperate need of a specially adapted vehicle to take children to and from their homes to the Club, on outings and to receive specialised treatments. The cost of purchasing and adapting the vehicle is \$40,000. Running costs of approximately \$10,000 will be funded by our partners in Ukraine, the American Jewish Joint Distribution Committee.

We just met with Bulgarian Foreign Minister Mrs. Nadezhda Mihailova in New York. She thinks the situation will improve. Minimum pensions have been raised and central heating costs can be averaged out to include winter and summer months to spread the unequal costs between seasons.

We, however, are preparing contingency plans in case the situation deteriorates.

I confirm that your \$36,000 went to government-sponsored soup kitchens supervised by JDC.

Our relationship with the R'fa-aye-nu Society is not yet fully developed and I am unable to evaluate it as yet. I will try to make enquiries.

I enclose a status report on the Odessa orphanage. It seems that our local staff feel that the operation is worthwhile as the children cannot, for the moment, be released for exit to Israel.

Please forgive my delay in responding to your letter dated August 22nd. I have been traveling extensively on JDC business since the end of August and only now have I been able to give my full attention to your correspondence.

I was fascinated by the book that Daniel gave me. It is an astonishing story of the triumph of the human spirit in adversity. I think it is far more difficult for those born to privilege to recover from sudden misfortune than those who have less to lose. It was an uplifting tale.

We are checking to see whether two bodies in the United States are aware of John Goldsmith's efforts. JDC certainly did not until your grant of \$10,000 was received from you.

I note that he concentrates on medical assistance for righteous gentiles, whereas we and two other Stateside groups provide regular monthly assistance. We will bring each side to the attention of the other. It would make sense for everyone to be coordinated. I will let you know what happens.

Regarding Professor Feuerstein, he certainly is a world authority on his subject. I would advise your representative in Israel to contact Professor Jack Habib, the Director of JDC's Brookdale Institute in Jerusalem, who could give him information about his work.

The Jewish Children's Home in Odessa, which was opened in 1996, currently provides a home for 67 Jewish boys and girls aged 5 to 15. It's driving force is Rabbi Shlomo Baksht, an Israeli expat living in Odessa. For a variety of reasons, these children are unable to leave Ukraine. The primary reason is that they have a relative in Ukraine who refuses to give the necessary authorization to allow the child to leave the country. Generally, they are products of abusive or otherwise dysfunctional homes. Lishka is aware of the situation and the problem of getting authorization to allow the children to come to Israel for Yanush. Without the necessary documents, these children must remain in Ukraine.

Rumors abound about commercial interests in operations like this. This is certainly not the case in Odessa. Additional orphanages are in various stages of planning/realization in Dniepro, Kiev and Moscow.

I am attaching a background paper on the Jewish Children's Home. In addition, below you will find a summary of recent funds allocated to this program.

### The Jewish Children's Home of Odessa

### I. Background:

At the crux of the collapse of the Former Soviet Union is irony. While it has given many Jews democratic liberty, better opportunity to make Aliyah, and the possibility of receiving open aid from Jewish communities abroad, there is no longer the necessary infrastructure to provide basic economic and welfare needs. Central to this peril is the future of the Jewish community in the FSU – children.

In the Ukraine, crime, unemployment, and drug and alcohol abuse are rampant. In addition, the divorce rate has dramatically escalated. Consequently, some children are left without much family care — in some cases completely abandoned — and moreover, are the recipients of severe neglect and abuse. In such impoverished family conditions, children become custody of the State which is legally empowered to place them in state-run orphanages. Unfortunately, the conditions at state-run orphanages reflect the family environment with children receiving little care and often times, are the victims of physical abuse by their "caretakers." Most poignantly, because of intense anti-Semitism at the state-run orphanages, Jewish children endure additional hardship and hostility.


### **II.** <u>Need</u>:

There is an alarming welfare need for Jewish orphans. Since the Ukraine state-run facilities cannot provide a benevolent and supportive environment for Jewish children at-risk, it is the imperative of the local Jewish communities to create a safe-haven. However, with such a frail Jewish community, it is difficult to galvanize local efforts for subsidies, volunteers, teachers, etc. In addition, autonomous Jewish agencies are not likely to receive much support from government municipalities.

### III. Project Description:

The recent opening of *The Jewish Children's Home of Odessa* serves as a unique solution to the current crisis facing Jewish children in the FSU. Still in its infancy, *The Jewish Children's Home of Odessa*, under the auspices of Ohr Samayach and direct support from the JDC, has been able to begin the work of helping these impoverished youths. Working in conjunction with the Gemilius Hesed of Odessa, the Odessa Community Center and the Library of Odessa, *The Jewish Children's Home of Odessa*, now serves a total of 54 children – 25 girls and 29 boys. The children range in age from 5 to 15 years old. The boys and girls are divided into different sections, however, interact regularly during extra curricular activities The basic framework of the home is to create a Jewish family atmosphere while providing the necessary medical and psychological attention, educational and extracurricular programs in order to promote healthy development and advancement as future contributors to Jewish life and society in the FSU or abroad.

However, in order to substantially accommodate and develop the programs necessary to aid these children, further resources are significantly needed. In fact, due to a lack of funds, there are currently at least 15 children who are on the orphanage's waiting list. Moreover, while the orphanage already serves 54 children, it is estimated that there are

### PROPOSAL FOR EMERGENCY RELIEF AND NON SECTARIAN AID FOR BULGARIA

### Background

Since the beginning of 1997, thanks to the generous donation of Dr. Bader and the efforts of WJR, a full operation of emergency relief for the people of Bulgaria was successfully implemented by JDC.

In cooperation with the Ministry of Labor and Social Affairs, thousands of people from more than 10 cities, benefited from that support which came at the moment when the social and economic situation in Bulgaria was a disaster.

The main group, which was benefited by the donation, was composed by those elderly people who supported the saving of Jewish lives during the Second World War. For them it was much more than an humanitarian action, it was a symbol of gratitude and solidarity.

The aid was distributed through public kitchens at Homecare Centers, Public Canteens, Kitchens at Public Hospitals, and Old Age homes. A very small part of the donation was allocated also for an Orphan Home in one small village in the countryside. 10 % of the donation was granted to the Jewish Community of Bulgaria. These funds were used for covering part of the needs of winter relief for the Jewish pensioners.

### Statement of the need

Unfortunately, the general situation in Bulgaria remains very difficult. Although some of the financial indicators have shown a few signs of recovering ( the inflation rate has decreased and the Currency Board is keeping the exchange level stable ), that's not reflected on the daily life of the people. As the government tries to comply to the IMF requirements in order to get loans, some unpopular measures are beginning to be taken. Electricity prices are going up and the basic food prices are being increased over the average inflation.

But the worst of all, are the expectations for the upcoming winter. Everybody says that the upcoming winter will be at least as difficult as the last one. This will again leave the biggest majority of the population faced to extreme uneasy living conditions.

As last year, people will stand in cues to get food, but the government ( which is also forecasting the worst scenario ) already claimed that it has not enough sources to cope with the emergency. Anyway, a lot of efforts are being made to get humanitarian help for that purpose.

### Proposal

Based on the experience of this year, the proposal is the following: 29-007-1997 20:35 1 212 370 5467

- 1) To continue with the support for the Public Kitchens at Hospitals, Homecare Centers, Old Age Homes and Public Canteens across the Country as it was done during this year.
- 2) To adopt 1 or 2 public canteens and support them completely during the whole winter. The effect of such "adoption" would be very strong. It would imply that about 600 pensioners in two institutions would be completely supported by Dr. Bader generous donation.
- 3) To increase the support for the orphanages where no additional help is being provided by the government (comparing to the pensioners who are receiving at least their small pensions). The situation of the Kids at those orphanages is terrible. The basic needs for essential food are not provided because lack of resources. Supporting somehow those orphanages would be a way to support also the descendants of those Bulgarians who save the Jews during the Second World War.

In order to fund the Program mentioned below the necessary funds are an estimate sum of: \$ 45,000.-. This sum includes a 10 % allocation for the Jewish Community as was granted this year. As you can see, by adding only \$ 9,000.- ( comparing to last year allocation of \$ 36,000.-.) the Program could be expanded not only in numbers but also in the effect and scope of the aid.

This emergency relief was a great action to provide support to the most needy people in the Country. Next winter when people will see that the emergency relief is coming again, they will feel again our partnership, sensibility and solidarity.

150 more Jewish children currently housed in the state-run facilities that need to be transferred to *The Jewish Children's Home of Odessa*. The costs accrued in the painstaking process of searching, identifying, and transfering these children -- travel, access to government files, human resource assistance, etc. -- is unfortunately exorbitant. Moreover, the Ukrainian government requires a fee to transfer each child to *The Jewish Children's Home of Odessa*. Capriciously, the amount can be anywhere from \$500 to \$2,000 per child. Furthermore, important future programs such as computer classes, implementing a "Big Brother/Big Sister" model, a Jewish music project, and continued partnerships with the Gemilus Hesed, the Jewish Community Center, and the Library of Odessa all require additional funding and support.

### IV. Budget:

An annual budget of \$235,000 for a total of three years is required to help develop and sustain *The Jewish Children's Home of Odessa*. The following list applies separately to the boys and girls sections, but are exactly symmetrical in their amounts. \*Please note that for the first budget year, there are some one-time needs with costs totaling \$14,600.
