


Since we have \$67,022.66 in the account, we will be left with a projected shortfall of \$3,617.74, and no funds for travel or research.





Dear Judith,

You would not believe how piled high my desk is and of course last weekend we wanted to spend three days entirely with David and Franziska de Witt. That explains my being so slow in answering your fax of August $5^{\rm th}$.

I just do not understand the progression of the decline of the ISC deficits taken from the Abeyance account. Could we discuss this briefly with the financial people when we come to Queen's at the end of September?

I will follow Janet Brooke's recommendations about next year's appraisal costs. In the meantime, I have received the Art Dealers Association of America's appraisal for the Lievens now at Queen's at \$6.5 million.

I have had an order in with my stockbroker, Baird, to sell initially 10,000 shares of Sigma-Aldrich when it reaches 65, but it did this only very briefly, just before I put in the order. Now I would just like to be patient and hope that it will reach 65 soon.

While at the ISC we discussed with David Bevan and Sandy Montgomery our wish to help with a building for the residence of academics close to Bader Hall. We promised to pay £750,000 which Sandy estimated to be the cost.

I would like to confirm this promise and also that this sum would be paid for us separately and not taken out of the abeyance account, for obvious reasons.

I think that the new building should somehow be connected with David Smith, who is really responsible for the purchase of the castle. We will have to consider whether it should be the David Smith dormitories or the David Smith house, whichever sounds best.

I will be happy to meet Bill Flanagan during our visit, though you know how busy we will be. We will plan the details a few days before our trip.




Please stop wasting the University's money and just give all of these thank you letters to Judith Brown, who will hand them to us with a smile when next she sees us.



For the next report I will include the fiscal year detail so that the report is clearer."

So, it looks like all is in order... we have to wait until the end of the summer to find out the amount for 2005, which is consistent with previous years. I should have thought of that when we first spoke.

I also wanted to pass along a request from the Business Office, relating to future gifts, should you want to make any, to the AEAC for the purpose of covering the costs of art appraisal.

It seems that gifts for appraisals are not eligible for a charitable receipt. This caused the Business Office some difficulty when processing the earlier donation you sent along to cover the appraisal costs of the Michiel Sweerts, because the language of the cover letter was very specific.

Here is a suggestion that Janet Brooke came up with, that will work fine from a receipting perspective: you can make "an unrestricted gift to the AEAC appraisal account, number 892-106, in support of this aspect of the Art Centre's operations."

On another note, I hope we'll discuss your plans for Homecoming some time soon; I've just received my first request for your time -- the incoming Dean of Law, Bill Flanagan, who created the Law in Business course that has been delivered in the spring session at the ISC, is eager to meet you. I've told him that you set your own agenda for your visits, and that I'll get back to him once we've had a chance to discuss.



Today I am giving Queen's University 20,000 shares of Sigma-Aldrich and the proceeds of \$1,120,000 US should be put into the Abeyance Account.




Queen's tradition of diversity was experienced first-hand by one of our most distinguished alumni and generous donors, Dr. Alfred Bader. As a Jewish teenager escaping Hitler, he came to England in 1938, and in 1940 was sent by Britain to an internment camp near Montreal, Quebec. There the young Austrian native continued his studies and, once released, applied to several well-known Canadian universities. Queen's was the only one to offer him admission.

"I was a free man, I had been welcomed into a Canadian family and had been accepted by a prestigious Canadian university," writes Dr. Bader in his 1995 autobiography, Adventures of a Chemist Collector. "I was determined to do my best. ...Two years in the camp, education without distraction, followed by four years at Queen's, was a great beginning for a successful life." Indeed it was. After receiving degrees in engineering chemistry and history at Queen's, Dr. Bader went on to graduate studies at Harvard, formed his own international chemical company, and became a world-renowned philanthropist and art collector. Among his many gifts to Queen's, in 1993, was the 15th century Herstmonceux Castle in England, which today houses the University's International Study Centre (see page XX).



We will be in England from this Friday until December 22nd and of course plan to be at the Castle several times and also meet with Sarah Dalton.




