
Your fax of yesterday reminded me of our happy meeting in Nashville.

My calendar for late afternoon on Wednesday, May 10th is quite free, and I am wondering whether you could join me for tea or a drink around 4:30 that afternoon.

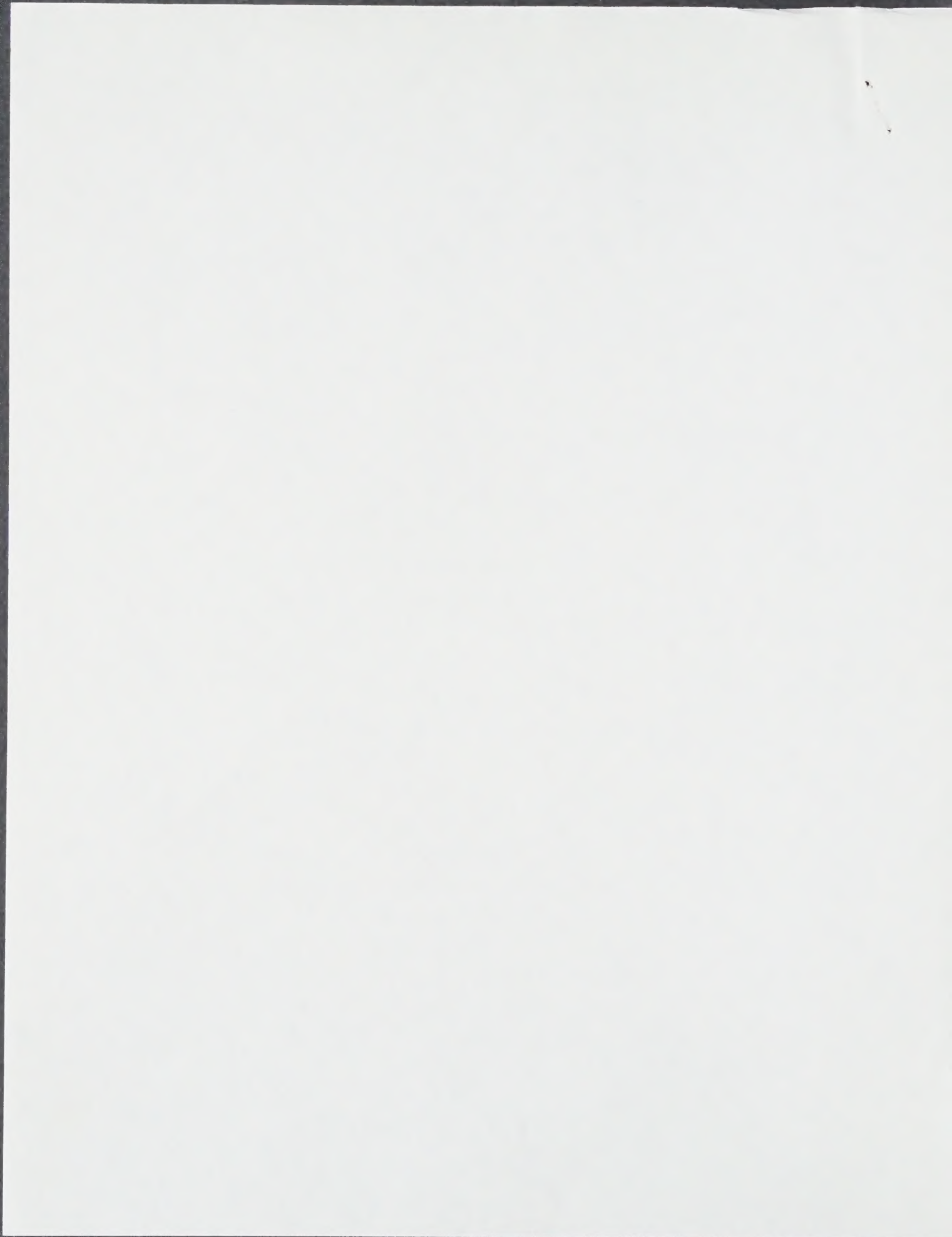
My gallery is located close to downtown and near the lake. Please telephone me that Wednesday afternoon, and I will give you directions how best to come here.
