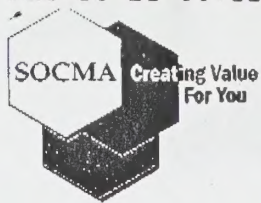
Dear Ms. Pyszka,

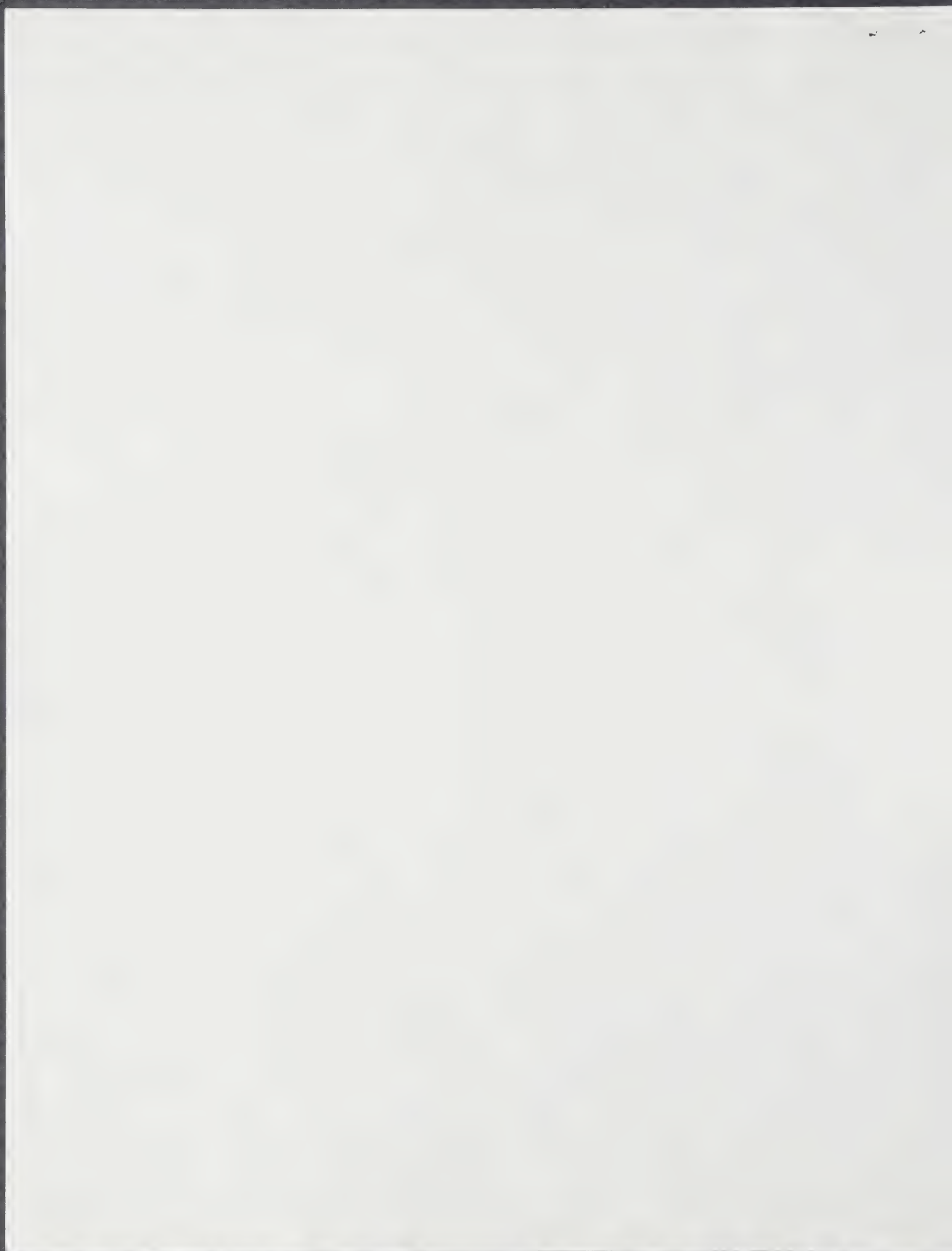

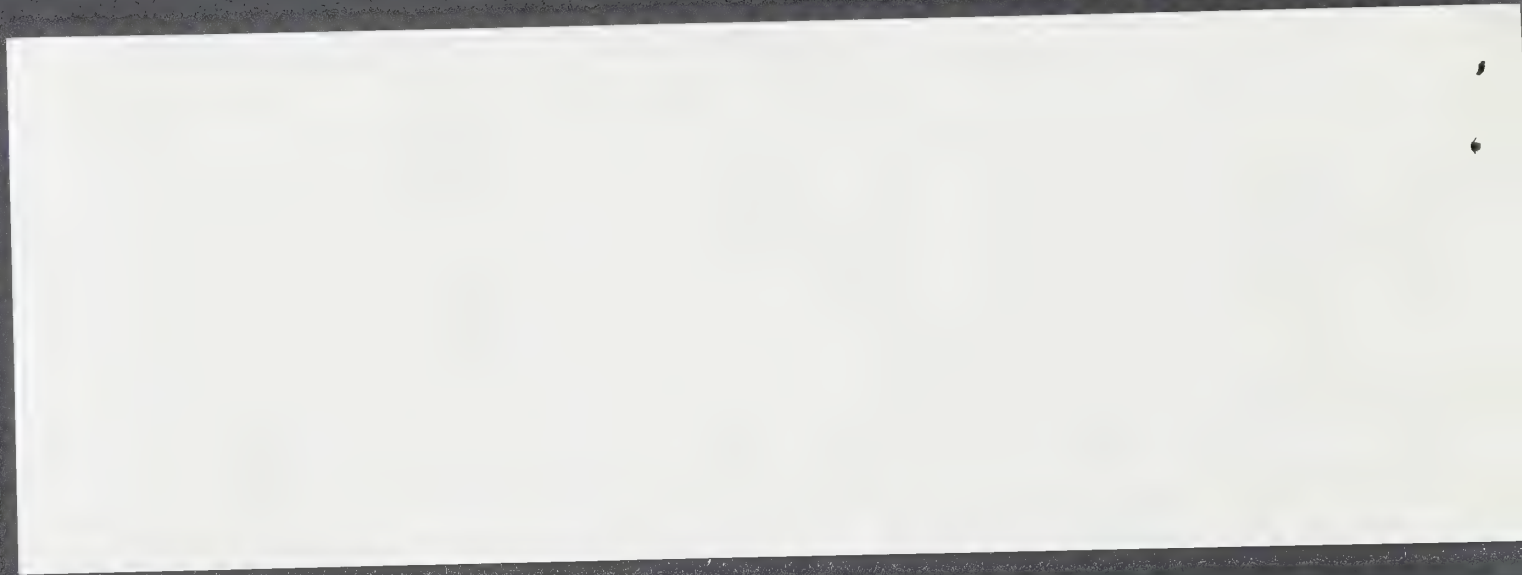

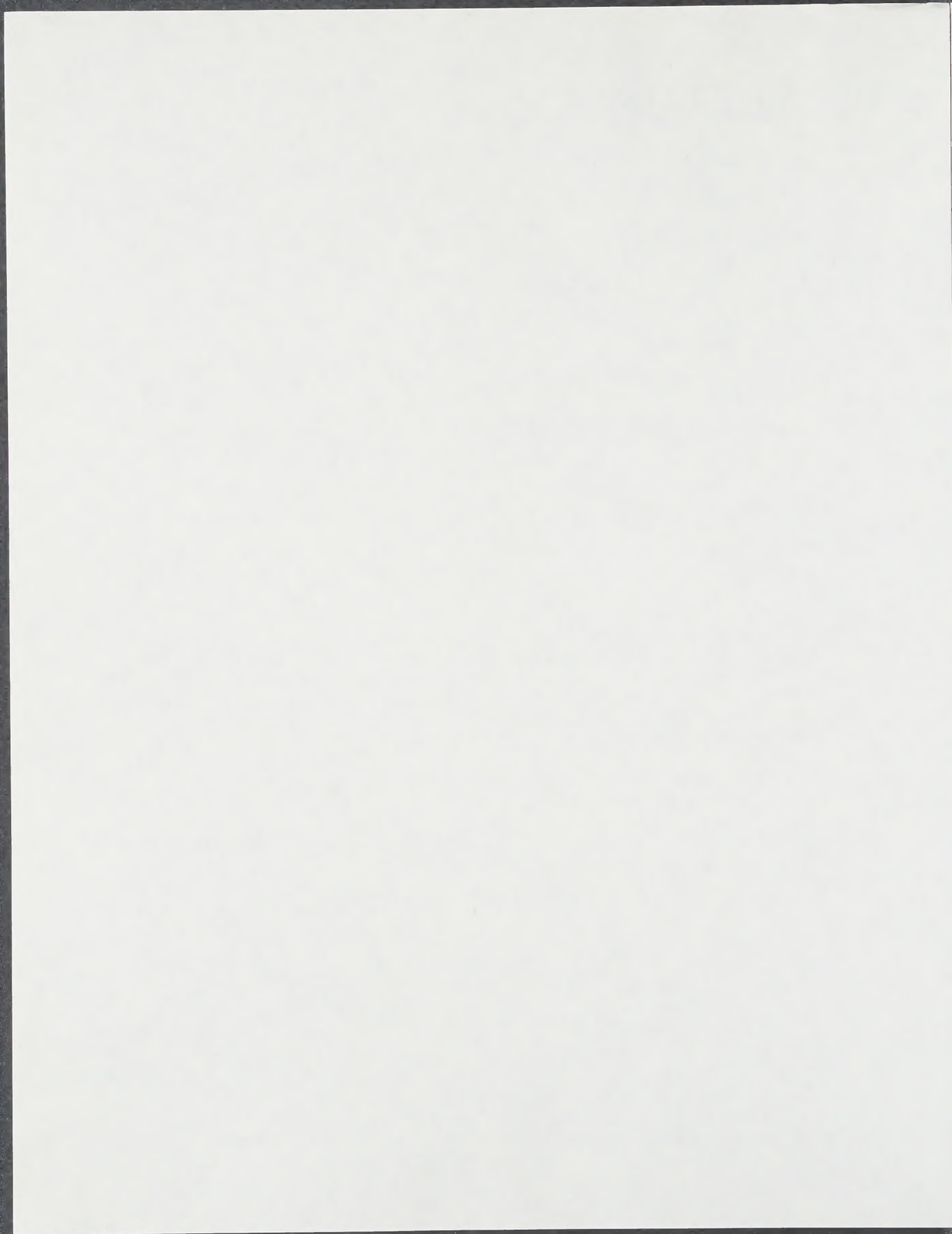

In response to your letter of July 18th, I look forward to being with you in Nashville on February 21st.

Neither Sigma nor Aldrich nor Sigma-Aldrich did a great deal in custom syntheses, although in the early days of Aldrich we certainly did some. Hence, if that is important to you, you can give my talk a sub-title "From Custom Syntheses to the World's Largest Supplier of Research Chemicals".
