Dear Friend,


I would like to take the opportunity to share with you some information about the recent and very exciting programming of The Project on Justice in Times of Transition. Enclosed you will find a report of the *Round Table Discussion on Reform of Intelligence and Security Services in Guatemala* that The Project held at Harvard Law School from March 31 to April 2, 2000.

The Project developed this workshop at the request of the new Guatemalan government to bring together four Guatemalan ministers with individuals with relevant expertise from Argentina, Canada, the Czech Republic, South Africa, Spain, and the United States. These meetings allowed for an open exchange of relevant information and provided the Guatemalan ministers with concrete suggestions for possible ways to reorganize Guatemala's intelligence and security apparatus so that they reflect the current needs of the country, uphold the rule of law, and make a successful transition from military to civilian services. Follow-up activities are currently being explored which would build upon the work initiated at the round table discussion. This may include: developing a program in Guatemala which would allow a wider group of Guatemalan officials to meet with leaders from around the world to examine in greater depth issues related to the reform of Guatemalan security and intelligence services; facilitating interaction between the Guatemalan ministers and their South African counterparts; and drafting and translating relevant documents which would assist the Guatemalans in making their reforms.

We are also organizing a number of new programmatic initiatives for the Summer and Fall of 2000. On June 25 and 26 in Gaza, The Project will hold *Fortifying the Foundations of a Nation: Strengthening Governance in the Palestinian National Authority*, a conference which will bring together distinguished leaders from around the world to share their experiences with 200 Palestinian government officials, civil servants, and community actors, representing a broad cross-section of leaders from Palestinian society. Additionally, The Project plans to hold a week-long session for politicians from Northern Ireland, Great Britain, and the Republic of Ireland at the Kennedy School in September 2000.

In April The Project officially launched its website, so for a more detailed account of our initiatives, please visit our site at www.ksg.harvard.edu/justiceproject/. We will keep you up to date on any future developments, and, as always, welcome your input and ideas. If you have any questions, please don't hesitate to contact us.

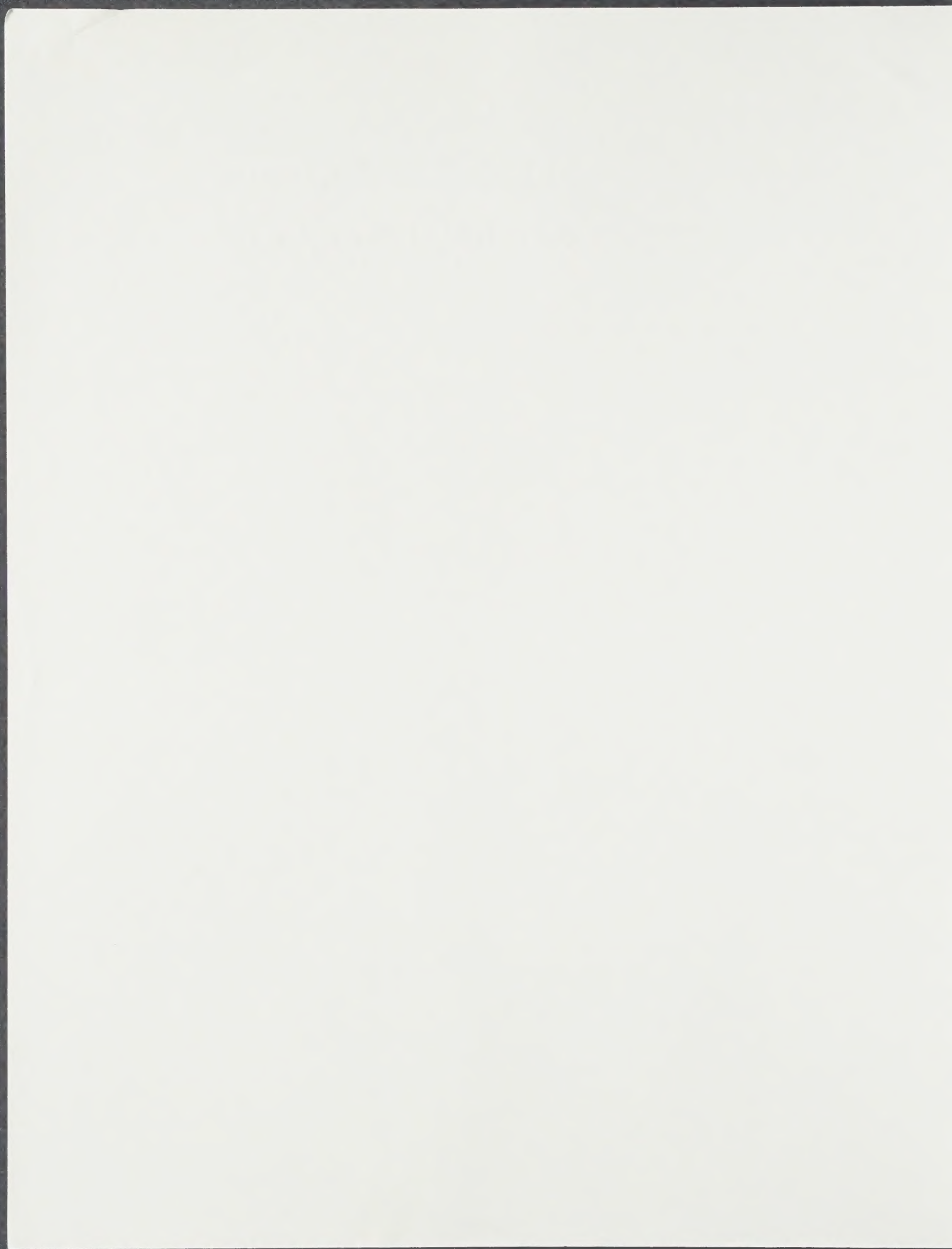

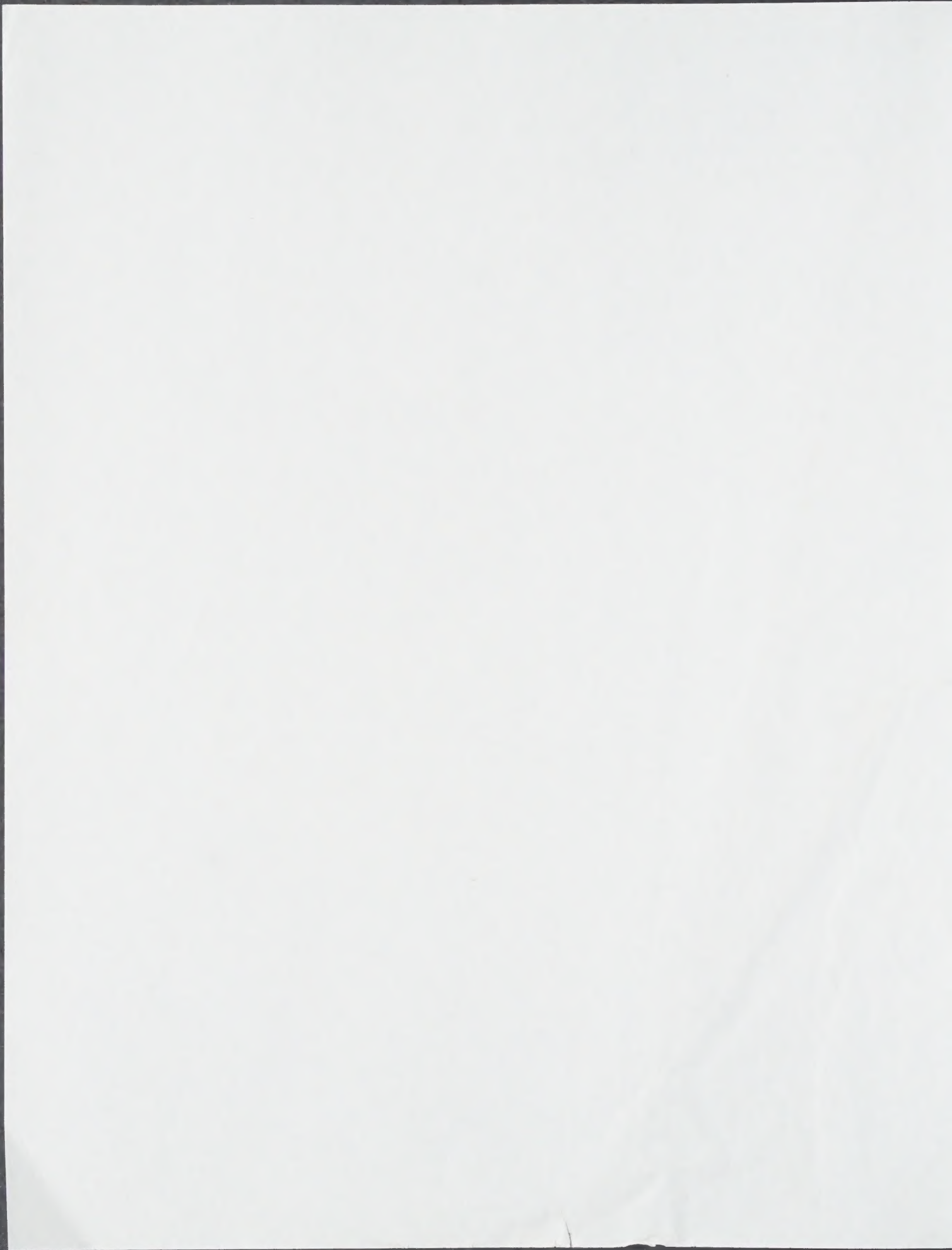
Thank you for your letter dated March 10th. I am thrilled that you have an email address, and I agree that we should communicate through e-mail. It is much faster!

Not many people has helped two generations in a family and made such a lasting impression in both of them.

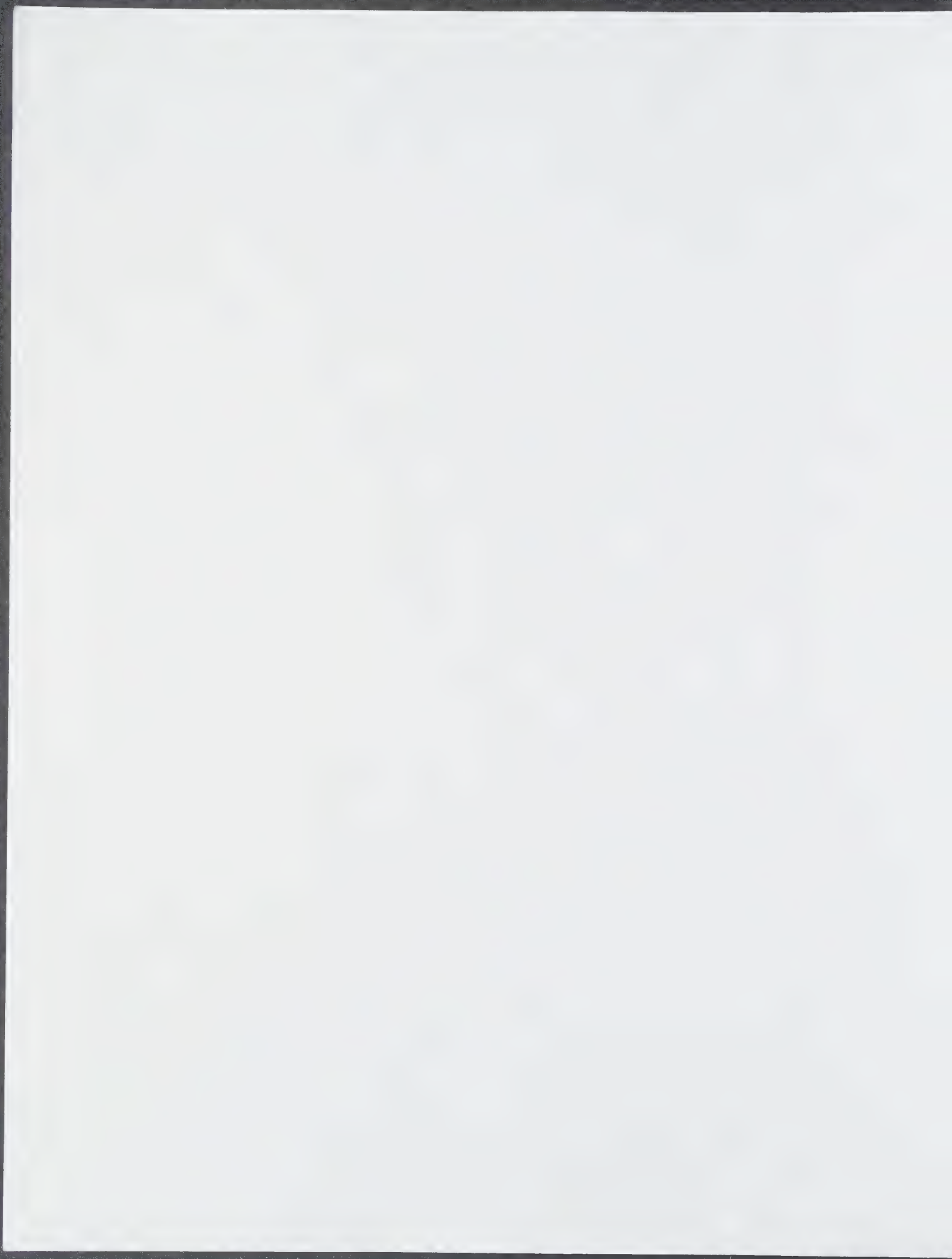
And, certainly, not many people has a gift named Isabel.

Shareholder letter – 2Q 2005

September 9, 2005

My Fellow shareholders:

Although we continue to experience difficulty in raising significant sums of capital, our university-based research activities are progressing very well. In fact, this progress has begun to draw attention from pharmaceutical companies. Management remains dedicated to the commercialization of our promising drug candidate pipeline.

Technology – Our radiotherapy collaborator, Dr. Griffin from the U of Minnesota, and Dr. Mayo have started their four year \$800,000 study. The NIH research grant will study the combined effects of PTX001 and radiation therapy on certain cancers in experimental animals. Dr. Mayo received notice that he has been awarded a separate \$800,000 four year grant on the anti-bacterial product line in conjunction with the bio-defense initiative of the NIH and Pentagon. In August, we received news from the NIH that our original SBIR grant obtained a high funding priority, but because we are a virtual company unable to spend the money in our own laboratory, we did not qualify for funding. Before we can reapply for NIH grants, PepTx would need to invest the capital to set up a lab and hire the appropriate personnel to carry out the research.

Pharmaceutical Collaborations – We recently signed a material transfer agreement (MTA) with a multinational pharmaceutical company for three compounds in our oncology platform. They will test PTX001, our lead peptide and two small molecules PTX008 and PTX009. We expect the testing be concluded in 60-90 days. Any future negotiations will be based on the outcome of their tests.

PepTx's licensing agent is now concentrating his efforts on a early stage Japanese pharmaceutical company. They are well funded and are looking to in-license antimicrobial products. We recently signed a mutual non-disclosure agreement and have sent them our confidential information for their analysis. If they show continued interest, the next step would be to execute a MTA to allow them to test our products in their own labs.

Our licensing discussion with a previous pharma collaborator has been put on hold. They recently made a strategic acquisition of a specialty pharmaceutical company and because of "business constraints" have put our licensing discussion on hold for at least 6 months. However, they remain very interested in our small molecule oncology compounds and indicated they would like to resume licensing discussions as soon as they digest the recent acquisition.

Pre-Clinical Program – Dr. Griffioen's group concluded additional confirmatory experiments in May, and PepTx has filed provisional patents on the novel PTX001 receptor and a recombinant process for making PTX001 analogs. Additional research is currently underway to determine the receptor(s) for the small molecule drug candidates. Early results have indicated the small anti-cancer molecules do not bind to the PTX001 receptor.

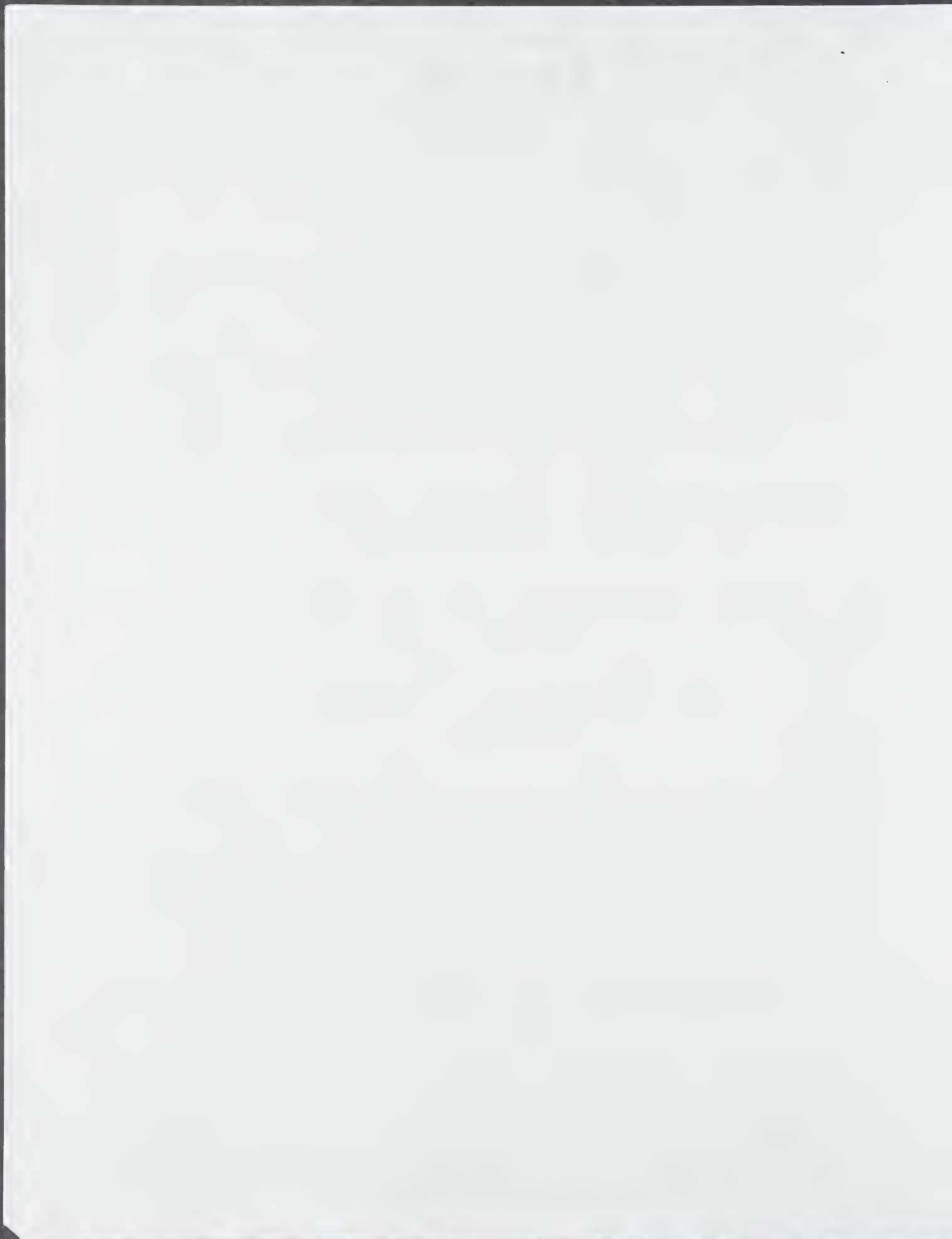
Funding – We have decided to launch a second round of angel financing with the target of \$300-600k. We are planning to fund a small toxicology and pharmacokinetic study on PTX001 at a leading Clinical Research Organization (CRO). With this additional data we will be in a much stronger negotiating position with potential pharma partners and investors. In the meantime, we continue to raise small amounts of money from management and Board members to pay essential expenses.

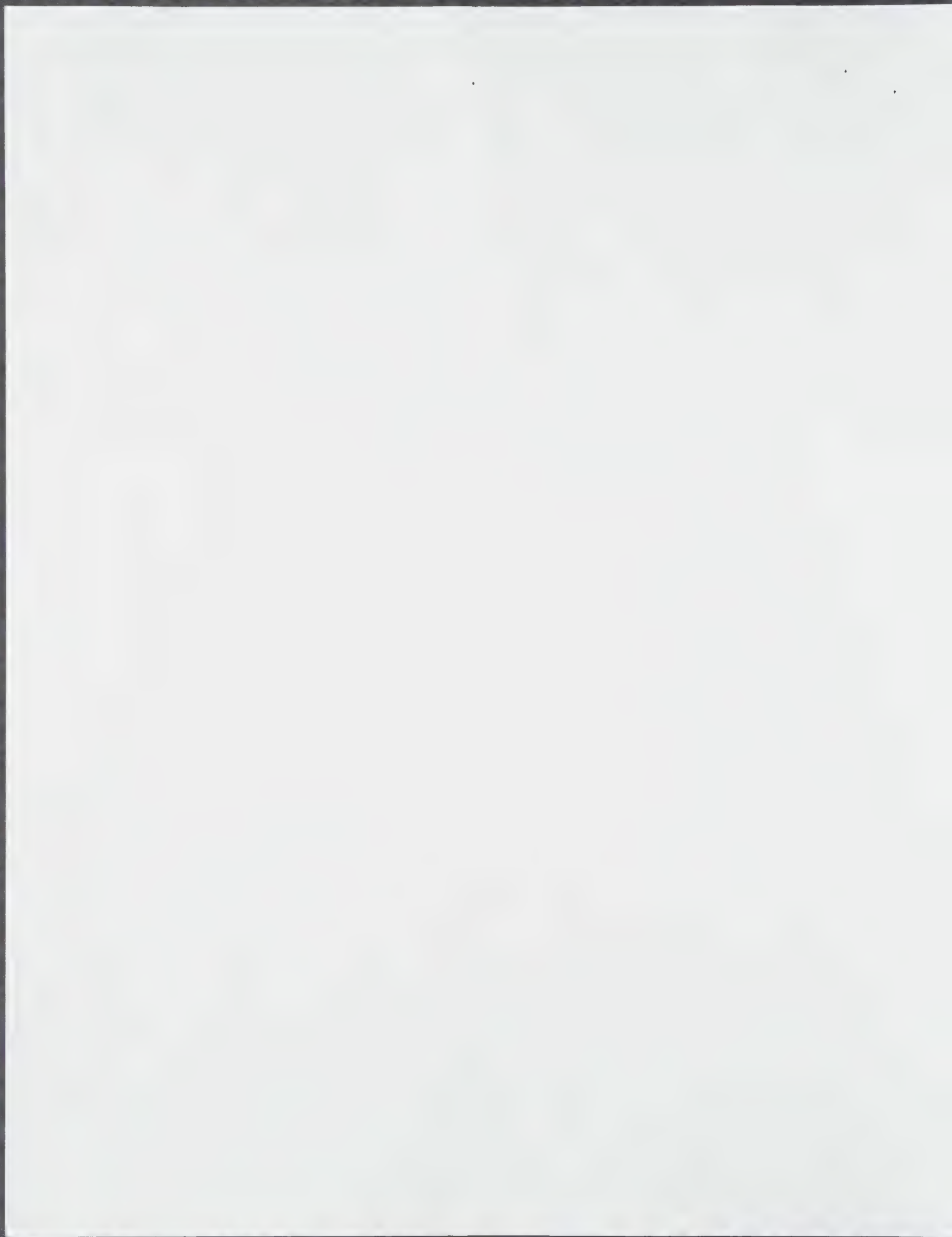
Dear Alfred:

Thank you for your letter of August 28. I think I understand your hesitation to invest in Protarga. Please forgive me for not giving up quite yet, however. I agonized over responding because I didn't want to bother you, but then I remembered your famous ads asking to be bothered, and how you, like Churchill, never give up! I really think this is an opportunity we should not let slip by. I am putting together some other investors who are willing to put more money into the new company, and buy some your equity, at a profit to you, very soon. With all the fraud and greed in the business world, wouldn't it be fun to work with someone you know and trust?

The situation is not as complex as it might seem. What we would be buying is not really a company, with all the accompanying difficulties, but just the intellectual property of Protarga: the patents, technology, the rights to Taxoprexin and the clinical data. My ideas are quite straightforward. I am afraid that other bidders may make some of the same mistakes that Protarga's current management has made, and that this drug, which could help so many desperately sick people, may not be properly developed. The potential is enormous, and the risks are clearly defined. We need to make a bid by September 26, and then attend the auction on Monday, September 29, and increase the bid to about \$4-5 million. If the other bidders go beyond a limit we set for ourselves, and we fail to win the auction, your money would be returned to you. If we were to be successful in buying these assets, our new company would need about \$1-2 million to cover the expenses for the first year if we focus only on the development of Taxoprexin. I have found a Canadian company (Bioxel Pharma, Inc.; Trading Symbol: BIP on the TSX Venture exchange; www.bioxelpharma.com) that is willing to provide us with a letter of intent to invest at least \$1 million in the new company within 30-60 days of the auction. They are in the process of closing on some funding, so they cannot meet the auction deadline by themselves. They would then put additional funds into the new company early next year when certain milestones are reached, and trade some of your stock for theirs, at a premium for you. They are a publicly traded company basic in the production of paclitaxel, the key ingredient of Taxoprexin. They would agree to supply crude paclitaxel to Cedarburg Pharmaceuticals for purification and synthesis of Taxoprexin. This would be of immense importance to Cedarburg in having a long-term supply agreement. Such an agreement could also be used to demonstrate to the pharmaceutical industry that Cedarburg is a reliable supplier of API's. I am attaching a simple draft of a term sheet I prepared that Bioxel is considering. If given a chance I think I can easily explain this and the clinical data to you and Daniel, and how we could proceed.

I certainly remember when we walked in Lake Park and discussed new compounds for Aldrich. I always brimmed with ideas and the excitement of Willow Brook working with you. Your encouragement, however, was always undermined by my lack of resources. I have never been able to follow through on so many of the ideas that I had then, or, unfortunately, now. As we recently discussed about genius and talent in artists, there is a similar nexus between ideas and resources in scientists. Even now at Cedarburg, as at Willow Brook, I am frustrated by having many more ideas than resources. Right now Jim cannot afford to provide me with the analytical equipment I need, nor even an office or a decent computer with essential programs. I have been working second shift, staying until late at night by myself in order to have at least some available lab equipment, and I have no hope of getting any assistants until much more money is raised. He cannot make me a permanent employee until further stock sales close. I am willing to do these things for you and Cedarburg, but I could do so much more. Yesterday, Jim showed me the financial projections, and the situation should be better next year. I have now started on the THC project, and am finishing the Exemestane project. I already have ideas for a novel, patentable THC synthesis. Agreements between the new Taxoprexin company and Cedarburg could be of great help in raising funds for Cedarburg, with minimal dilution.

I want you to know that I appreciate your offer to sell me a portion of your Cedarburg stock at very attractive terms. Regardless of the outcome of the Protarga opportunity, I would like to work with Cedarburg to assure and enhance its success. I would finally be doing what I should have been doing many years ago, working for you!



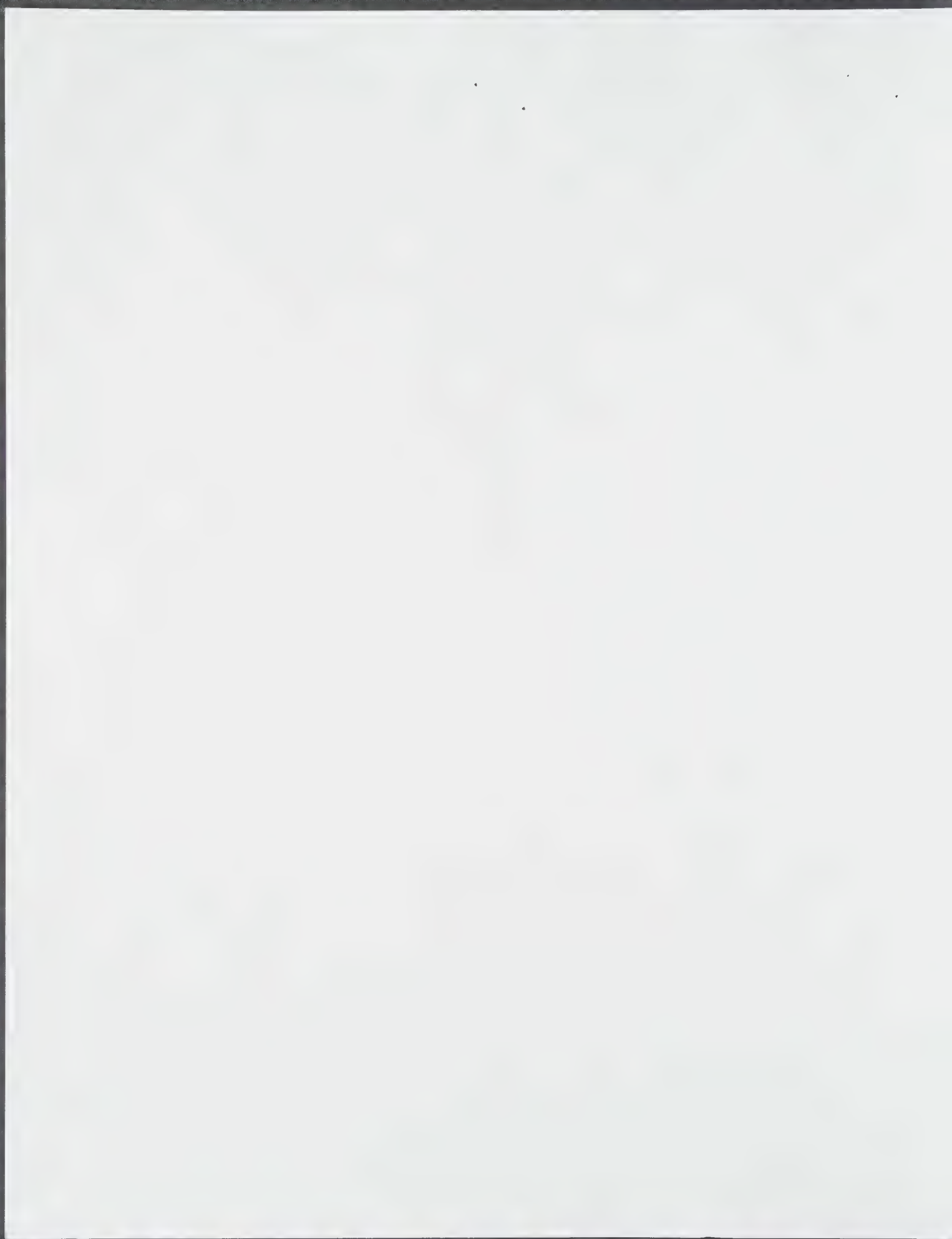

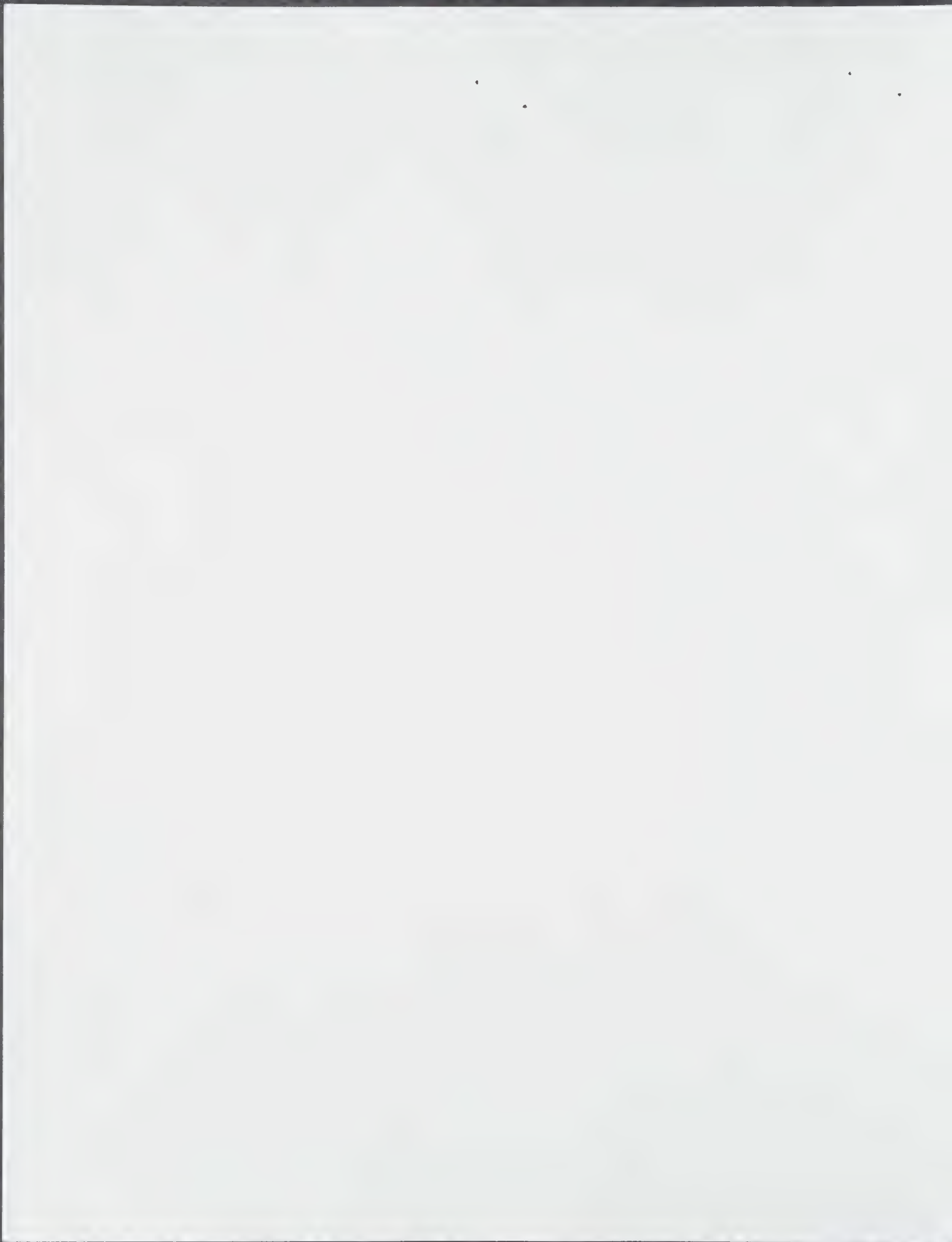

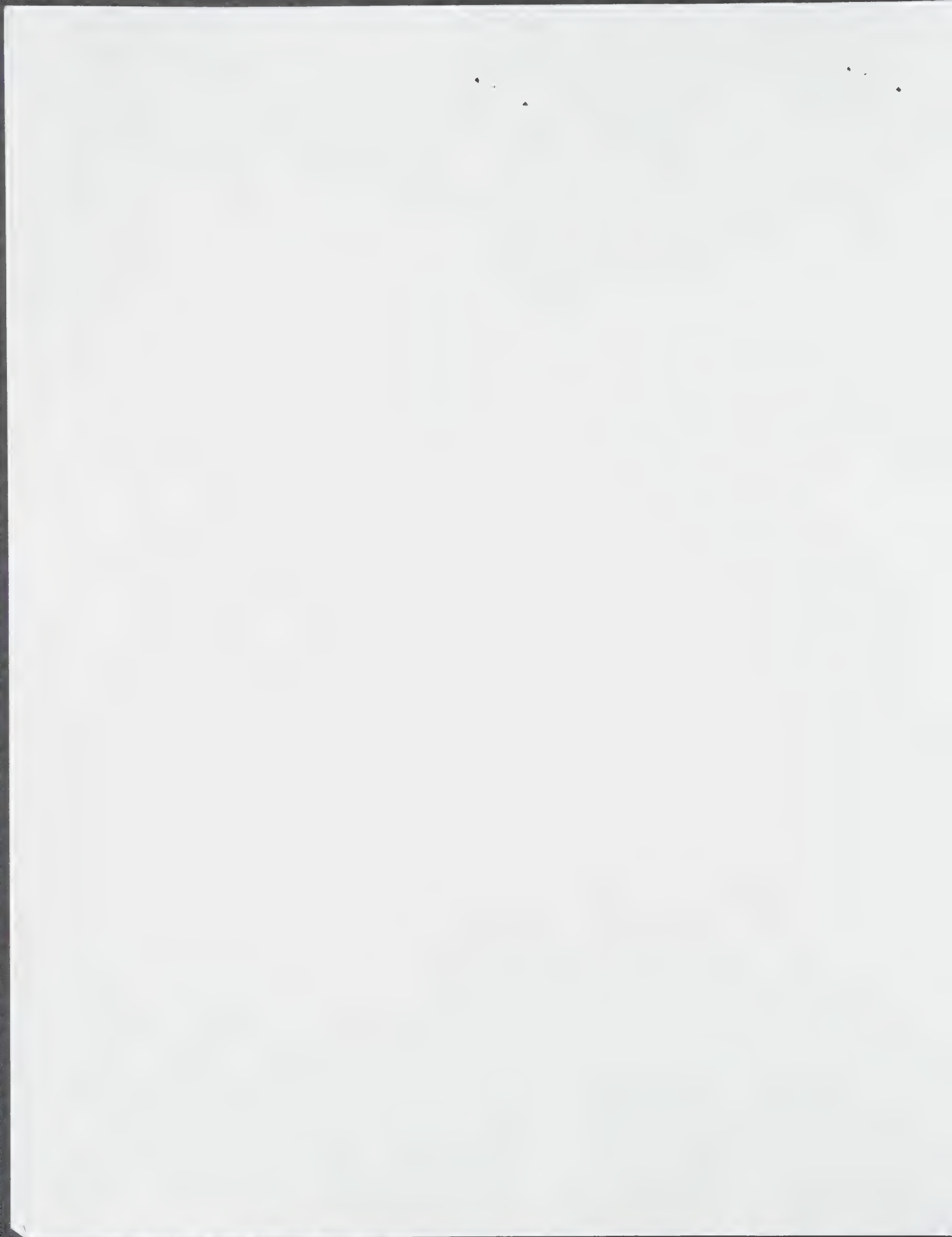
Proposed Term Sheet

(September 11, 2003)

- 1) A new company, "Newco," would raise money from a private investor and bid for the assets of Protarga, Inc. The purchase price is expected to be about \$4-5 million, with some royalties to be paid later.
- 2) If the purchase is successful, Newco would continue the development of Taxoprexin with the current studies and one or two new clinical studies, such as restarting Dr. Julie Brahmer's study at Johns Hopkins using Taxoprexin in combination with Gemzar (gemcitabine) for pancreatic cancer, and a non-small cell lung cancer study as a single agent or in combination with Navelbine (vinorelbine). A budget of \$1-2 million would be needed for the first year.
- 3) Within 30-60 days of completing the auction, Bioxel would agree to invest \$1 million (US) in Newco in exchange for stock, proportional to the initial investment by the private investor. Bioxel would further offer to exchange Bioxel common stock for a portion of the private investor's stock in Newco, at an exchange rate favorable to the private investor.
- 4) During the 6-12 month period of the first year of Newco, when certain milestones are achieved in the development of Taxoprexin, Bioxel would agree to purchase with cash additional Newco stock, at a predetermined price, and exchange additional shares of Bioxel common stock for more of the private investor's stock in Newco, at his option.
- 5) Bioxel would receive from Newco a long-term supply agreement for paclitaxel, that would be shipped to Cedarburg Pharmaceuticals in either final, purified form, or at some intermediate stage of purification, where Cedarburg Pharmaceuticals would produce Taxoprexin API. Cedarburg Pharmaceuticals would retain the exclusive rights for the production of Taxoprexin API, and could purchase addition supplies of paclitaxel from other companies if Bioxel is unable to meet its obligations. A fixed price for the



paclitaxel, plus a royalty based on the sales of Taxoprexin, would be agreed to between Newco and Bioxel.

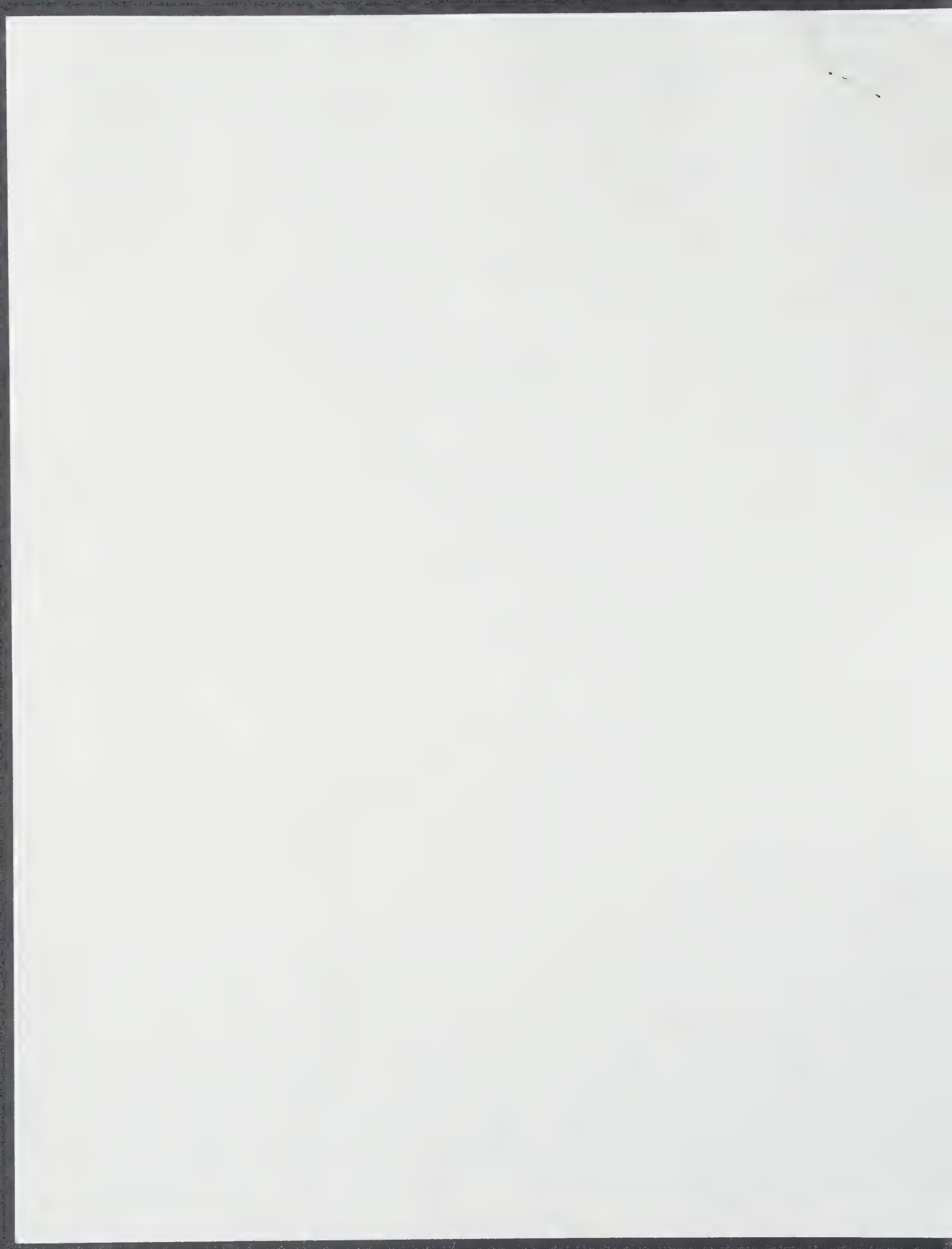

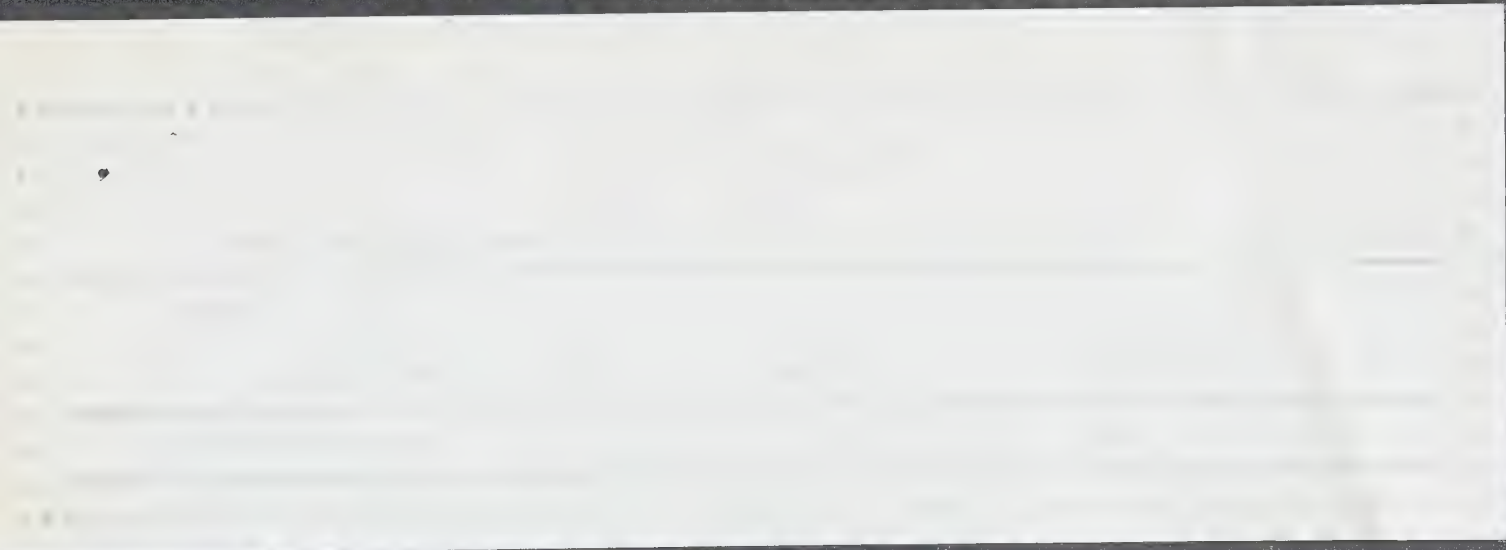

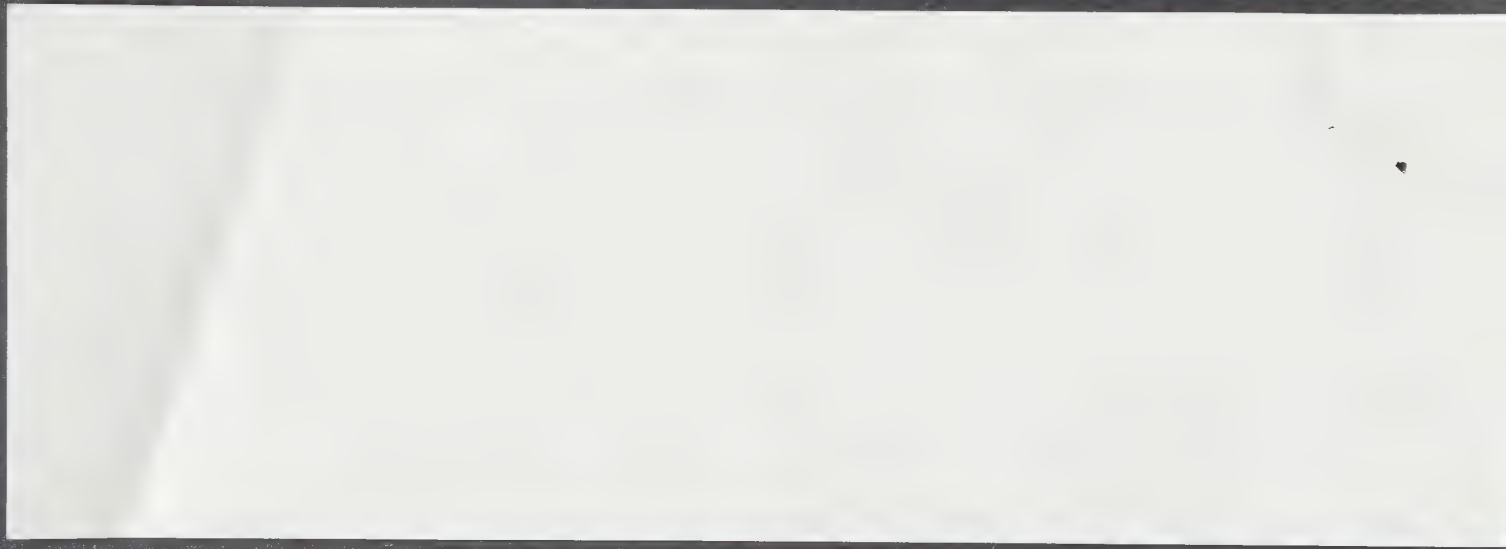

Not many people has helped two generations in a family and made such a lasting impression in both of them.

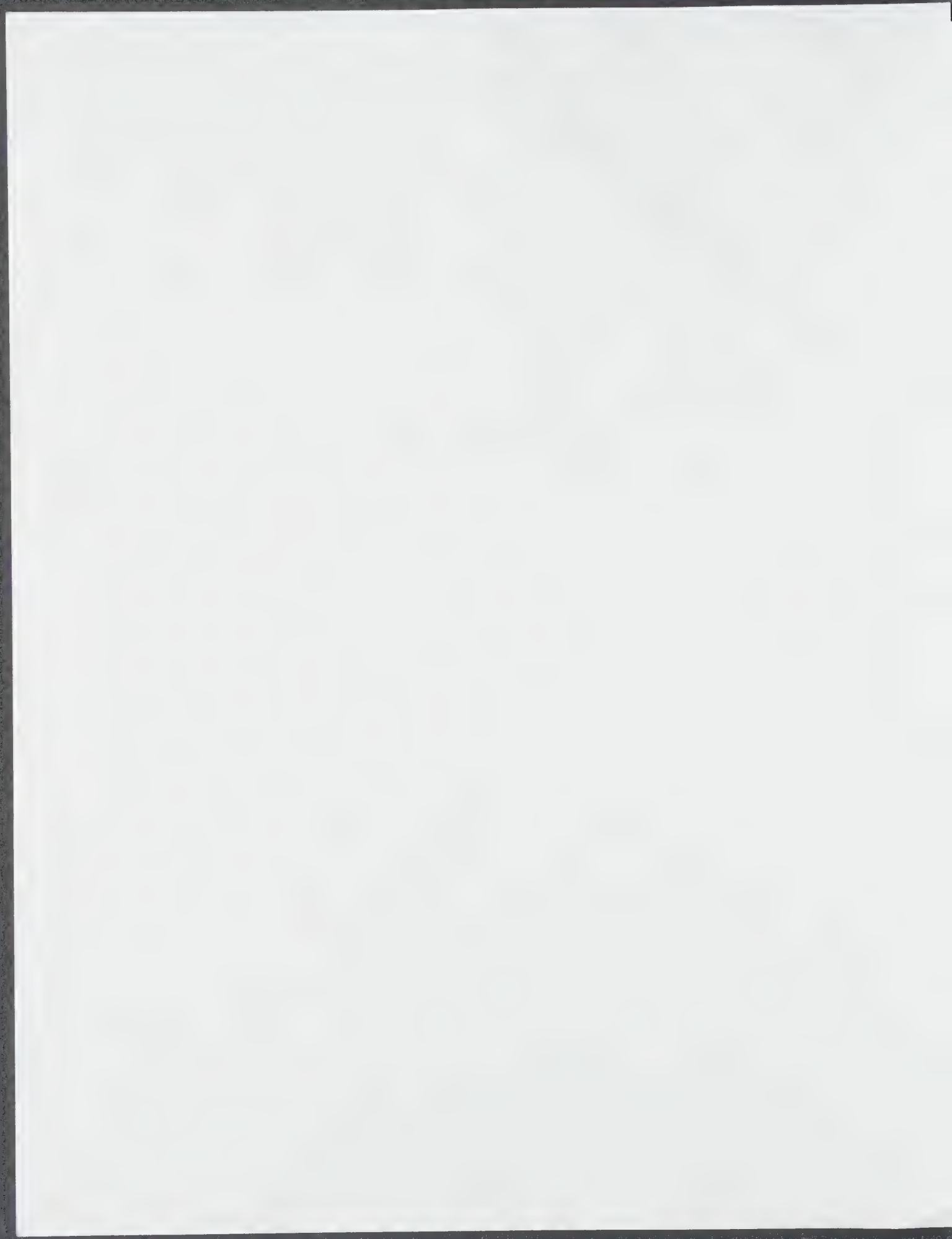
And, certainly, not many people has a gift named Isabel.

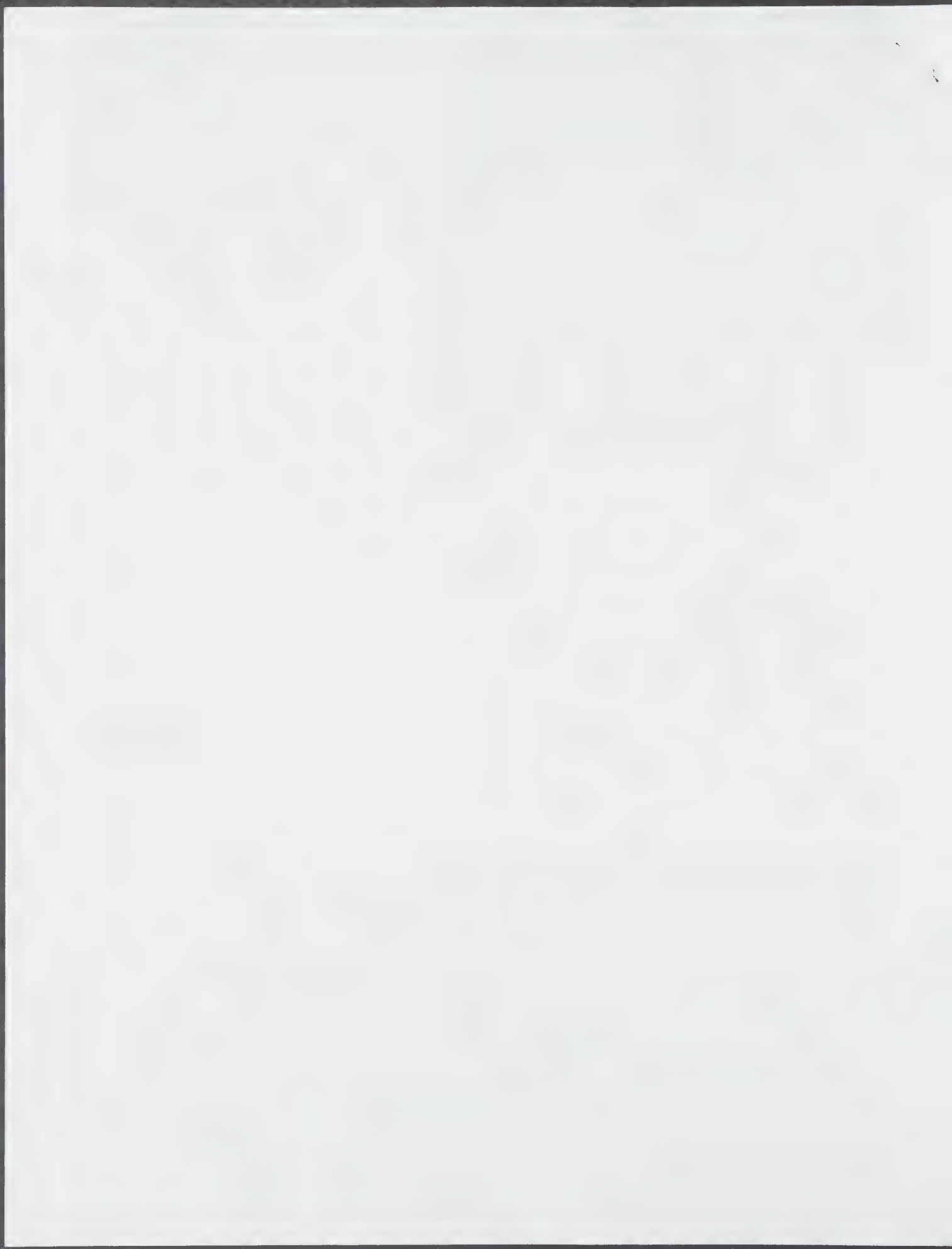
Thank you for your kind letter of January 6, 1995 and the deep interest you expressed in my research relating to Alzheimer's disease. As you know, this disease is one of today's most painful and costly afflictions in individual, social, and economic terms, affecting over 4 million Americans and costing over \$50 billion annually. In spite of intensive and prolonged research into the nature and etiology of this condition, neither a cure nor a consistently effective treatment is as yet available. In the case of such an illness, which is so very burdensome to the individual, the affected family, and society, even palliative measures with no permanent curative properties would be of great importance, especially in view of the demonstrated correlations between the severity of a case and the hardship and expense endured by both afflicted and caregivers.

The interest in acetylcholinesterase inhibitors as therapeutic agents came recently into focus with the approval of 1,2,3,4-tetrahydro-9-aminoacridine (Tacrine; Cognex) by the FDA as a long-acting inhibitor which easily penetrates the blood-brain barrier after systemic administration. Our recent studies provide valuable information about acetylcholinesterase via two channels.

First, due to the difficulties involved in the clinical monitoring of this enzyme, we decided to develop a much simpler assay. Our method is based on the enzymatic hydrolysis of p-nitrophenylacetate and provides an excellent introduction into laboratory courses designed to emphasize neurodegenerative diseases of the Alzheimer type [see reprint].

Second, we have developed a quantitative model of inhibition of acetylcholinesterase by Tacrine [see accompanying manuscript]. The competitive and noncompetitive components of drug inhibition, as well as substrate inhibition are all seen to occur at the enzyme's active site and to respond to the same charge relay network. Furthermore, recent molecular dynamics simulations utilizing the x-ray structure of the enzyme support our conclusions by showing that Tacrine is involved in π -stacking interactions with tryptophan residues located within the active site.

Tacrine has improved memory function in up to 33% of patients involved in clinical trials and is the first drug to be licensed by the FDA specifically for the treatment of Alzheimer's disease.



However, medical studies indicate that with prolonged treatment some patients suffer some degree of liver damage. Consequently, if funding permits, we propose to design, synthesize and study novel Tacrine derivatives that are less toxic to the liver, especially those containing hydroxyl groups.

Although many of the presenting symptoms of Alzheimer's disease are well known, such as progressive loss of memory, cognitive dementia, and specific behavioral abnormalities, the defining characteristics of Alzheimer's disease are histological and are frequently identified or confirmed only after the death of the patient. The two abnormal tissue morphologies most often seen in the brains of patients are neurofibrillary tangles and senile plaques. The composition of the plaques includes the so-called β A4 peptide, a specific fragment of the amyloid precursor protein (APP). The invariable presence of these plaques in the brains of patients, together with genetic evidence that the APP is etiologically important, implicate the plaques as either probable causative or aggravating agents. However, the connection between the plaques and cell death or other events resulting in dementia is as yet unknown. Consequently, we initiated in depth studies of aggregation of the β -amyloid peptides under a variety of conditions. The three specific areas we hope to address in greater detail are: (a) the rate of spontaneous aggregation as a function of pH and ionic strength; (b) the effect of metal ions, especially aluminum and zinc, on the rate and mode of β -amyloid aggregation; and (c) the effect of sulfated proteoglycans on the rate and mode of β -amyloid aggregation.

The delicate nature of the aggregation process, and its sensitivity to environmental factors, require a level of skill found only in well trained postdoctoral research associates. If funding continues, these studies will allow us to deduce the events that enhance self-aggregation to dimers, to hexamers, to higher oligomers, and eventually to plaque formation. Our earlier experience with insulin self-association [*Biochemistry* **19**, 5043-5049 (1980), **20**, 4354-4361 (1981)] gives us an important advantage in delineating the kinetics of amyloid aggregation.

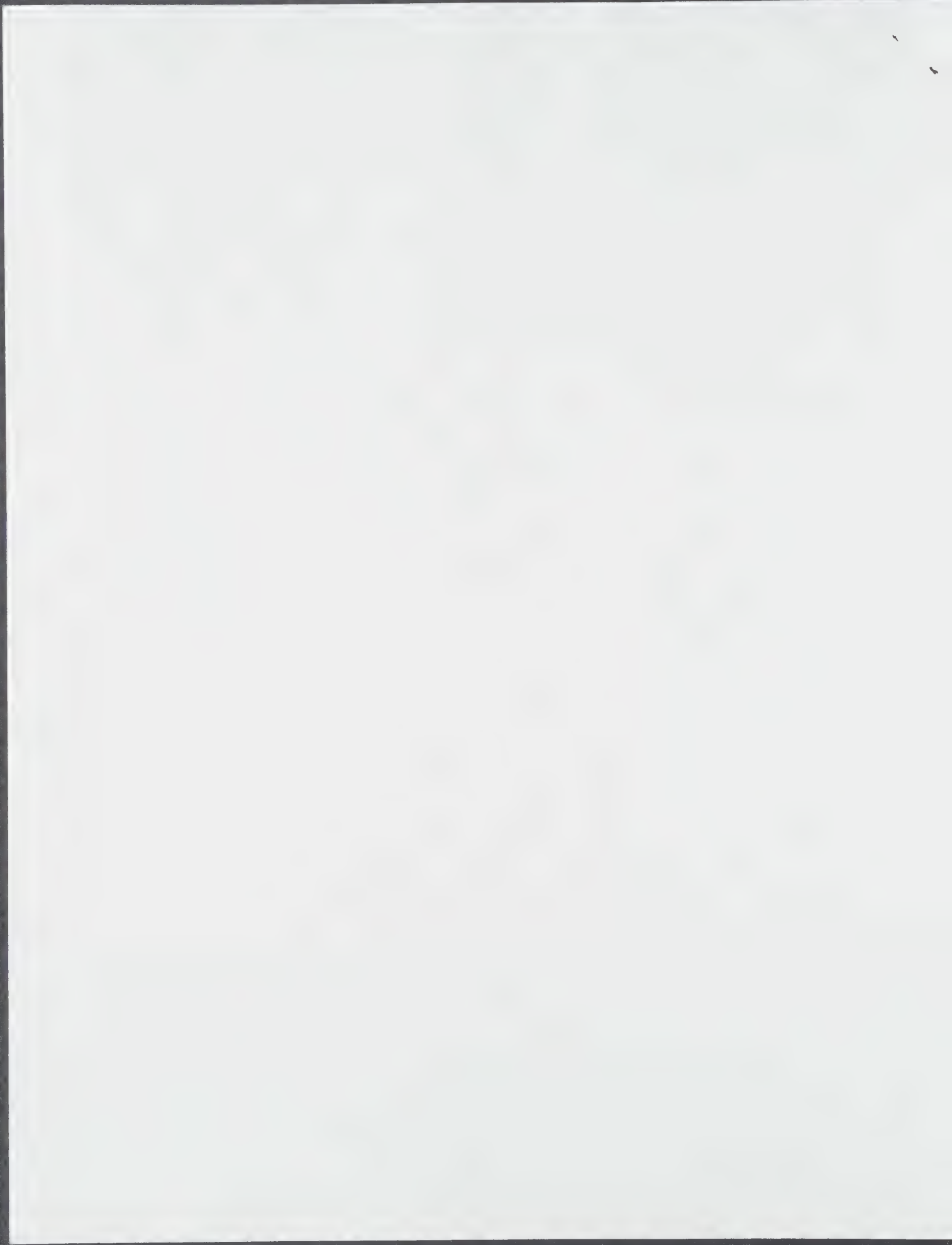

Book makes science fun, enlightening

MATT PLISZKA'S little book, "The Lemonade Mystery," started with a question.

Why is it that kids, born full of wonder about how the world works, grow up to hate (or fear) science?

"About four years ago I was working as a chemist for a company," says Pliszka, 28, who now works as a chemical consultant. "I was doing a lot of Mr. Wizard-type demonstrations for den meetings and in schools for friends who had kids. I'd do the demonstration and ask the kids, 'How do you think it works?'"

The youngsters surprised Pliszka with their insights. "They were so close to the answer in their own terms," he says. "I thought, 'What happens?' Everyone seems to be born with this interest in the unknown, but as they become older, science becomes a bad thing."

FEW CAN EXPLAIN

His theory is that very few parents and elementary school teachers know enough about science themselves to explain the world around them in simple terms that children understand. As a result, children give up and quit asking questions.

"The Lemonade Mystery," self-financed and self-published, is Pliszka's attempt to help kids and adults learn about science in a hands-on, everyday way. It is written for children from kindergarten through third grade.

His paperback coloring book tells the story of a monkey named Moppy who wants to be a scientist when he grows up.

When Moppy makes lemonade for his friend, Ribbons, she asks: "What happens to the lemonade when you stir the water? It seems to go away. Where does it go?"

This is Moppy's big chance to play the scientist and explain crystals and the concept of solubility.

"Solubility" sounds like pretty dull stuff. But Pliszka hopes to hook young readers with his hands-on lure: A package of Wylor's lemonade mix and a packet of crayons ("Moppy's Science Stix") come with the book. This gives his readers a chance to actually make lemonade, watch the crystals dissolve and color the storybook, which reinforces the concepts in the story. A teaching guide at the end of the book helps parents anticipate questions.

FINDS BIG GAP

"I believe if I show you the right example, you can understand almost anything," Pliszka says.

In researching his project, Pliszka checked out bookstores to see what was available to kids. What he found convinced him that there was a big gap to be filled. When he couldn't drum up any interest from publishers, a graphic artist friend convinced him he could go the desk-top publishing route.

Before he jumped in, Pliszka sent his text to grade-school teachers, librarians and scientists. "A lot of wonderful people did critiques," he says.

One of those people was Candee Kolb, buyer for the four Teacher's Pet stores, which sell educational supplies. (Pliszka's book is carried at Teacher's Pet.)

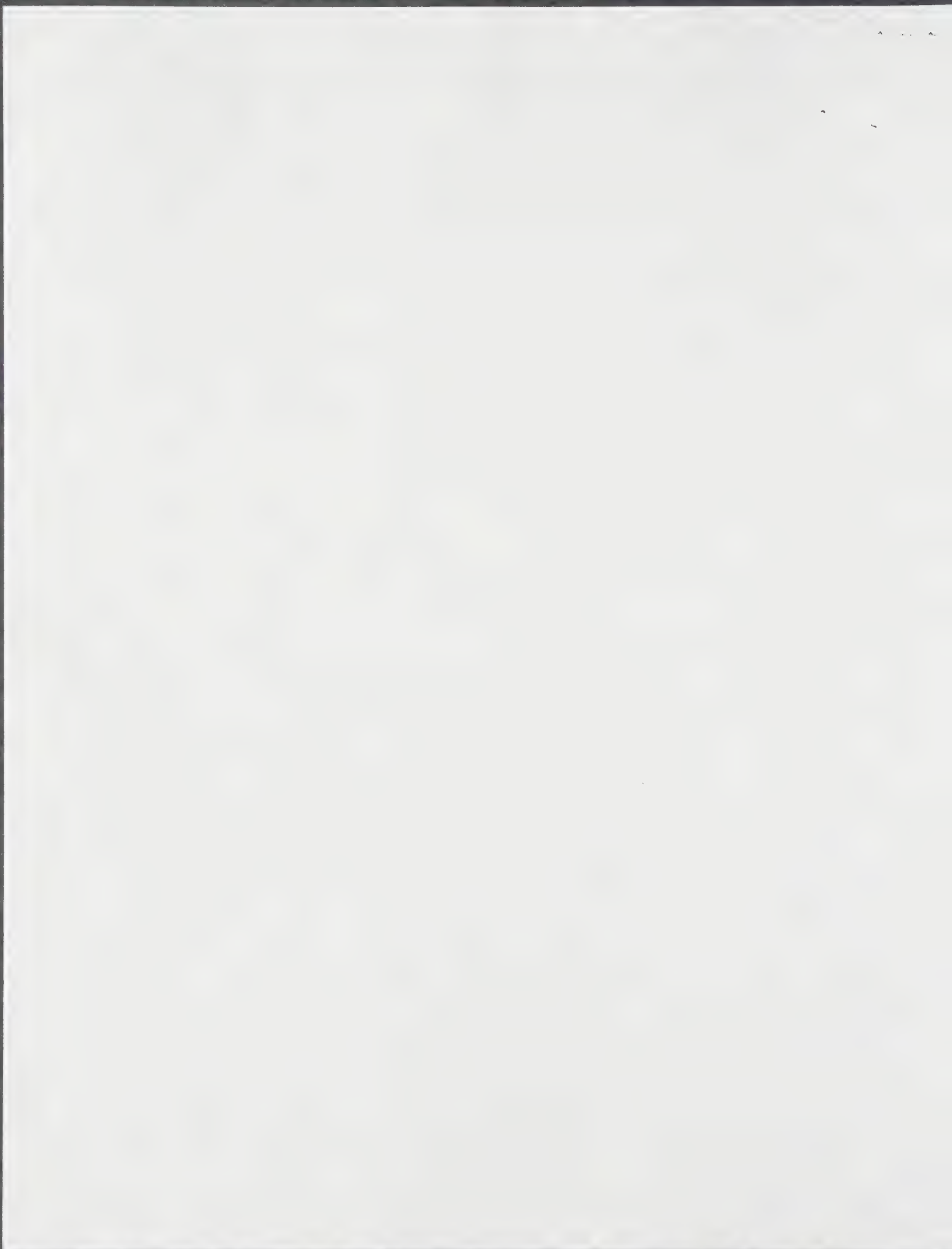

"I gave him some input," Kolb says. "I suggested what customers look for and so on. I think he's making an attempt at something that has been needed. People are intimidated by science. He's bringing it down to a level where we can understand it. I applaud him for that."

The energetic Pliszka has more ideas on the back burner.

His next book, which he hopes to publish this spring, will answer the question, "Why do I skin my knee when I fall off my bike?" The answer, in words kids will understand, explains the concept of friction and force.

After that, Pliszka will take on thermodynamics with the question, "Why does ice cream melt?"

The Unfair Trade Practices of Book Wholesalers

Introduction

In the July 1991 issue of the *COSMEP Newsletter*, John Huenefeld declared war against the distribution discrimination of the two major bookstore chains and the top national trade wholesaler. While there are no specific numbers available, it has been estimated that as much as 40 or 50% of all bookstore sales are made via these three outlets and a few other major wholesalers.

The problem for smaller publishers is that most of these major buyers will not order direct from a smaller publisher. Instead, they insist on obtaining the books they want from a select list of small press distributors. While this saves these outlets many hassles with fulfillment and payments, it places a huge penalty on all small presses who want to do business with them.

While major publishers can sell direct to these outlets at 46% to 50% discounts, smaller publishers must sell through wholesalers (at a 50 to 55% discount) or through a distributor (at effective discounts of 60 to 72%). Some smaller publishers are paying as much as a 22% penalty just to sell to these outlets.

While Huenefeld's major recommendation was to sell direct to the bookstores (by developing a customer base over a period of years), he also recommended selling direct to the major national and regional wholesalers rather than going through an exclusive distributor.

The Problem

The problem with this solution is that most major wholesalers are now requiring new small publishers to sign contracts with them that give them a 55% discount, free freight, and consignment terms (they pay 60 to 90 days after the sale).

Among the companies that are now requiring such contracts from new vendors are the two major national wholesalers, Baker & Taylor (for bookstore sales) and Ingram, as well as many regional wholesalers, including the distributors (of South Bend) and Pacific Pipeline (for a sample of their contract, see page 30). Indeed, Baker & Taylor is now asking for a blanket 55% discount from any new publisher who wants to sell to bookstores through them. B&T then buys all books at that discount, even those intended for libraries which normally get only a minimum discount from B&T.

The fact of the matter is that these same wholesalers do not require similar terms from the major New York publishers. Most wholesalers buy from these publishers at discounts ranging between 46 and 50%. In effect, smaller publishers end up subsidizing the larger publishers.

One Small Publisher Fights Back

At the ABA Convention in June I spoke with one growing publisher who had decided to leave their distributor and sell direct to bookstores, chains, and wholesalers. While one of the major national wholesalers had been buying their books for years at a 50% discount (through the publisher's distributor), the wholesaler now required this publisher to offer them a 55% discount.

Well, this small publisher fought back. They refused to buckle under, but it was "a bloody battle." Eventually the wholesaler agreed to take this publisher into their system at the old 50% discount. But the only reason this wholesaler agreed to such terms is that they wanted and needed the publisher's line of books. Why? Because the bookstore demand for the books was so great.

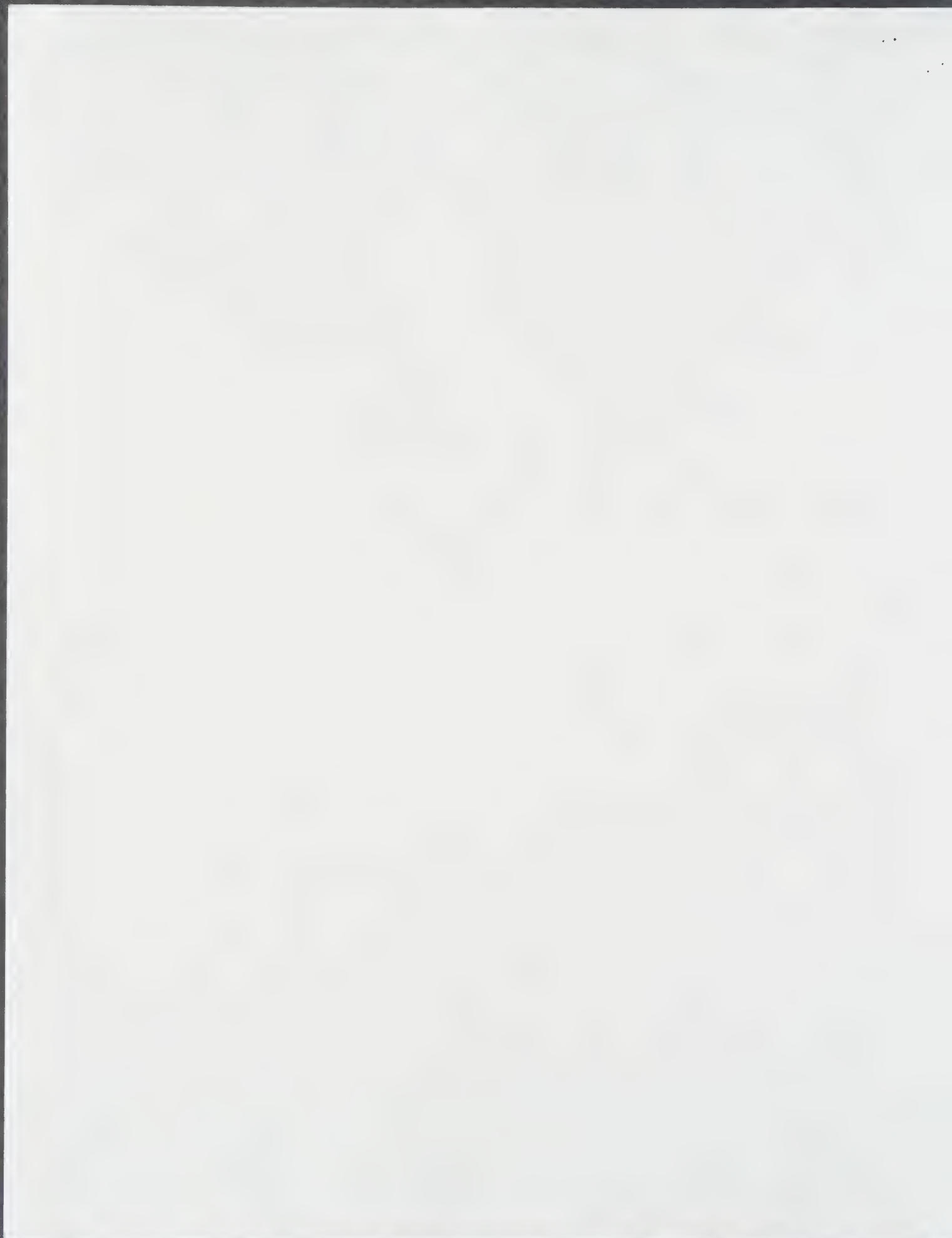
The Solution

The problem, of course, is that new publishers do not have a line of books with a long history of sales that the bookstores demand. As a result, if new publishers want to sell to these major wholesalers, they are forced to agree to these unfair and discriminatory terms.

What is the solution? I'm not sure I have one. To be quite honest, I don't mind accepting these terms—but only if the wholesaler earns them. I gladly sell books to Quality Books and Unique Books under these terms, but both of these library distributors earn their keep by selling books direct to the libraries. Plus, even more important, they treat all vendors equally.

The wholesalers, on the other hand, are relatively passive order takers. Furthermore, they don't require such terms from the larger publishers. That's discrimination. And it's unfair. More horribly, it has the effect of denying the reading public many of the best books now being published—those published by small publishers.

What to do? Stand up and be counted. Write to me with your suggestions. Write now!

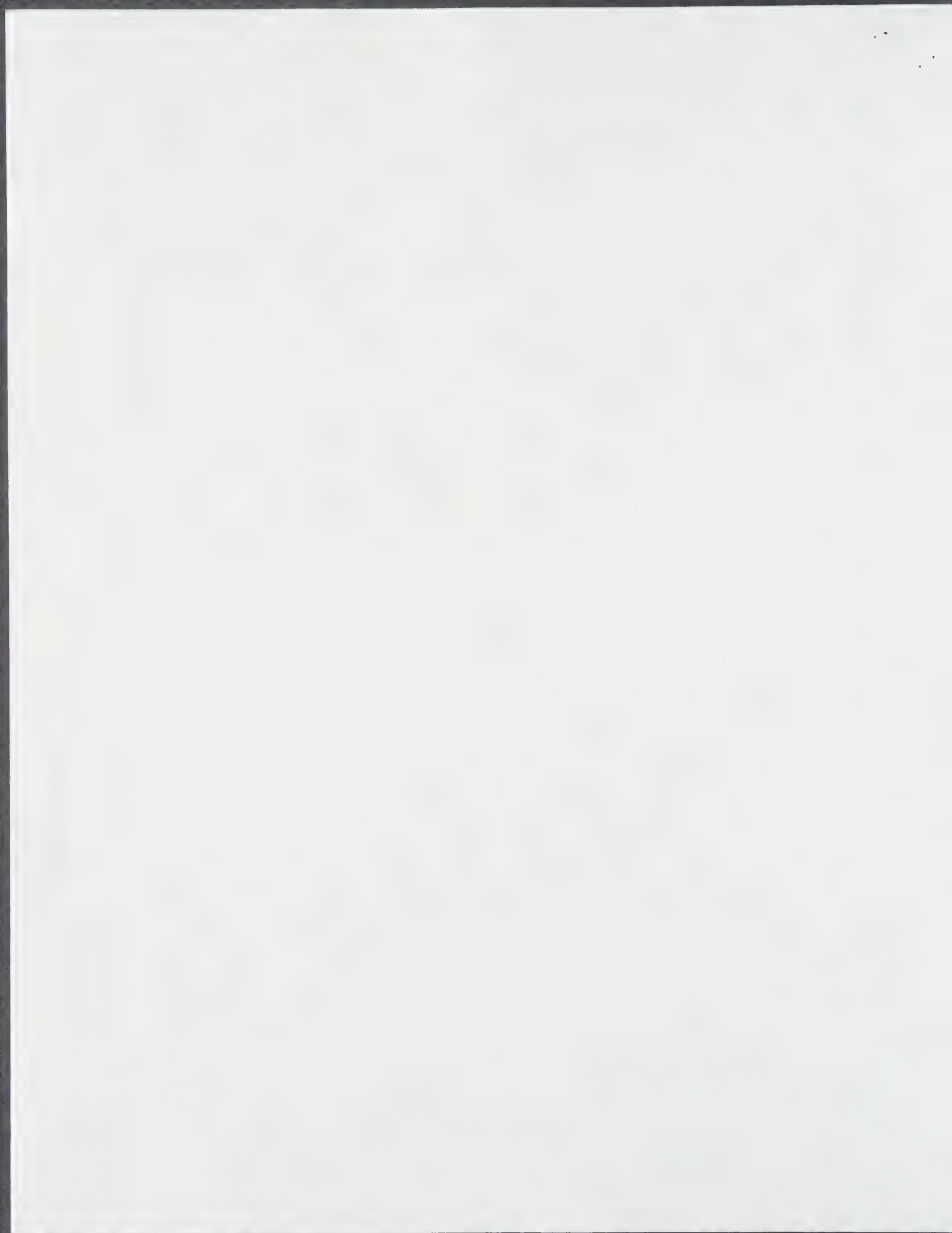
