

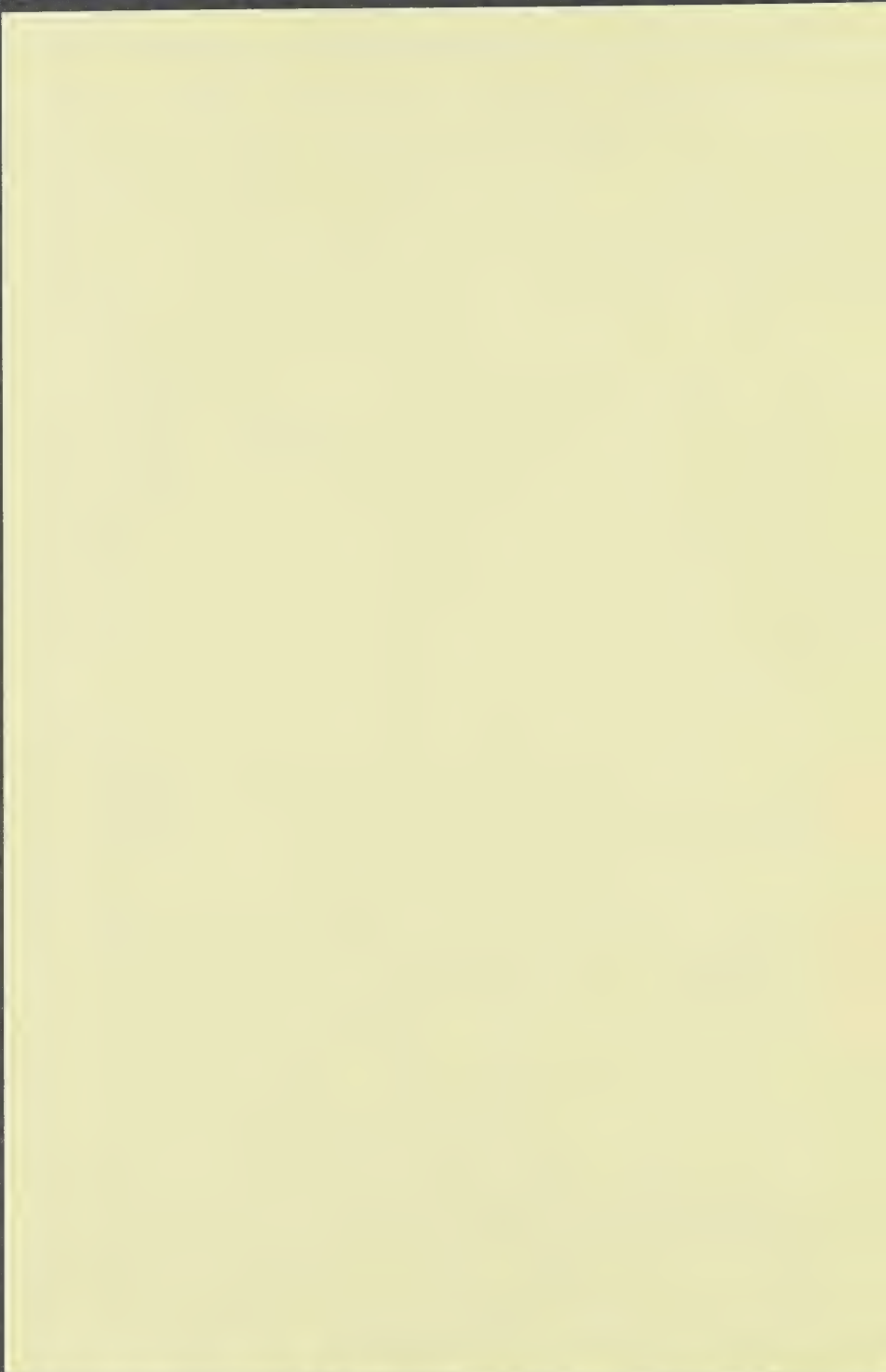

1. The bulging fill was removed from the forehead and a few background areas.
2. The patch was removed from the back of the forehead area.
3. The canvas distortions were flattened as much as possible.
4. Losses were filled with gesso and inpainted with polyvinyl acetate and pigment.
5. Final varnish of Regalrez 1094.

Yosemite Valley by Jorgensen
oil on canvas

1. Surface dirt was removed with dilute ammonium hydroxide and yellowed varnish was removed with acetone. This also removed some retouching at the bottom edge but some filling and retouching remains.
2. Insecure paint was consolidated with wax resin.
3. The painting was coated with Acryloid B-72.
4. Losses were filled with gesso and inpainted with polyvinyl acetate and pigment.
5. Final varnish of Regalrez 1094.
