Dear Dr. Wolf,

First of all, I would like to keep my promise and send you one of the several catalogues commissioned by the late Col. Chesrow. You will want to send this to the buyer of #17, who should be very satisfied with his purchase. Of course it isn't by Van Dyck, but a fine portrait anyway.

You saw #2 at Clovis Whitfield's; it isn't Caravaggio, but a very fine Vouet.

#1, while not on canvas but on copper, is a fine painting, small enough that it might be one of the several that I could send you from England in November, for your next March sale.

All in all, the collection is really a mish-mash, ranging from very good to pretty poor and it is amazing that a Colonel in the U.S. Army in Naples in 1944 couldn't have gotten superb advice to acquire only masterpieces like #2 and #3.

I have heard about the proposed change in ownership of the Dorotheum. Of course to me you personally represent the Dorotheum and I wouldn't want to have much to do with it if your involvement does not continue. Please let me know.

Did my four works which Clovis sent you in July arrive safely?

When next I purchase anything at the Dorotheum please do not again involve Panalpina. As you will see from the enclosed, they began by charging 6,550 EUR, C.O.D., for the shipment of the Berckheyde. That mistake led to their having to put it through US Customs in Chicago and my having to pay \$695.21. My letter to Ms. Susis will be self-explanatory. Clearly, Panalpina did not keep their promise: incompetence compounded by their not keeping their word.

The painting which I received from the Dorotheum before, that lovely little portrait of a young man in a fur cap, came via Mailboxes and that shipment was handled very well and was very inexpensive.



As you will see from Chapters 17 and 18 of the enclosed, I really enjoy collecting old master paintings and buy quite a few in Europe, then have them shipped to Milwaukee.

I never received a shipment as complicated and costly as the shipment with which you helped me in such a kind manner. For that please accept my sincere thanks.

The problem started with Panalpina in Vienna. As you will see on the enclosed, they alleged that I have to pay Eur. 6,550, which is ATS 90,129.97 rather than the correct sum which is ATS 6,550, or approximately \$440.00. I had a long conversation with Mrs. Kraushofer in Vienna on July 13th and I faxed her the agreement which she and I had reached. That agreement, copy enclosed, was that Panalpina Illinois would deliver the package at no charge and as soon as it was received I would wire transfer Panalpina Vienna \$440.00, the equivalent of ATS 6.550.

I was still in England when the shipment arrived in Milwaukee and so \bar{I} asked my son, Daniel Bader, to pick up the painting, which he did.

The invoice, copy enclosed, asked for a C.O.D. charge of \$771.85 but for some reason Daniel was told that that invoice was in error and that he only had to pay \$695.21 which he did.

But of course, according to our agreement, we should have had to pay nothing on this end and only wire transfer \$440.00 and surely you will agree that I am owed the difference between \$695.21 and \$440.00.
