

Dear Mr. Walker.

With your letter of 18 January you sent me good transparencies of two paintings. After I informed you that the proposed attributions at first sight did not seem convincing, you asked me to have a closer look and to report to you. So I did and now conclude as follows:

1. Bust of a man wearing a hat looking at the beholder, attributed to Ferdinand Bol. The picture does not at all fit into Bol's ocuvre, as reconstructed in my book on Bol of 1982. I am reminded of Isaack Luttichuys (1616 - 1683), but the picture is not on the same level of quality as this master's ascertained works. "Manner of Isaac Luttlichuys" would seem to be an appropriate designation.

2. Head of a smiling young man wearing a red bergt, attributed to Samuel van Hoogstraten. The piece has many features that resemble Van Hoogstraten's oeuvre a lot indeed. The woolly execution of most details makes me however wonder if it can be autograph or may have suffered too much. The designation "attributed to Samuel van Hoogstraten" seems to me best fitting. It may well be of interest to have a look in vol. If of Werner Sumowski, Gemälde der Rembrandt-Schüler, Landau Pfalz, 1986, which can be found in most art historical libraries. Plates 843 - 857 illustrate comparable portraits of young men that Prof. Sumowksi all assigns to Van Hoogstraten. So it might be interesting to send him a photograph and ask his opinion too. He is rather old, but as far as I know he still lives at his old address Hessenwiesenstrasse 4, 70565, Stuttgart-Rohr, Germany. In the monograph by Michiel Roscam Abbing on Van Hoogstraten of 1993 some of these works that Sumowski accepted are not included. I do not have the address of Roscam Abbing in my files but can find out in case you would decide to approach him too.

I do hope that these notes may be of some interest to you.




Dear Alfred,

Albert Blankert's attribution of William Walker's "Head of a Young Man" turns out to be an uncommitted approval of an existing viewpoint, with deference to Sumowski and Michiel Roscam Abbing. Of course, none of the portraits of young men cited in Sumowski relate to this painting; furthermore, besides the two that are signed and dated, few of those are convincing as Hoogstraten. However, I don't think we need to hold our breath until Johnny and William Walker turn around and offer the painting at a Horst price.

Thank you for faxing me Albert Blankert's comments about Walker's painting. I understood that Blankert has firmly attributed this painting to Hoogstraten but of course all that Blankert does in this letter is to point to Sumowski's attributions of somewhat similar paintings, some of which are by Hoogstraten and some of which are not. Knowing you I do not think for a moment that you would sell this painting as definitely by Hoogstraten. This does not change the fact that it is a good portrait which David de Witt, the Bader Curator at Queen's, believes to be by Horst and so not worth £ 50,000.

Dear Alfred,

Yes, it is indeed a long time ago that we wrote. I saw in my files that it is exactly two years ago! So first of all, I wish that this letter sees you and Isabel both in good health and fortune.

It is certainly a long time ago that there was an interesting 'Bader'-picture on the market. As recently as March on the TEFAF at Maastricht I was amazed by the lack of those. There only Johnny Van Haeften had a nice 'Bader' subject: the beautiful *Arrival of Rebecca* (1655) by Eeckhout that the Mauritshuis sold to pay for their Rubens portraits...: an exchange I do not suppose Alfred Bader would have made (although the portraits are really magnificent and a welcome addition) But than you already have three Eeckhouts.

07-01. This is indeed a very fine self-portrait, a beautiful addition to your collection 07-02. I do not see this as a Samuel van Hoogstraten, I'm afraid. If at all it should be a very early one, but even in his younger days he treated the hair e.g. totally different. And about Horst I have to bow to David, as he knows infinitely more about this artist than I do.

07-03 The same goes of course for this Rembrandt: I leave that completely in the capable hands of Michiel.

07-04 I showed the landscape to Marijke, who reiterated that she sticks (a bit more than tentatively) to her attribution to Adriaen van Eemont. I unearthed the photograph and after seeing only a corner of it she already exclaimed 'Eemont'! And who, frankly, are we to question Mrs. Landscape where landscapes are concerned? 07-05 is indeed a surprise and certainly by B.G. Cuyp! The iconography derives ultimately from Antonio.Tempesta, which together with Lucas van Leyden's 1512 (B.19) print and Rembrandt's etching of 1634 (B.39) are the three seminal images for almost all Joseph-and-Mrs. Potiphar's since 1500. The emphasis on the lush bed must indeed derive from Rembrandt. Joseph's anguish, so well captured by Rembrandt, is never to be seen in any rendering of the subject by any other artist. And also Cuyp fell back on the stage setting-like pose encountered by Tempesta. I am very happy to add this picture to me already great collection of this subject!

Hopefully we will have more letters to write in the future, which would mean that you have to buy more Dutch 17th century art! With best wishes, from all of us, to you and Isabel,
