



My dear friends,

This is the first time that my son Daniel and I are being honored together and naturally this gives me a great deal of pleasure.

But of course I am mindful of the advice that I gave my Sunday school students at Temple Emanuel every second year when we were studying the Books of the prophets. It gave me immense pleasure to shake hands with 18 of these students this evening! Jeremiah in Chapter 9 put it so clearly, "Let not the wise man glory in his wisdom, neither let the mighty man glory in his might, let not the rich man glory in his riches: But let him that glorieth glory in this, that he understandeth and knoweth me..."

Knowing and understanding means knowing and keeping the commandments.

There are some rabbis who say that each of the 613 commandments is equally important, but I find this hard to believe. To me, among the most important commandments, next to the Ten Commandments are the commandments Justice, Justice You Shall Seek and You Shall Not Stand Idly By the Blood of Your Neighbor.

And another of the important commandments is one which I say twice a day:

Veshinantom Levonecho. You shall teach your children, and I am truly happy to know that I have taught my sons, and they have learned.

Recently I read a wonderful speech given by Professor Yehudah Bauer, the Director of Holocaust Studies at the Yad Vashem in Jerusalem. In that speech given in January 1998 to the German Parliament, Professor Bauer outlined most cogently how it could happen that in the center of European culture, in Germany, Nazis could grab and retain power for twelve years and plan for the final solution to kill every Jew. Just the day before yesterday the German Pope Boruch XVI visited Auschwitz and, speaking in Italian (so as not to offend the Poles), explained that the Holocaust was the Nazi effort to banish belief in God. The Pope's speech last Sunday



was, I think, very much guided by Professor Bauer's speech. Professor Bauer ended this great speech by saying that perhaps we should add to the Ten Commandments three more.

- 1. That neither you nor your children nor your children's children should ever become perpetrators.
- 2. That neither you nor your children nor your children's children should ever become victims; and
- 3. That neither you nor your children nor your children's children should ever stand by passively during mass murders.

And yet since the Holocaust we have seen mass murders in Bosnia, in Rwanda and now in Darfur and right here in Milwaukee there is such poverty. My sons and I are trying as much as we can never to stand by idly. The keys in Milwaukee are education and employment. You know how much the Helen Bader Foundation is trying to help education, Jewish education and in the inner city. And the first buildings Aldrich bought were at 29<sup>th</sup> and 30<sup>th</sup> and Meinecke, so that we would find it easier to employ African Americans. And it gives Isabel and me a great deal of pleasure to attend the annual Aldrich award dinner and to note that about half the employees attending are people of color.

But is not standing by idly enough?

I am reminded of what Martin Buber in his *Tales of the Hasidim* calls the Query of Queries asked by Rabbi Zusya of Hanipol shortly before his death in 1800. Rabbi Zusya said, "When I come before the Heavenly Judge, He will not ask me, Zusya, why were you not as great as Moses, our teacher. He will only ask me, Zusya, why were you not as great as you, Zusya, could have been?"

When I come before the Dajan Emes I will not be asked, Alfred Bader, why were you not as great a chemist as you could have been? Why were you not as great an art dealer as you could



have been? I will be asked, as I ask myself many times, and not only on Yom Kippur, why were you not as good a husband, why were you not as good a father as you could have been?

Now when my son Daniel comes before the Heavenly Judge, I hope many years from now, he will not be asked why were you not as great a President of the Helen Bader Foundation as you could have been? Why were you not as good a husband, a father, a son, as you could have been? because I am convinced that my son Daniel is truly as good as he can be.

I cannot close this talk without mentioning Marvin Klitsner, the ablest lawyer I ever knew and my best friend. Our success in life would not have been possible without him. #### Alfred and Daniel Bader - AJC Centennial Award

By way of introduction, I would like to mention that it is quite fitting to honor Dr. Bader on the eve of *Shavuot* – the holiday commemorating the receipt of the *Torah* (the Bible). Many of you must know that Alfred's main passions – his "ABC's" – are Art, Bible and Chemistry. I don't Know as much as Alfred does about Art or about *Chemistry*. I know that Alfred is very knowledgeable about the Bible… he was my mother's Sunday School teacher and she still remembers his dramatic lessons. But I also received a thorough Jewish education and know a thing or two about the Bible and I would like to address Alfred from that point of view.

The Bible is a wide-ranging compilation of laws and stories in light of which we lead our lives. Is it possible to reduce the Torah to a single principle? I think our Rabbis may have tried to do this when they chose the book of Ruth to be read on Shavuot. The book of Ruth is all about *Chesed* (loving kindness) that extends beyond our immediate circles. It is about doing for others with a sense of duty without any expectation for reward. This is what I have learned to be Alfred's Torah, and I am happy to share with you some of the projects of *Chesed* that Alfred has helped me take part in.

First was my involvement in the Middle East Children's Association (MECA), a joint Israeli – Palestinian organization that I founded in 1996 and co-directed up until eight months ago. MECA is based on the premise that any peace in the Middle East can only be sustained if there is a significant investment in education. Parenthetically I will mention that my belief in the power of education to change lives is something I inherited from my grandfather, Marvin Klitsner, who together Rabbi David Shapiro and Alfred established the Hillel Academy here in Milwaukee and who collaborated with Alfred on numerous educational projects.

MECA works with throughout Israel and the Palestinian Authority exploring how to better help the young generations cope with the complex reality in which they are brought up. The organization, which is now a decade old, has managed to bring together several hundred Israeli and Palestinian teachers. These educators all share a similar challenge: They committed to instilling in their students the values of tolerance and understanding and at the same time wish to protect these children from the violence and conflict amid which they are being brought up. These teachers not only share their concerns but also work on developing curricula that they use in their respective classrooms.

I am proud to say that today, as the political Israeli and Palestinian leaderships state the there are great rifts between them, MECA is one of the very few organizations that continues to succeed in bringing people together with a common goal. This, in my eyes, represents a ray of hope for the future.

Alfred in particular, as well as his two sons Daniel and David, showed great interest and support from the outset. Alfred's support has been crucial especially as the political situation deteriorated and took with it support and



belief in the possibility for cooperation. I am attaching a note from MECA's Palestinian co-director which I believe speaks for itself.

Ironically, one thing that I am particularly grateful for is Alfred's relentless insistence that I conclude my law degree. This subsequently resulted in my resigning from my position as MECA co-director (although I remain as an active board member) in order to begin my full time internship at a law firm - a one year commitment required of every Israeli law school graduate before being admitted to the Israel Bar Association. Stepping back has allowed me to watch the organization grow and to witness the great dedication of those who are involved who continue to collaborate on qualitative educational endeavors.

If I thought that this might be enough to keep me occupied, several years ago, Alfred and Isabel approached me and suggested that I assist them with one of "their most difficult tasks" – as Alfred put it – namely "giving away money wisely in Israel". I was probably not worthy of the request, but picking up Alfred and Isabel's challenge, gave me an unbelievable opportunity to look into how I may play the role of a strategic funder – something that I learned about to a large extent from discussions with Daniel.

According to Alfred, who cares deeply about Israel, one of the Jewish State's biggest problems is how we dealt unfairly with the Arab Israeli population. He suggested in his modest way, that I fix this.

The problem does not lend itself to a quick fix, but here is how I, with Alfred and Isabel's help am trying to make my modest contribution. I felt that the best way to address Arab – Jewish relations was to invest heavily in an area in such a way that would enable me to impact and ensure equality and open dialogue. I chose to do this by investing in the public libraries in Israel.

Public libraries in Israel are, for the most part, not very well developed and have not realized their potential as community resources. Especially today with the growing poverty in Israel such public services could be utilized much more than they have been. Public libraries in the Arab sector are in an even worse state, than the Jewish ones.

The idea was to address a need common to all Israeli citizens in a way that would invite participation across ethnic lines and present an opportunity to redress some of the inherent inequalities. Israeli public libraries were up until now so neglected that they offered the opportunity to build from the bottom up and infrastructure that would treat Jews and Arabs equally and provide a model for cooperation in other areas.

Over several years a series of small grants were given to Jewish and Arab libraries in order to carry out projects that would reach out to their communities. Such projects would include, for example, working with single mothers and their children in the library, using the library as a place to rehabilitate at risk youth, or a communal resource for investing in early childhood. Each grant was within itself relatively small but had a huge impact



on the community. Librarians said it was what they needed in order to do something special in their library, which shed light on the library and had a ripple effect on the community. For example children were encouraged to write histories of their villages, which required very little money, but was an impetus for community discussions and intergenerational dialogue. Furthermore, when librarians from two communities — one Jewish and one Arab both execute such a project the overlap and lessons learned bring in another dimension of communication between the two communities that would normally not have existed. This is another lesson I learned from Alfred, to look for ways to where a relatively small investment can have a far ranging impact.

The overall strategy has several layers.

First, the librarians are empowered to work with their own community.

Second, the Jewish and Arab librarians work together as professionals, and raise social issues of awareness, which could be then be disseminated through their libraries. One of the conditions of funding is that all recipients participate in monthly meetings to share ideas and discuss some of the more sensitive issues that Israel, as a multicultural society has. Librarians who would never come into contact, such as orthodox Jews and religious Muslims find themselves working side by side on the same projects with common goals.

Third, all aspects of the project were done in cooperation with the Ministry of Education which enabled me to leverage the grants by being in a position to demand supplemental State funding. In particular I will mention that this led to establishing several new libraries for the Arab population in Mukeble, Haifa (which to date did not have such an institution) and in several Bedouin villages. The Bedouin project was so successful that we are currently in the midst of negotiations with the Ministry of Education for them to open for the first time such a library in each Bedouin Village. The project, which is actually a conglomerate of over 35-40 smaller grants, has undoubtedly raised the role of public libraries in Israel in general, and has spearheaded this progress with a model of Arab-Jewish cooperation.

Another side benefit was that I have had the great privilege to pool some of my own family funds for similar projects and involve my siblings in this area as a joint community investment in memory of our late grandfather. This is a partnership, which brings a lot of satisfaction to us and I believe to Alfred and Isabel as well. We are now in a situation where there is more awareness towards the need to invest in libraries here and especially in the Arab sector and are now helping the libraries look to new sources of funding for their growing work.

And this brings me to a more personal note. Alfred - besides the great support and opportunities which you gave me that enable me to be a partner in creating cutting edge change here in Israel, we both share a sincere feeling of love and respect for my grandfather, Marvin Klitsner, and both miss him



dearly. Not that there are a lack of people anywhere that miss him, yet there is a special link that you had that makes it extra special for me to have you share in my projects, and I have a sneaking suspicion that this is also one reason why you are so eager to have me share yours. My grandfather instilled within me a deep commitment to help the community. Communal investment - here in Israel and the Milwaukee Jewish Community - was a significant part of Marvin Klitsner's life. I know that his involvement in the establishment of the Helen Bader Foundation was one of his most satisfying accomplishments (and there were many) and I cannot relate to Alfred or Daniel without remembering this special link.

Alfred, you and my grandfather shared so many ventures – business and philanthropic. An occasion such as this is a reminder to me as to how lucky I am to have benefited and learned from this partnership. Sometimes when I would complain to my grandfather about the difficulties of engaging in community work, he would remind me that I should always appreciate that I am in position where I can give and that it is easier to be a giver than a recipient. The sense of duty is something in my genes. From you Alfred, I have learned to compliment this sense of duty with a feeling of tremendous responsibility to give wisely and carefully knowing that our G-d given gifts must not be squandered.

Congratulations on your well deserved honor.

#### THE JEWISH CEMETERY IN NISH

The today's Jewish cemetery in Nish is the third one in this town. The first was situated in the town's center where the Jewish ghetto skirted it. The Second Jewish cemetery was near St. Panthaleimon's Church.

The remnants of the Jewish cemetery today are in the city section called the Stock Square, prevalently settled by Gypsies. The Jewish cemetery dates back to 17<sup>th</sup> century. It could, however, be even older. Among the other tomb markers there is also the memorial tablet of the famous rabbi Rahamim Naftali Gedalia. A great number of Jews from Nish, but also from the neighboring towns were buried at this cemetery. There are records stating that also the Prokuplje Jews, whose community was small and, therefore, had no cemetery or synagogue of its own, were taken to the Nish cemetery for interment.

The monuments at the today's Jewish cemetery of Nish are sarcophagus shaped and are laid out in diagonal long rows one sarcophagus next to the other on a surface of thirty-two hundred square meters. A pertinent remark would be that the Association of Jewish Communities of Yugoslavia bequeathed 50 hundred square meters of the cemetery's unused surface to the township of Nish in the fifties of the past century. All memorial tablets are engraved with long Hebrew texts. A smaller number bear Hebrew inscriptions done in plastic lettering. A small number of tablets are also inscribed with the Serbian translation of the Hebrew text. These date back to 1913, 1915, 1935 and 1936, while the other much older inscriptions that surely date back to 19th century bear neither a date nor the Serbian translation. There is little ornamentation on the monuments. A few hemispheres of smaller size, placed in groups of four, embellish each corner of the tablet. The Jewish Scriptures existed once. Rabbi Abraham Daniti wrote in 1939 that some Jews demonstrated such zeal and haste at "burying" information, notebooks, and books that the Jewish Association of Nish was left without any important piece of information except for some notebooks that were kept when first the Association was formed.

NISH: THE JEWISH CEMETERY BEFORE

Burials were performed at this cemetery until the beginning of WWII. In 1948 the cemetery was expropriated. In 1965 the Assembly of the County of Nish prohibits burials at the Jewish Cemetery. In the following years many Jewish families had disinterred their dead to take them and bury them at the Jewish Cemetery of Belgrade. The Jewish Cemetery in Nish today cannot be seen, examined, or photographed. It is overgrown by grass, reeds and covered by tons of debris, excrement and rubbish. The memorial stone tablets are overgrown by grass and weeds. The brush is some two meters high. The way it looks, the cemetery has become the sore spot of the town. Many Gypsy homes have memorial slabs from this cemetery for foundation, while other tablets make the inventory of the homes' interior. Additional uses of the memorial slabs were to pave the passages between the homes, to cover the sod in the sties of this Gypsy settlement, to panel the walls of the underground sewers. On top of all this space there are tons of trash, so that calling the Jewish Cemetery of today huge garbage disposal is no misnomer.

With the exception of some twenty tablets on the eastern side of the cemetery, the other memorial stones cannot be seen and all are greatly damaged, that is, broken, displaced and ruined. There is also a chapel at this cemetery. According to the title documents it belongs to the Jewish Community of Nish. In front of the chapel is the rabbi's grave. Inside the chapel seven members of a Gypsy family have domicile.

One should also say that one part of the Jewish Cemetery on its north-west side has been usurped by firms "Metalac" and "Niplast" before and by "Tehnomarket" today, while on the eastern side is the commercial firm "Otpad" from Zrenjanin. Also these firms have covered the cemetery with tons of waste materials, making it impossible to see or examine the gravesites. The Gypsy settlement is also on the cemetery's east side.

Just before WWII 360 Jews lived in Nish. During the war 1100 were killed. The war has claimed all Jews of Nish. Their graves are not marked. Entire families were killed. No relatives survived so that nobody remembers them. In Nish there is no memorial plaque to inform about their suffering, about the doom that befell our neighbors who no longer live.



In April the Jewish Community of Nish submitted their request that the Cemetery be moved to another location to the Department for City Planning in Nish.

On April 27, the Jewish Cemetery was burned down. It was newly covered with human waste and garbage. Two graves were dug up and the bones were scattered around. The incident was reported to the police, who investigated the case, but the culprit remained at large, most probably.

This December 2003 the story of the Jewish Cemetery is finished. There is no longer a Jewish Cemetery in Nish. It has been razed and buried under tons of garbage and waste. "Tehnomarket" built illegally a wall, 50-70 m long and 3-4m high all along the side of the cemetery. Tons of garbage are thrown over the wall. Where the Gypsy settlement is, fences were built around the homes, so that neither from that side is the cemetery accessible.

During summer 2004 the cemetery was roughly cleansed with the help of JDC and support of private donation od Dr.Alfred Bader .Trees were cut, bushes were taken away and 200 tones of rubbish was transported away. A huge part of cemetery was delineated from the Roma settlement. The sewage system was made in a proper way. By cleansing the cemetery, 1015 tombs + 150 fragments were discovered. A part of cemetery which is situated in a Roma settlement is cut off by fence and it is impossible to approach the site.

The works concerning the cleaning and arrangement of the Jewish cemetery in Nis are almost finished. JDC responded to our appels to help rehabilitate this cemetery and Dr.Alfred Bader support private donation for everytning.

I wont to tell to Dr. Alfred Bader, thank you for everything what you do with Jewish cemetery in my small town and small Jewish Community in Srbija.


By approving us a loan for buying new printing machines that are necessary for us to survive on market. That loan is fulfilled his purpose, and we already see benefits.
