Also, I thought I'd tell you about my weekend. We started out last Friday at the National Gallery in London. This day had one of the greatest effects on me of nearly any other day of my life. I have always tryed to appreciate and develope a taste for art, especially painting. It is very hard to come to love art from examining it in texbooks. As well it should! To be able to come to love art from merely seeing it in a textbook downplays the value of the real thing. I know this now. No matter how much one thinks he likes a piece of art he has seen a copy of, the feeling that overcomes you when you see the real thing is unbelievable. For me, seeing Titian's work "Bachus and Ariadne" was just such an experience. I cannot over estimate the value of oversea's study to someone interested in art. I now believe it is simply a necessity.

Saturday was not quite as eye-opening a day, but still wonderful. We journyed to Stratford-Upon-Avon. The entire city is centered around it's most famous personage: William Shakespeare. It was a very quaint town with many gifts shops for tourists, yet not over commercialized at all. The Mower monument to Shakespeare was a tribute to this spirit. A giant statue of the man himself surrounded by four of his most famous characters including the legendary statue of Hamlet gazing at Yorick's skull. It was also interesting because one could sit and gaze at this monument while drinking either a draft beer or glass of wine. Such beverages are not illegal to carry around in Stratford.

The river Avon was also nice to get to see, even if for nothing more than to say one saw it. Although the river boats that take you down the river while dinning were not running, I hope to get the chance to go back to

the city and do this.

The very same river ran along another place we went on this day, Warwick Castle. Warwick Castle is a fully fortified, fairly well preserved, medieval castle. This place was complete with everything from five foot thick walls to dungeons and torture chambers. The torture chambers were, as opposed to those in the Dells and Disney Land, truly moving. To see and read about a place where people were horrifically molested on the very ground you stand is not to be underestimated in its effect. One's feelings for how far humanity has come is dramatically experienced by one's utter repulsion to the scene.

Sunday ended the weekend with a visit to Oxford. Once again, a truly historic town. The University of Oxford is like no other University in our country. They measure time exactly from Greenwich.), they are true bearers of excellence.

We were even luckier than the average tourist to have our sojourn guided by a professor from Oxford also teaching here at Herstmonceux Castle. He gave us both a bus tour around, and a walking tour. What was timeless about this tour was this professor, John Dowling. This man showed us around the campus with wild stories about the "never to be forgoten" Oscar Wilde and the likes of others who have attended Oxford. Prof. Dowling is such a passionate man that many times durring his intimate stories he actually

broke down crying! While telling us about the largest tower of Oxford, which reminds him he is once again home, he had to stop talking and wipe a tear from his eye. He was the perfect man to show us around such a place where extremes are the rule. One could not have a more woderful weekend. At least I don't think so.







Dear Dr. Bader:

I am writing to you on behalf of myself and Jodi Rossman, and with regards to the International Study Centre (ISC) at Herstmonceux Castle -- which you generously donated to Queen's University and of which you continue to be a great supporter and benefactor. Specifically, this letter concerns a proposal which Jodi and I made to the ISC administrators regarding the making of a student-promotional video.


First, allow me to introduce ourselves to you. I am twenty-one years old, and am a third year student at Carleton University, majoring in Political Science with a minor in Film Studies. I have been on the Dean's List for the past two years, and have received the R.A. Mackay Award for excellence in Political Science for the past two years. As well, I am the current recipient of the Claude Bissell Academic Excellence Scholarship. In terms of video experience, I have owned and operated a video production company, "Nathanson Video", for the past seven years. Through that company, I have performed or supervised the filming, editing and production of hundreds of videos of Bar-Mitzvahs, weddings, birthday parties, reunions, company meetings, speeches, Ottawa Va'ad Ha'ir conferences, and other such special events. While in high school, I was awarded a Rogers Television film-makers excellence award for a video I produced which dealt with homeless persons in Ottawa. Furthermore, I served as the creative advisor for a promotional video commissioned by the EXPO 2005 Corporation, and the executive producer for a promotional video for Camp Gesher (a Zionistoriented Jewish summer camp). This past summer, I was the video-program director at Camp Massad, a Hebrew-speaking summer camp located in Quebec, where I taught over 150 children the basics of video filming, editing, and post-production. As well, following my summer at Camp Massad, I produced the camp's promotional video which was distributed throughout North America. Recently, I was in charge of the production of a promotional video for Hillel Academy, the Jewish day school in Ottawa, which highlighted the school's new Judaic studies program.



Jodi Rossman is also twenty-one years old and is a third year student at Queen's University, in the Faculty of Concurrent Education. Jodi is an Honours Student who recently received the Allan R. Taylor Excellence Scholarship. That scholarship allowed Jodi to study at the ISC at Herstmonceux Castle, which she did during the first term of this scholastic year. It was at the Castle where Jodi had the honour of meeting you and speaking with you. Before departing for the Castle, Jodi was one of the founding members of the student-led "Save the Castle Committee" which organized awareness and fundraising events on behalf of the ISC, to insure its survival. When Jodi returned from the ISC, she expressed to me how her semester spent at Herstmonceux had literally been, "the time of her life." She had enjoyed the Castle so much and had so greatly benefited from her experiences at the Castle that she wanted to give some back to Herstmonceux and wished to help promote the Castle and convince others to participate in the ISC program. It was this desire to help advance the ISC and promote all of its values, which led Jodi (who has served as the creative and artistic director for most of my video projects) to approach me with the idea of taking a video camera to the Castle and putting together a simple, but effective, "Castle Promotional Video".

Jodi informed me that unfortunately Queen's was having somewhat of a difficult time recruiting students to the ISC and that she felt a promotional video would help alleviate that problem. I was quite surprised to learn that the ISC did not have a promotional video and relied almost exclusively on pamphlets, posters, and other written material to advertise the Castle. Immediately, Jodi and I realized the incredible benefits which a Castle Video could provide to Queen's University, and how easy it would be to take a video camera to the Castle and make such a video. From my years of experience in the video business, I knew that a Castle video would be a relatively inexpensive, yet extremely effective advertising and promotional tool. I have witnessed, time and time again, how videos affect and influence people in a way which printed material simply cannot. I have seen how people are attracted to and drawn towards a video and how people are more inclined to watch a short promotional video, especially a student-made video, than to read a pamphlet or a brochure. More importantly, after viewing Jodi's pictures and hearing her stories, I was convinced that the Castle and the programs which it offers are perfectly suited for a video. The beauty and majesty of the Castle's surroundings, the modern and complete facilities which it houses, the academic environment which it creates, the diverse people which it attracts, and the memorable experiences with which it leaves students, are all ideally portrayed by a video.

With all this in mind, and wanting to help Jodi contribute to the Castle, I contacted the staff at the Queen's ISC office in order to discuss the possibility of producing a basic promotional video for the Castle. I was met with initial enthusiasm and was asked to submit a preliminary proposal. I detailed to the staff that I had already given some thought to the content and style of a Castle promotional video and would be prepared to meet with them to discuss exactly what they would like to see contained in such a video. I explained that the video (which would probably range from about 5 to 15 minutes) would be a 'standard type' video (we had decided that a 'high-end' video, full of special effects, was simply too expensive and unnecessary for this situation) filmed on a High-8 home video camera. My proposal stated that the video would consist of beginning and end titles (identifying what the video is about and how to get more information, etc.); shots of the Castle its European location, exquisite surroundings, fully-equipped facilities and classrooms, numerous student activities




and outings, spacious accommodations, etc., narrative voice-overs (when possible/necessary/desired), interviews with people associated with the Castle to explain its history and its beginnings, with students from various backgrounds and world locations, and with faculty- all of whom could give a first-hard account of the benefits of the Castle and the great experiences which the Castle provides, and overlaid music to complement the visual shots (when possible/necessary/desired). I explained that I would film the video, with Jodi as my on-location assistant (Jodi's knowledge of the area and the Castle would be invaluable to me), over a one to two week period, some time in the summer, and that it would be ready before the 1997-98 scholastic year began. The student-made video would be concise, simple, and of a high quality.

Finally, my proposal outlined the costs which would be associated with such a venture. Noting that I was definitely not approaching this project as a business venture from which I could make great profits, I explained that the tentative pricing figures which I had estimated consisted almost entirely of costs which Jodi and I would incur in making the video. The tentative price which I established for the filming, editing, and post-production of a Castle video was between \$3,000-\$3,750 (Canadian funds). This price includes the cost of airfare for two to England, the cost of transportation to and from London to the Castle, and the cost of purchasing material and supplies (which will include 10 metal hi-8 video cassettes and a professional quality VHS cassette- all of which become the property of Queen's following the filming,) and renting some other necessary video equipment.

The ISC staff considered the proposal, and though they agreed that the idea of a promotional video was a worthwhile one and one which they had been considering for quite some time, they decided that it was not a project which they were ready to invest in at the current time, mainly due to budgetary considerations. Jodi and I viewed this decision as extremely unfortunate and regrettable. We knew that a Castle Video would be a great asset to the ISC and could help convince students from all over the world to participate in the program. As well, I did not view the price as being overly-high and realized that once one student signs up for the Castle program because of the video, Queen's instantly begins to recover its initial investment. A video can be easily and inexpensively duplicated and sent to various locations for many people to see, and is a superb way of advertising the Castle and promoting it to prospective candidates.


Upon hearing the unfavorable news, Jodi and I remained committed to the idea, and began to consider alternative means of bringing about and financing such a project. We knew that we could not afford to travel to Europe and make the video by ourselves, but that we still wanted to pursue the idea and felt that it could be a very worthwhile project, and one which would not be extremely difficult to carry out. It is for this reason that I am writing to you, Dr. Bader. I wish to know if you have any suggestions or advice for how such a project could be realized and financed, or any ideas to share with us on how we should proceed. This project means a lot to both Jodi and myself and we do not want to simply abandon the idea. We thought that because of your affiliation and experience with the Castle, and with Queen's, you might be able to assist us in helping benefit the ISC. We hope that you share in our views concerning the value of such a video and that you might have some advice which would be beneficial to us.

Two of my colleagues, Dr. Mary Ann McColl and Dr. Will Boyce would bring particular strengths. Dr. McColl is currently involved with colleagues from other disciplines in investigating the role of spirituality in disablement and community independence following disablement. Dr. Boyce has been involved in many projects that have included needs assessment and program evaluation. We also propose to include someone with interest and experience in aboriginal matters.

At this stage, I believe it would be helpful for us to meet with you and perhaps appropriate people in the Native Mental Health Unit to gain a better understanding of the proposed project. We could also explore the possibilities for developing a proposal. Would this be attractive to you? If so, we might make a day trip to Montreal early in the new year.

I look forward to hearing from you. Please feel free to call me if you would like to talk further about this.


