The observatory at Herstmonceux

Re: A Castle Fit for Queen's, (Mar.-Apr. pg.12)

How wonderful to read of the marvelous gift to Queen's from Isabel and Alfred Bader! Just to read about the beginning Alfred had at Queen's is almost like a fairy tale in itself, so his gift is very much in keeping with his life. The plans for future use of the castle sound very interesting.

Just after reading about Herstmoneux in the Review, I read an article in the February issue of In Britain magazine about Greenwich, the town in England which is the centre of world time. One paragraph from that article was most fascinating, in light of the news about Herstmonceux castle. It read, "In the 1920s the work (from Greenwich) was moved to Surrey and later a new home for the Observatory was created at Herstmonceux Castle in Sussex."

Is this Observatory still being used, and is it possible to visit it?

(Unfortunately, the telescopes at Herstmonccux are no longer in use. The Royal Greenwich Observatory moved there in 1948, and during the next 41 years, a total of seven telescope observatories were built, as well as an administrative complex. In 1989, however, the Observatory moved to the Canary Islands. The vacant telescope domes and offices are still at Herstmonceux, of course, and while visitors can visit, those who have done so report there's not much to see note.—Ed.)

The World War II history of Herstmonceux Castle

What a thrill to me personally that a Queen's man — Alfred Bader, and his wife Isabel — have made the University the owner of Herstmonceux Castle.

This most notable property is very dear to me. When Field Marshal Bernard ("Monty") Montgomery went to Africa to subdue (which he did) Rommel, I succeeded him as Commander of the Defences of South East England. I made my operational headquarters in Herstmonceux Castle.

The castle dominated the Nazi-held

shore of Normandy from Cherbourg, Le Havre, Dieppe, St. Valery, Calais, which could have served as a base from which to launch an attack on Britain. My marine and air force resources were disposed from the Isle of Wight to Sussex and Kent.

Seeing the cover of the Review (Mar.-Apr.) was a thrill to me of the most exciting magnitude. I cannot properly thank all concerned for: a) the idea, b) the beauty, and c) my personal thrill.

Castle memories recalled

The Review's March-April cover story on Herstmonceux elicited a response from several readers who wrote to share personal memories of the castle. Among them was John Dalton of Kingston, the father of Sarah Dalton, Arts'88, and Peter Dalton, Arts'92, John sent along this photo of Sarah and Peter on a 1978 visit to Herstmonceux. The Daltons were visiting relatives in the village of Herstmonceux when they decided to visit the castle. "It's what you'd picture a castle to be," says Sarah. "The surroundings are beautiful, and on a clear day you can see the English Channel in the distance (For more on the castle, please see our July-Aug. issue, which will feature a selection of color photos by Kingston Whig-Standard photographer Jack Chiang.)

Posma's letter berating the need for a human rights director at Queen's. There are many reasons that one might feel such a person isn't needed; some might even be valid. Many times, it takes some ne like frène Bujara to point out our shortcomings so that we may improve We've made great advances since the 1960s. The naming by Queen's of a director of human rights is simply an acknowledgement that we still need to go further.


Mutual respect is the key to improving human values

I enjoyed the letter by R.H. Posma and his comments on race relations, sexual harassment, homophobia, alumni from the 1960s and 1970s, and the fact that their generation treated people with respect as individuals. I'd like to add a few comments regarding the era of the 1940s and 1950s.

I was one of a small number of females accepted into a predominantly male class in Medicine in 1944 - one year after females were fully accepted into Medicine at Queen's. One might think that under the circumstances there'd have been a lot of harassment, and I suppose by today's terms there was. But, I'm not sure who did most of the harassing -- the males or the females.

The difference in our years at college was that we didn't consider it harassment. We considered it as good old-fashioned teasing, good old-fashioned hijinks. It was handed out, accepted, and handed back with humor, good fun, and mutual respect.

We — and I believe I speak for a majority of females of that time — never demanded that the males treat us with



I am writing to express to you my personal excitement over the announcement of your presentation of Herstmonceux Castle to Queen's University. I should perhaps begin by explaining that I am an observational astronomer on the Physics Faculty at Queen's (you may not be aware that we have a full undergraduate and graduate Astrophysics program here), but that my career began with graduate school at the University of Toronto. When I finished my Ph.D. in 1975. I went to Cambridge, England, for a five-year Post-Doctoral Research Fellowship, during which time I had the very good fortune to visit, stay at, and even do some astronomical observing at Herstmonceux Castle on several occasions while it was still the home of the Royal Greenwich Observatory. Consequently, I know the site and its surroundings well; in this respect I may be almost unique at Queen's!

You will understand, then, my enthusiasm for this marvellous gift: there cannot be anyone who has visited Herstmonceux who has failed to be captured by its charms. Indeed, when Dean McLatchie came to my office to tell me of our acquisition, I was momentarily dumbfounded, but quickly recovered to the extent that I was, on that very day, showing my personal slides of the Castle to my large liberal arts Astronomy class and telling them with excitement about it. Subsequently, I wrote Principal David Smith to tell him of my thoughts - and also to encourage the prospect of perhaps preserving the astronomical heritage which the site represents, although clearly any development along those lines will require considerable thought.


What is clear, however, is that your extraordinarily generous bequest has opened any number of possibilities for the University. Subject: Herstmonceux Castle Estate — Status Report

There are several aspects of the Herstmonceux project beyond the plans and budgets that Dr. Yeates will discuss in his report at the Board meeting. This note summarizes the developments to date. In general, the project is proceeding well; although some aspects have taken longer than had been expected, there have been no major difficulties. These are some important parts of the project:

- The "offer to purchase" signed in December is being elaborated into a detailed contract between the University and the bank operating on behalf of the receiver.
- Since we intend to use the Estate for a new purpose, we require formal planning permission from the local district council. Since the Castle itself is a Scheduled Ancient Monument, the process is complex and requires approval from many bodies including Cabinet.
- The buildings—the Castle for the academic program and the West Buildings for accommodating students and conferees—must be renovated for our purposes.
- For legal and tax purposes a formal organization is being established as a charitable trust in England to hold and administer the property.
- An organization is being put together and staff are gradually being taken on to carry out the various tasks required. We are only adding staff members as they are required.
- Administrative policies and procedures are being put in place.
- The grounds have traditionally been open to the public for a fee. With the cooperation of the receiver, we are re-opening this summer.
- A group with experience in running a hands-on science centre is negotiating to use the Equatorial Buildings (the collection of domes, telescopes and workshops) for another such location. Since we have no plans for these buildings (and no budget to make use of them) this seems a good fit.
- The project is attracting a good deal of attention in the media. Various staff members have been involved in getting the news out.

Attached to this note is the Academic Plan that forms the basis of the work on the project. Since some of you are aware of some of the developments mentioned above, I have also attached an appendix giving sufficient detail to convey a relatively complete picture. I am unable to be at the Board meeting (I will be at Herstmonceux) so Heather Ball from my office, can supplement these notes with explanations of any of these matters, or I would be happy to speak with any of you after I return.



Academic Plan

Mission

To enhance Queen's University's role in international education and research.

Academic Goals

 To provide opportunities for undergraduate students to gain a more international education, particularly with respect to Europe and the European Community.

This will be achieved primarily through:

- (a) a "third year (or one term) abroad" that is integrated with regular Fall and Winter semester programmes at Queen's University;
- (b) Spring and Summer courses of more general interest that will also provide academic credits from the University;
- (c) non-credit courses with local and international focus.

The courses offered in the Fall and Winter terms will be clustered into groups of collateral disciplines, and over a three or four year cycle the clusters will include courses in the fine arts, humanities, commerce, education, and the social, physical, biological, life, and applied sciences. Spaces will be available to students from Europe and the rest of the world.

2. To develop internationally-oriented "executive", professional, and special interest courses and programmes.

It is envisaged that these activities will be held during the Spring/Summer period.


3. To provide a venue for focussed conferences and colloquia that will bring together scholars from around the world.

These activities will be interleaved between the regular terms.

4. To enhance the educational and social environment for the local community through increased accessibility, public lectures and seminars, and the provision of facilities for a possible science centre and/or planetarium.

A science centre and/or planetarium will need to be self-funded.

- 5. To establish a base for graduate students and faculty researchers undertaking independent or collaborative work in the United Kingdom and/or Europe.
- 6. To provide a "meeting place" that will promote interaction between students and researchers from Canada with those in Britain and Europe (and the rest of the world).



Detailed Status

Developing a Contract With the Receiver

- This has been a difficult negotiation so that the contract is still in draft form, not yet signed.
- Mr. David Shankland (Lovell White Durrant) and Mrs. Jane Whistler (Associate Director/International Study Centre) will meet with Mr. Justin Salkeld and Mr. Oliver Buckley (of Guinness Mahon and Company Limited) the 1st week of May, 1993 to resolve outstanding points of principle.
- Mrs. Whistler is meeting with Mr. Buckley the 1st week of May, 1993, to continue negotiations on the proposed estimate of running costs for the Estate for 1993, by Guinness Mahon and Company Limited. It is hoped that Queen's University and Guinness Mahon will be able to come to a mutual agreement on the costs by mid-May.
- It is the understanding that Queen's University's contribution toward the running costs and interest payment are due to begin after the 7th June 1993.
- Queen's University has reviewed the insurance policies, and has made arrangements to take on
 the insurance for the centre as soon as the contract to purchase has been signed. We are placing
 the coverage with Bradstock Blunt and Tompson Limited, in the UK.

Obtaining Formal Planning Permissions


- The application for planning approval ("Statement of Intent and Master Plan for Proposed Change of Use") was submitted to the Wealden District Council, February 15, 1993.
- The University expects to receive approval of the application at the meeting of the Council on May 25, 1993.
- There has been an unexpected delay in obtaining the Scheduled Monument Consent by English Heritage. English Heritage has requested fully detailed drawing and specifications before the SMC will be granted. We do not anticipate any delay in the project due to this request, as the detailed drawings were to be developed as the next stage in any case.

Renovations

- An on-site project manager will be on staff by mid-May. Mr. Tom Morrow and I (in Kingston), along with Mrs. Jane Whistler and Mr. Keith Newman (in England) have short-listed the applications and are interviewing candidates May 11 and 12/93.
- The project's team of consultants will be coordinated and hired after the project manager's position has been filled.
- Detailed planning and renovations are scheduled to be completed by September 1994.

Charitable Trust

- The Herstmonceux Estate property will be owned and operated by a charitable foundation. Lovell, White, Durrant are handling the establishment of the foundation.
- The Charitable Trust Board will comprise three members. They will include the Vice-Principal (Resources), and two Queen's Alumni who are residents of the UK.
- Ms. Vanessa Reburn of Lovell, White, Durrant has represented the University in putting together
 the documents. She is submitting a legal application to the Charitable Trust, on behalf of the
 University, the first week of May.



Organizational Structure


- The International Study Centre is included in the portfolio of the Associate to the Vice-Principal (Resources). Ms. Ball and Dr. Barnard provide day-to-day management of the project.
- Mr. Tom Morrow, Executive Assistant to the Vice-Principal (Operations and University Relations), is working on budgets, liaison with consultants, and other aspects of the project.
- A broadly-based committee oversees the academic developments, while a smaller executive committee provides advice on administrative matters. Both are chaired by the Associate to the Vice-Principal (Resources).
- The appointments that have been made to date are: Executive Director (Dr. Maurice Yeates; still working at the Ontario Council on Graduate Studies, and part-time on this project until some time in 1994); Associate Director (Mrs. Jane Whistler); Estate Manager (Mr. Keith Newman).
- Clerical help at the Castle has been hired on a part-time temporary basis.
- Temporary staff, including gatekeepers, groundsmen, housekeepers are being hired on a contract basis
- Serious consideration is being given to outsourcing several services that will need to be provided such as the catering, groundswork, security, and housekeeping.

Financial/Administrative/Personnel Planning

- Mr. Timo Hytonen, Director, Human Resources, is reviewing compensation policies and organizational structures at other institutions in the UK. and advising us accordingly.
- Mr. Tom Thayer, Director, Financial Services, is consulting with Peat Marwick Thorne on various financial, tax, and accounting policies in the UK. Peat Marwick Thorne, will be consulted regularly for advice.
- Mr. Ken Low of Financial Services will be visiting England to set up financial and accounting procedures.
- Advice is being sought from Lovell White Durrant on employment law in the UK.
- Contacts have been established with the University of Brighton and Sussex for advice on planning and structure.

Opening the Grounds to the Public

- The grounds of the castle are being opened to the public beginning May 29th, 1993. This will generate revenue for the project.
- A tearoom on the grounds will be open, and souvenir items will be sold.
- There will be an "Opening to the Public Celebration" scheduled for July 11th. The theme of this day is to welcome the community and the public to the grounds of Herstmonceux. A black-tie dinner will be held the evening of July 10th. Invitees to the dinner will include Queen's Alumni, Dr. and Mrs. Alfred Bader, Mrs. Agnes Benidickson, Dr. and Mrs. David Smith, and local community dignitaries. Dr. and Mrs. Yeates, and Dr. Barnard will attend. The proceeds collected for the festivities will go toward student bursaries.
- Gatekeepers and additional groundspeople will be hired on a contract basis to maintain the premises over the summer months.
- The grounds will be closed to the public some time in September 1993.




Science Observatory-Equatorial Buildings

- A "General Plan for the Proposed Herstmonceux Science Centre" was submitted to Queen's University by Richard Gregory, University of Bristol, and his colleague Mr. Stephen Pizzey, Director of Science Projects (a charitable organization), for consideration April 25, 1993.
- Copies of the draft Lease, draft Agreement for Lease and draft Application and Court Order for the Science Centre have been forwarded to Queen's University from Lovell, White, Durrant, for our consideration.
- Negotiations with respect to details of the proposed Science Centre are proceeding.

Public Relations

- In addition to the local print and broadcast media, stories about Queen's New International Study Centre have appeared in major Canadian daily newspapers including *The Globe and Mail* and the *Toronto Star*, as well as in broadcasts on national radio and television news programs.
- The story has also received wide coverage by newspapers, radio and television programs in the East Sussex area and in the Times, the Financial Times, the Observer, and the Daily Telegraph.
- Illustrated stories have also appeared in: AUCC's University Affairs; the Chronicle of Higher Education; the Bulletin of the Association of Commonwealth Universities; The International Educator; and Ontario's Business published in the United Kingdom.
- The University has commissioned Mr. David A. Calvert of the Royal Greenwich Observatory to
 update his booklet "The History of Herstmonceux Castle" by including an additional chapter on
 the acquisition of Herstmonceux for Queen's University through the generosity of Dr. and Mrs.
 Bader. This booklet will be sold to the public.

Aide Memoire

Dr. Jeffrey Cooper visited us in Milwaukee yesterday and today. We picked him up at O'Hare yesterday afternoon and so we had ample time to discuss Herstmonceux Castle.

He does not know of any obstacles to the acquisition of the castle by Queen's other than the many legal formalities that have to be taken care of.

He agreed that the three options of the agreement of December 11, 1992 are options and nothing else. He agreed, with a broad smile, that Amanda's suggestion that these options should be changed into first refusals or that Queen's should pay the bank part of any profit on the sale of these lots, were just her attempt to do the best for the bank. There are really no grounds for demanding this. He admitted that he had been exceedingly pleasantly surprised that Queen's agreed to pay 75% of the running costs of the castle. He had not thought that Queen's would agree. One of the reasons for Amanda's recent promotion was her ability to negotiate. We last heard from her yesterday evening; today she may have gone to the hospital to have her first child.

I asked Dr. Cooper whether the bank would have any objection to Queen's opening the castle to visitors, and he said, "Certainly not; but Queen's must make sure that this might not interfere with getting planning permission."


Of course, I broached the question whether life would not be very much easier if the bank accepted a straight £4 million and did not have all the option hassle. He told me in some detail that this could not be considered before the end of March because the fiscal year end of the Bank of Yokohama is March 31, and the auditors have agreed that the bank could value the optioned land at the option price! A case of constructive accounting! If the bank now accepted £200,000 they would have to show a loss in this fiscal year of an additional £400,000, and this simply is not practical. He promised to revert to this question when he sees me in May.

He felt that Lord Gowrie could be most helpful in getting the planning permission and other papers signed speedily, and I urged Dr. Cooper to make sure that these efforts are coordinated with Jane Whistler.

All in all, it was a very pleasant meeting, and Dr. Cooper left Milwaukee in very good spirits.

I hope the photo will be of use. We all enjoyed writing up the castle coup because it's all so interesting and off the beaten track of daily news stories.



- 3. Queen's will arrange to buy sterling, but not 6 million pounds at once, but 1 million pounds at a time. You will not purchase the first million pounds until Queen's has received the first U.S.\$1.5 million from Baird.
- Queen's will arrange to invest the sterling at the best rate possible, in such a way that
 the investments will mature close to the closing date.
- 5. Both the earnings accruing in U.S. dollars and in sterling investments should be added to the principal.

Tom Thayer will advise me weekly about the total funds in U.S. dollars and in sterling accruing in these "castle accounts."

Subject: Cost Estimates on the Herstmonceux Property

This report makes three contributions to the debate about the Herstmonceux property:

- 1. It catalogs, summarizes and compares the various sources of information available about the costs of renovating and operating the property.
- 2. It evaluates the various information sources.
- 3. It makes a recommendation on the capital required if the acquisition of the property is to be pursued.

In summary, we conclude that the property will require major expenditure after purchase. and thus recommend that an amount of at least \$9M in addition to the purchase cost will be required to make the project a success. This assumes that a program of use and a business plan derived therefrom can be devised that will generate the annual cash flow required to maintain and operate the property.

This report does not address the issue of use of the property-the academic program and other activities that could be carried on at this site, the cost of mounting these activities, and the degree of conformance these would have with established institutional priorities.



Information Sources

These information sources have been used:

- 1. On October 19, 1992, Principal Smith visited the Herstmonceux site, accompanied by Sam Blyth of Blyth and Company Travel, representatives of the architectural firm MacCormac Jamieson Prichard (MJP), and Jane Whistler (a Queen's alumna). On the basis of this visit, Blyth and Company have discussed an estimate of the renovation costs at a meeting with the ad hoc working group and submitted a written business plan for operating a study centre on the property. The Blyth estimate is based on experience the company has had with other projects in England and on the European continent.
- MJP submitted a written estimate of costs for renovating the West Buildings to Blyth, which he forwarded to Principal Smith. This estimate is based on their experience with other renovation projects.
- Blyth requested another estimate from the firm of Rattee & Kett (the letterhead used for this is from their affiliate Mowlem). This estimate is based on their experience with other historical renovations.
- 4. Alan Broadbent, Vice-Chair of the Queen's University Board of trustees, provided the name of Cobb McCallum, a quantity surveyor in England with whom his firm has done business. Tom Morrow spoke with McCallum, who visited the site and provided a written report. He based his estimate on similar renovation projects and Morrow's description of what Queen's would require rather than working from a specific architectural plan.
- 5. Jane Whistler, anticipating that the estimates from MJP and Mowlem might be for a level of elegance unnecessary in a student residence, asked English Heritage for names of architects in the area of the site who might give another estimate. With the Principal's permission, she commissioned Clive Mercer for this purpose. Their report is an extensive one, certainly the most detailed of all that we have on hand. It is not directly comparable with the others because it anticipates spreading the costs of renovation over several years—it is thus at least a specific payment plan, and possibly also a work plan, for 10 years.
- 6. Tom Morrow generated an estimate of several components of the cost based on comparison with similar activities in Kingston. Renovation costs are estimated by using a per-square-foot amount suggested by the quantity surveyor Hanscomb (based in Ottawa) using a scaling factor quoted as being appropriate for costs in England; the deferred maintenance and long term maintenance costs are based on the report of the Board of Trustees Task Force on Deferred Maintenance; the annual operating costs are based on COU reports on operating costs.



The reports from which the inputs are drawn are not attached here as they are too voluminous, but they are available for consultation.

The attached spreadsheet presents a comparison of the costs presented in the various reports now available to Queen's. The following points should be noted concerning the data as presented in the spreadsheet and the data as presented in the reports themselves.

- Some of the raw figures provided in these various estimates are not directly comparable. For example, some have included the architect's fees and some have not. Morrow has scaled up the non-inclusive estimates. The factor used is 1.4, which is consistent with the scale used by the estimates that do include fees, and also with our own local experience (for example, the Stauffer Library project has a construction cost of \$30M and a total cost of \$42M which is 1.4 times as large as the construction cost).
- Some estimates deal only with the renovation of the West Buildings into student accommodation. We have considered this to be necessary before the property is useful. Some of them also deal with renovations to the Castle itself; some of these would be essential initially (we base this on our reading of the Clive Mercer report) and some of these would provide additional accommodation that is not considered necessary initially.
- There has been no attempt to estimate interest charges on money that would be spent on different schedules in the different estimates. We assume this difference would not be significant at the level of this analysis.
- The various estimators were working under a number of difficulties:
 - the academic program has not been worked out in detail, although there have been some discussions in the working group, so estimators assumed a combination of student residence and conference-like facilities;
 - the time constraints were very tight;
 - architects did not have time to draw detailed plans and quantity surveyors did not have detailed plans from which to work; and
 - they were commissioned by different persons so that, in the absence of a written specification of what we require, they were doubtless working with different conceptions of the finished product.

Evaluation

Concentrating only on the costs for the West Buildings, 1 of the 6 estimates—that from Blyth—is an outlier. The others, though differing in non-trivial ways, are reasonably similar given the difficulties under which the work was completed.

We thus have a high degree of confidence that the amount of money required to renovate the property to make it suitable for use by undergraduate students in reasonable numbers lies in the range of \$9M to \$16M.



There is less information about the operating costs. The Mowlem figure is the outlier in this group of 3. We have some degree of confidence that the costs for direct expenses plus the costs associated with keeping the buildings on a reasonable (30 year) schedule of regular maintenance is in the range of \$.9M (Blyth) to \$1.2M (Morrow) per annum.

While our local estimates are thus similar to those provided by Blyth and Company, we do not share their optimism about the occupancy level that can be achieved in the facility. We have on hand a report (provided by Alex Zikakis of the Donald Gordon Centre) showing that the average occupancy rate of an international sample of university conference facilities is 47%. Achieving more than that is certainly reasonable with good management, but basing a business plan on almost twice that number seems excessively optimistic. Thus, we are in agreement about the costs but do not share Blyth's optimism concerning the achievability of the income required to cover the costs.

Recommendation


The Blyth capital estimate seems so different from the others as to be unsafe as a basis for planning. To get a more realistic lower bound on the requirement for additional money beyond the purchase price, we have assumed the following:

- Leaving Blyth's estimate aside, the next lowest estimate for the West Buildings renovation is that from Clive Mercer, at \$4.437M.
- Some work seems to be necessary on the Castle itself (i.e., not simply providing more
 accommodation in that building), and according to the Clive Mercer report this will
 cost \$2.832M.
- The Cobb McCallum report is the only one that addresses the need for renovations to provide food services on the site, and provides a cost for this of \$1.610. The other estimators did not envision this, or had in mind a different approach (Blyth's idea of kitchenettes where students do their own food preparation).


The total of these three amounts is \$8.879M. We thus recommend that an amount of at least \$9M in addition to the purchase cost will be required to make the project a success. This assumes that a program of use and a business plan derived therefrom can be devised that will generate the annual cash flow required to maintain and operate the property.

Minimal Cost Option

As an alternative, we might consider simply acquiring the property and not running any programs there. This would have a minimal cost of \$.7M per annum, the amount estimated by Morrow for annual long term maintenance costs (we actually believe a figure of \$1M would be more realistic). This expenditure would be required to slow the rate of deterioration of the property and maintain marketability. Under this plan the property could be purchased




now and held for 5 years. We have been told that an offer of \$35M was previously made (and turned down), so it might be reasonable at some point in the future to expect that a market value of \$25M could be achieved. We do not know if this could be achieved in 5 years or ever. If it could, maintaining the property as is might be a more attractive option for Queen's, if not for the donor.


Preliminary Note on Charitable Aspects under English Law

1. Background

- 1.1 Bodies established for charitable purposes only and subject to the jurisdiction of the High Court must (with some exceptions) be registered with the Charity Commissioners.
- 1.2 Charities are subject to the supervision of the Commissioners; a copy of LWD's note on the provisions of the Charities Act 1992, which strengthened their supervisory powers, is attached. The trustees of a charity are accountable to the Commissioners and ultimately personally liable to the Court for the proper administration of charitable funds.
- 1.3 Extensive UK taxation exemptions are available to registered charities.
- 1.4 The advancement of education is a charitable purpose and in principle a body established for that purpose and where there is no element of private profit is registrable.


2. Taxation

2.1.1 Income/Corporation Tax: Charities are normally exempt from tax on rents, investment income, and trading profits to the extent that the trade carries out of the charity's primary purpose. Any



profits received from the educational activities of the charity are therefore exempt.

- 2.1.2 It is possible in some circumstances to recover income tax paid by non-charitable companies or individuals which make donations to charities and this may be relevant if Dr. Bader is subject to UK income tax.
- 2.1.3 This exemption can also be used so that trading activities which are not themselves part of the primary purpose of the charity, but of which the profits are payable to the charity, can effectively be relieved from tax. It is usually necessary to establish a separate company to carry on such activities.
- 2.2 Capital Gains Tax: Charities are normally exempt from capital gains tax on the disposal of assets.
- 2.3 Inheritance Tax: Property given or left by Will to charities is not normally subject to UK inheritance tax (see also paragraph 5).
- 2.4 These exemptions are normally available to the extent that the relevant funds are actually applied for charitable purposes.
- 2.5 Non-domestic Rates (local taxation): Relief from 80% of the non-domestic rate is given in respect of property occupied by a charity for its purposes. Relief from the remaining 20% may be given at the discretion of the local authority.
- 2.6 VAT: Liability to VAT is not determined by charitable status but by the nature of the activities carried on. The provision, otherwise




than for profit of education or research of a kind provided by a school or university is normally exempt from VAT but other business activities carried on (for example the supply of conference services if contemplated) could be subject to VAT and VAT registration will be required if turnover exceeds the threshold of £36,600 in any 12 month period. Even if the charity registers for VAT, to the extent that the charity does not itself charge VAT, it will not be able to recover VAT paid by it on the supply of goods and services to it which are attributable to exempt supplies; it may be possible to recover a proportion, if services subject to VAT are supplied.

2.7 Stamp Duty: Exemption from stamp duty is normally granted on the transfer of property to a registered charity.

3. Registration


- 3.1 In a preliminary discussion the Charity
 Commissioners have indicated that they would be
 unwilling to register Queens University ("the
 University") as a charity because they take the
 view that it is outside the jurisdiction of the
 High Court (see paragraph 1). We therefore
 recommend the establishment of a UK charitable
 body ("the Foundation").
- 3.2 The preliminary requirement for registration is the submission of the completed questionnaire Form RE96 (copy attached) together with the supporting documentation outlined in the questionnaire and summarised on the final page.
- 3.3 Question 1: The University will presumably wish the name of the Foundation to include the word


"University". Consent for this will be required, but is likely to be given. The Commissioners have power thereafter to require the charity to change a name including "University"; this is a new power and seems likely to be exercised only where there is a cause for complaint.

- 3.4 Question 5: LWD will recommend an appropriate structure and advise on the appropriate form of draft governing instruments after taking further instructions on the proposed activities and the relationship proposed between the Foundation and the University.
- 3.5 Questions 8-14: If feasibility studies are not available for submission with the questionnaire, then enough detail should be supplied about what is intended to enable the Commissioners to form a view of the project and its viability. It will be necessary also to supply background information about the University, with a brief summary of its Canadian status, accreditation, and types of course offered, and also tax status.
- 3.6 Questions 22-24: If full financial projections are not available for submission, summary statements should be prepared (see also paragraphs 4 and 5).
- 3.7 The Commissioners have indicated that their current 'first response' time is six weeks from receipt of the completed questionnaire and supporting documentation, although they will try to shorten this in a case such as this where a purchase of property is involved. The time taken between their first response and registration clearly depends on points raised by them and the speed with which instructions can be taken on



them, but it is suggested that at that stage the matter be expedited if necessary by arranging a meeting with the Commissioners. The Commissioners will liaise with the Inland 3.8 Revenue and it should be possible to deal with points raised by either body together. Following registration the Inland Revenue will normally grant the relevant exemptions on being given the appropriate details. 3.9 Once any outstanding points are dealt with, completion of the formalities of registration may take some 2-4 weeks. 4. Confidentiality 4.1 The terms of the confidentiality provision are noted, but there may be obligations to disclose this information to the Revenue and the Commissioners, and it would be helpful to have consent to disclose the purchase price to the Commissioners when the questionnaire is submitted (ie. without written request). 4.2 A charity is obliged to file accounts and accounts are open to public inspection. Regulations under the Charities Act 1992 governing the form of accounts have yet to be published, but it may be that the price will have to be disclosed in the accounts. 5. Funding Details of the funding arrangements must be 5.1 concluded. Is it intended that the Foundation be funded direct by Dr Bader or will all funding come via the University? It may be necessary to seek Canadian tax advice and Dr Bader will need advice





ADDENDUM TO THE AGREEMENT made the 11th day of November, 1992 between ALFRED BADER and ISABEL BADER (the Baders) and QUEEN'S UNIVERSITY AT KINGSTON (Queen's).

WHEREAS the Baders and Queen's are parties to an Agreement made November 11, 1992 (the Agreement) with respect to a gift from the Baders to Queen's to enable the acquisition, renovation and refurbishing of the Herstmonceux Castle Estate in Sussex, England for the educational purposes of Queen's;

 $\ensuremath{\mathsf{AND}}$ WHEREAS it is desirable to amend provisions of the Agreement.

NOW THEREFORE, in consideration of the premises hereto and the covenants herein, the Baders and Queen's agree as follows:

- 1. Paragraphs 1 and 2 of the Agreement are amended to read:
 - (1) "The Baders will give Queen's the sum of six million pounds Sterling, which sum shall be used and applied by Queen's for the sole purpose of acquiring, renovating, refurbishing, and starting up operations of the Estate for the educational purposes of Queen's."
 - (2) "Queen's will submit an offer to purchase the Estate forthwith and endeavour to enter into an Agreement of Purchase and Sale for the Estate upon terms and conditions acceptable to the Baders and to Queen's."



2. Paragraph 5 of the Agreement is amended to read:

"If Queen's is unable to reach an Agreement of Purchase and Sale for the Estate prior to December 31, 1993 or if an Agreement is reached, and cannot, for any reason, be completed, this Agreement will be null and void, and the gift of six million pounds sterling will be held by Queen's in an abeyance account with a disposition of it (and the yield thereon) to Queen's projects to be determined by agreement between the Principal of Queen's and the Baders."
