Dr. Otto Naumann has told you about my offer for your beach scene by de Meyer, which was unsold at a thousand dollars, lot 304 in Christie's sale of the 13th of October 1992.

You know the problem with this painting: it was at one time a pretty work which is now in terrible condition and restoration will be expensive. Nonetheless, it is decorative and so I offered one thousand dollars. Dr. Naumann urged me to do a little better, and so I offered, and he accepted on your behalf, \$1200. Dear Ms. Norman:

Thank you for your fax, just received. In substance, everything you wrote is correct.

Please consider these suggestions:

Paragraph 3 - To say that I "was eased out" of Sigma-Aldrich is an understatement. I was thrown out.

Also, I have remained the biggest private stockholder in the company, and I have not really used "the proceeds" to buy art; I have had the courage.

I paid more than Sotheby's high estimate, and worry that your writing that I "got it cheap" might be hurtful to the church. Incidentally, the church insured it for only £250!

I never actually mentioned a price to the National Gallery. The sum of £500,000 was in my mind, and I shared it with you, but not with the committee or Neil MacGregor. Please consider changing this to, "He offered to sell it to the National Gallery for considerably less than he was prepared to bid."

<u>Paragraph 4</u> - I wasn't really "summoned" to the meeting, but invited. George Gordon suggested that I should attend or someone should represent me. Nor was I really in a fighting mood; eager, yes, and actually hoping that the National Gallery would buy it.

What you wrote about confidentiality is of course correct, and yet might be hurtful to the committee. <u>I would</u> appreciate your taking that out.

Paragraph 6 - Please consider deleting £500,000; see above.

<u>Paragraph 7</u> - The wings did not look to me to be by the same artist, and were probably painted later. Hence, I did not bid.


Please do send me a copy of the piece when it appears. Will that be next Sunday? Will it include photos? I could send you a transparency.

A German altarpiece of around 1500 which the National Gallery considers of "outstanding significance for the study of art" has been granted an export license - because the Gallery hasn't the money to pay for it. It depicts the "Lamentation" over Christ

's dead body with a very Germanic rocky landscape in the distance and was painted by a hitherto unidentified artist close to Durer (umlaut on u).

Neil MacGregor, director of the National Gallery, has pointed out that there are only two "Durers"(umlaut on u) in his collection, "a portrait, the attribution of which is often disputed, and another painting no longer held to be by him." The retention

of the "Lamentation" in Britain would "not only provide a rare opportunity to study German relgious art on the eve of the Reformation", he said, "but also stimulate and advance discussion of the working practices of Durer (umlaut on u) and his associate s."

The painting had belonged to a church in Shropshire since the late nineteenth century and was sold at Sotheby's in December for pounds 236,437.50 to Dr. Alfred Bader, a professional chemist, art dealer and collector of Old Masters from Milwaukee – he w

as eased out of the chemicals company he founded two years ago and has begun to play the big time in the art market on the proceeds. "I bought the painting in partnership with the New York dealer Otto Nauman", he told me. "We were prepared to go one bid

over pounds 1 million but we got it cheap. He offered to sell it to the National Gallery for around pounds 500,000.

Dr. Bader was summoned to appear before the Reviewing Committee on the Export of Works of Art on March 2 and flew into Britain in fighting mood. "They sent me an open fax marked "Confidential" inviting me over", he told me. "I don't know what they thin

k they're doing. As far as I'm concerned, nothing can be confidential unless both parties have agreed that it should be."


He took a tape recoder to the meeting but agreed only to tape what he said himself. His opening statement was sharply ciritical: "I feel very badly about how this has been handled. This came from a church and the church announced that payment would be

used to build affordable housing. I understand that the National Gallery looked at the paintings carefully, and that Sotheby's was certainly under the impression that the National Gallery was not interested and I was told that there would be no problem ω

ith an export permit and hence I was given 60 days to pay after receipt of the export permit. So up to now the church has not been paid."

But by the time his session with the Export Committee was over he had been seduced by the old world charm of the British art historians. "It was like a love affair", he said afterwards. "I'm only sorry they are not going to buy it." He indicated that a

bargain price, probably around pounds 500,000, would be available to the London or Edinburgh National Galleries but if a British private collector wanted to "save the painting for the nation", he would have to pay over pounds 1m. Bader



now has "a major

American museum" interested in the painting.


It was sent for sale at Sotheby's by the vicar and churchwardens of St. Martin, Little Ness, Shropshire, together with two panels which were probably once the wings of the altarpiece but have been cut down since then. They were bought for pounds 45,500

by the German dealer Eeckard Lingenbauer of Dusseldorf (umlaut on u) who is exhibting them on his stand at Maastricht Fair (closes Sunday March 20). He hopes that they will one day be reunited with the central panel.nnnn

Dear Egbert,

When we saw each other all too briefly at the meeting of the Netherlandish Art Historians, I was puzzled by your saying to me that you were sorry that we had lost touch for awhile. It occurred to me later that my long letter of September 21, copy enclosed, may have gotten lost.

I purchased a lot of fine paintings since then, including two works by Aert de Gelder, but they are for the gallery, and I really want to "bother" you only with paintings which I want to keep in my personal collection. So, I now enclose only one photograph of a painting which puzzles me greatly, both about authorship and iconography. When it was sold at Sotheby's in December it was attributed to Sweerts, but surely that is not correct. It cleaned up beautifully and certainly is 17th century and northern. The closest I have been able to think of is a beautiful single figure by Jacob van Oost in the National Gallery in London, but that is painted a little more tightly.

And what is the subject? Could it be an allegory of old age with the old man looking back on his youth? But I don't know of anything comparable. At first I wasn't even certain whether the figure in the background is a man or a woman, but Isabel feels that with such a beret it must be man.

As you will see from the copy of letter of Milena Bartlova just received, during the second year she has succeeded to find some competent students for the three Bader Fellowships.

I just had a delightful call from Ronnie Baer in Atlanta, and I very much hope that she will visit us in Milwaukee, soon. As you know, at one time she was a Bader fellow at the Institute, and that reminds me that I have not received any names of students who received the fellowships during the last three years. Could you please ask the Institute to send me the names with the dates, and then to let Isabel and me know every year who receives them.

Of course, we also very much hope that your travels will bring you to Milwaukee before long.

We are having a hot and humid week. The temperature "plunged" down to 79° last night. I don't know what the temperature has reached yet today--they say we can set records for high temperatures and highest low temperatures. It's deliciously cool in the gallery. Went to the bank about 9:15 this morning to avoid mid-day heat. There is a strong breeze and if you stay in the shade not too bad!

Had a fax from Jan Martens today, per copy enclosed, offering another 25 books for a total of 50--cutting the baby in half, I guess. I sent copy to Marvin for his comments. Hope to have a response from him by the next time I call you.

The other fax, copy also enclosed, is from Professor Ed Piers at UBC. I responded with a list of your talks and stating that you might like to visit and lecture at other universities in the area, as well as at art museum. You can settle on date, etc. when you return. He will send his paper to Aldrich towards the end of the year, so I sent copy of Piers' letter to Steve Branca.

Lee Curry sent sample of plastic folder available from Associated Bag--they are quite a bit better in quality, I think, and much less expensive--\$.087/each in lots of 50, \$.08/each in lots of 200, of 500 at \$0.77/each, lots of 50 in one color. You may have to talk to his supervisor as Mr. and Mrs. Guest are expecting a baby just about the time you return. Your "brief" was enclosed with the first memo which I assume you have already received. I am enclosing one of the three copies of each document so be sure to bring them back with you as the ribbon and one copy must be returned after you have signed them.

Dear Alfred:

How was your visit to the Czech Republic? I hope that all went well, and that your concerns have been met. Also, that you and Isabel felt right at home there.

I am writing mainly because I have a beginning of an answer to the confidential question you asked me concerning the University of Toronto. When we speak together I shall tell you what I actually did but let me simply say now that I am extremely optimistic. Could you perhaps let me have any biographical material regarding Isabel for when activities resume this Fall.

By the date of this letter you can tell that my presidency is quickly drawing to an end. Mrs. Lewis, presently my administrative assistant, very kindly offered to continue to receive my mail and messages. In this fashion, though my office will now be in another building, the confidentiality of my mail will be respected. You can therefore contact me c/o the President's Office, Victoria University etc... with the same address, fax and telephone number as before. At home also, of course (63 Albany Ave., Toronto M5R 3C2; telephone 416-538-0173).

This Summer I shall be away a good deal. First, to China and South Korea, but going through I os Angeles on the way there and back to see my mother. Then, at our country place near Ottawa; then at the International Congress of Comparative Literature in Edmonton, where they asked me to give the inaugural address.

At all times however I shall be in touch with the office at Victoria.

I have given an enormous amount of thought to the questions and concerns you raised regarding RELIABLE procedures for the kind of projects you and Isabel favour and those you might yet favour in the future. I am beginning to see a plan you might find both creative and secure; and I hope some time to have the oppportunity to present it to you in cooperation perhaps with Dr. Moscovits, who also has been giving these things much thought.






