
Mrs. Kohman wants \$75,000 for the painting, which is very high, and yet it is so beautiful that you might want to negotiate with her.

Insurance

You must have realized from our conversation on Wednesday that I was truly delighted to have the opportunity of sending you one of my best paintings in so easy a manner. Your Registrar kindly advised me yesterday afternoon that the Jan de Bray arrived safely.

As you perhaps know, we have only put my favorite paintings onto covers of the Aldrichimica Acta, and the Acta with the Jan de Bray is enclosed. The description of the painting is on page 21.

Enclosed please also find copies of Ellen and Walther Bernt's and Egbert Haverkamp-Begemann's comments. A number of art historians have told me that this is one of the finest Jan de Bray's they have ever seen.

While planning for the Haarlem show at Rutgers University, Dr. Hof-richter took counsel with Prof. Haverkamp-Begemann about which paintings to exhibit, and he told her that the Jan de Bray was my finest Haarlem painting and that she should borrow it. However, when she realized how large it is, she had to decide that they simply did not have enough room, and she borrowed my Jacob Ruisdael instead.

Because of the hurried decision to send this to you, I have not obtained an appraisal. If on close inspection you still like the painting as well as you did when you saw it here, then please accept it as my gift and help me in obtaining a competent appraisal. If for any reason you will change your mind, please just return the painting with the portrait. Regarding the latter, please note that
